# BRSU selects Randi Lowe as new superintendent

SUNDERLAND, Vt. – There will be no learning curve when Randi Lowe, the newly appointed superintendent of the Bennington Rutland Supervisory Union, begins her new job July 1. Lowe has been an integral part of the BRSU leadership team since 2013 when she joined the supervisory union as special education director. During that tenure, Lowe dealt with the variety of challenges created by the mergers of the Taconic and Green and Mettawee School Districts. In her most recent post as assistant superintendent, Lowe took the primary role in helping the BRSU's Winhall School District grapple with the complex administrative demands of a full school choice district.

The BRSU Board proudly announced its decision Friday, Jan. 31, following a unanimous vote of the board to offer Lowe the position at a meeting Thursday. "Randi is simply a great hire for the BRSU and the 12 towns that we serve with our three school districts," says BRSU Board Chair Jim Salsgiver. "She understands our community and is a fierce advocate for public schools and for all our children."

Raised in New England,

Lowe's first job in the teaching profession was serving as a special education teacher in White River Junction. For the 25 years she has spent in public education, Lowe moved from the classroom to education consulting to administrative responsibilities. During her time at the BRSU, Lowe established an excellent reputation as a spokesperson on behalf of our schools. She also helped to explain the nuances and aided in crafting legislation on behalf of special education students in Vermont.

"Special education was what

originally attracted me to education," says Lowe, who lives in Manchester with her three children, twins Spencer and Parker, who attend BBA, and Sydney, who is an eighth grader at MEMS. "I always believed in public schools, but I also realized that we must be able to serve the diverse learning needs of all our students."

Lowe enthusiastically looks ahead to her new assignment. "I love the BRSU," says Lowe. "We have an amazing community and our teachers are doing incredible work in their classrooms."

Lowe also expects to benefit from the work of the district school boards in reaching out to the public for feedback on setting education goals as part of a Governance Ends Policy. "A clear and direct understanding of what our community expects from public education," says Lowe, "will guide our work both in and outside of the classroom."

Lowe's selection was set in motion last September when current BRSU Superintendent Jackie Wilson

# Cavendish Selectboard addresses meeting rules, allows quarry statement

CAVENDISH, Vt. – The Cavendish Selectboard meeting Monday, Feb. 10 again dealt with information on the proposed quarry on Tierney Road. This month, however, the board allowed resident Mike Harrington to read his complete statement.

During January's Selectboard meeting, Harrington attempted to make a statement about the latest legal rulings on the proposed quarry but was stopped by board member Mike Ripley just over a minute into his statement. Ripley cited a need to follow Robert's Rules of Order and adopt standard procedural meeting protocols for citizen comments. Ripley also termed Harrington's remarks irrelevant and characterized his remarks as "childish." Later in the January meeting, board member Sandra Russo said she felt uncomfortable not letting Harrington speak.

Ripley's conduct resulted in a formal complaint to the board and Town Manager Brendan McNamara concerning the censure of the subject and whether Ripley should recuse himself for bias in future meetings.

In response, the board again put the issue on the agenda and allowed Harrington to read his statement completely – this time speaking for over 13 minutes. Harrington, in compliance with concerns by the board, was careful to address the chairman and present a factual update on recent proceedings, avoiding inflammatory speech on the subject.

Harrington informed the board about recent decisions by Vermont Superior Court Environmental Division, which found in favor of Snowstone LLC and denied a motion by the neighborhood group for sanctions to be levied against Jason Snow and Snowstone.

According to Harrington, the jurisdictional opinion from several years ago was limited in scope to contrac-

tual dealings and the pro-quarry side has fought successfully to keep expert opinions from the anti-quarry side about lot size and excessive storm water from being brought before the Environmental Court. According to Harrington, the judge said from the bench to Snow that, "Anyone could ask the Act 250 board for another jurisdictional opinion on those two issues."

Harrington also went on to quote from the ruling, "...this Court believes that the legal issues in these coordinated appeals rise to a level of complexity that permits reasonable differences of interpretation."

This statement in Harrington's opinion points to the likelihood this will go before the Vermont Supreme Court. And if need be, "We're just going to go right back to the Act 250 board and ask for our own jurisdictional opinion...and they'll listen to our experts on storm water."

Issues concerning impact of blasting on residents' well water and pipes, decreased tax revenues being collected by the town, and suppressed property values were also discussed.

Harrington said he would continue to keep the Selectboard informed as legal issues unfold for both sides.

The board then proceeded to a discussion on Cavendish Selectboard meeting rules of conduct. Russo drafted a proposal

that would help establish "an atmosphere of courtesy and respect and accommodate meaningful participation by citizens."

Her proposal included that all remarks should be made to and recognized by the chairman; remarks stick to clear and relevant facts; that citizens cannot speak to or about another member of the public; that a time limit be set for remarks; that citizens would be able to speak at two different times during the meeting – as each agenda item is discussed and also under "Hear Citizens" section of the agenda. The board will make any additional suggestions to Russo and the revisions will be presented in the future.

The Stone Church project, which is a joint effort between the town, Cavendish Historical Society, and the Solzhenitsyn Center, is making progress with meetings with VTrans and the Fire Marshal happening next week. Renovation funds are coming from the Solzhenitsyn Center with the town acting as point person on the renovations. One issue that's arisen is that the pews in the stone church are all deeded to individuals and their families. They have to go through the process of researching ownership and notifying heirs before removing them.

The Depot Street Bridge only has a few weeks of work remaining once spring weather arrives. McNamara expects the bridge to reopen before the Memorial Day Parade.

Cavendish Town Meeting is Monday, March 2 at Cavendish Town Elementary School. Voting will happen the next day, Tuesday, March 3 at the Proctorsville Fire Station. Polls open at 10 a.m. The Cavendish Town Plan is up for approval. Copies are at the Town Office.

# Okemo discusses expansion at Rotary

LUDLOW, Vt. – Bruce Schmidt, Okemo general manager, was the recent guest of the Ludlow Rotary Club to inform the organization on the new plans to update a number of facilities at Okemo Mountain Resort.

Bruce opened his discussion by noting that Okemo, now in its second year as part of the Vail organization, was intent on maintaining its close relationship with Ludlow and the surrounding area.

In outlining the planned development projects, he indicated that the base lodge at the Okemo entrance would undergo a major expansion beginning in mid-April of this year. The expansion would make the lodge and its associated facilities more user-friendly by placing most of the lodge area on one level, increasing the ease of access to the lifts. He said that a new training area for children would be developed in a building that would

house training facilities as well as equipment needs for the skiers and boarders.

The multi-million dollar effort would also expand lift service at Jackson Gore to reduce the wait time at the base lift.

One point that Bruce emphasized was the development of a management style that would train people for higher

level positions in other Vail resorts.



announced her retirement at the end of the current fiscal year, June 30, 2020. This advance notice gave the BRSU time to implement a comprehensive search for a new superintendent with the guidance of a consultant from the Vermont School Board Association.

Central to the plan was the creation of a Candidate Screening Committee made up of board members, BRSU staff, and parents from the community. Applications were received from candidates from six states. After an extensive review of each applicant, an initial round of interviews was conducted in December with a final decision Jan. 30, 2020.

"We are fortunate, indeed, to have Randi Lowe as our next superintendent," says Salsgiver. "Please join us in congratulating Randi Lowe on her selection as our new superintendent and in welcoming her to her new role at the BRSU."

The Bennington Rutland Supervisory Union is made up of three school districts: Taconic & Green Regional School District, Mettawee School District, and Winhall School District. These three districts serve 12 Vermont communities: Danby, Dorset, Landgrove, Londonderry, Manchester, Mount Tabor, Pawlet, Peru, Rupert, Sunderland, Weston, and Winhall.

## The blacksmith

The blacksmith was an important tradesman in the old days. There were blacksmiths who were farriers. Others made iron strap hinges, rims for wagon wheels, or tools. All could make or repair most anything.

The iron they used in those days was not as pure as the iron we have today. Blacksmiths saved any scrap iron they found. An old broken plow was used to forge new iron implements.

In the 1883 Child's Windsor County Gazetteer, I found 13 blacksmiths working in Chester. Two blacksmiths were on Main Street. Three are listed in Chester Depot with two in North Chester. Others were scattered around town.

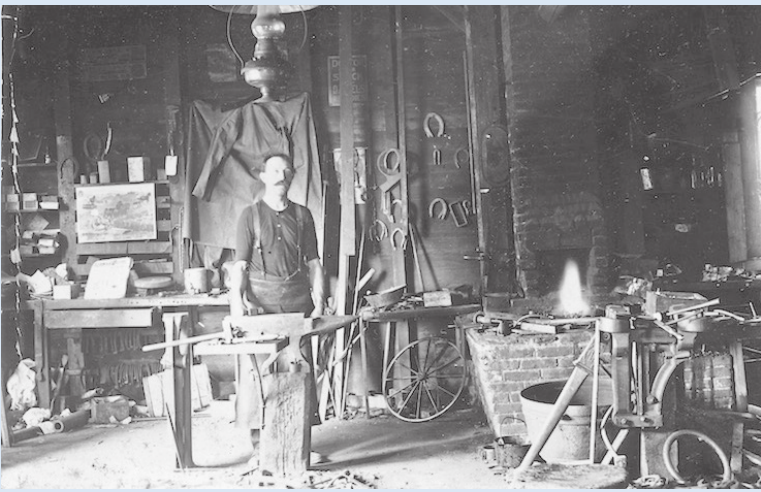
Springfield, three times the population of Chester, had 10 blacksmiths in 1883. Ludlow had five blacksmiths. Why did Chester have more blacksmiths than these towns?

Chester had the railroad where many products were shipped. Soapstone and talc from Windham, Chester, and Grafton, logs from area forests, and farmers shipping their goods all added up to a very busy and prosperous Chester. All of these products were delivered to the Depot with team and wagon.

From Louis Marshall's May 1913 ledger are a couple relevant entries. "We went to Chester after building. It rained, had good luck." The next day: "Loading building to start home broke wheel at Bunting hill on forward axle. I drove the 4 horses got another wheel." I use this entry to illustrate how hard these horse-drawn wagons were used.

Two days later: "Father got his horses shod and a load of grain at Chester." Again, a blacksmith was needed to shoe the horses.

Blacksmiths of the day kept these teamsters in business. Breakdowns were costly to the teamster. A while back I wrote about W.R. Spaulding "Ironing the hearse." You may recall ironing a wagon was beefing up the iron on a wagon. If you made your living with a team, a

blacksmith was your best friend.

The photo with this article is Frank Jarvis in his blacksmith shop. His shop was next to his house where today the Green Mountain Turnpike meets Route 103 near the old gristmill.

It's an interesting photo to study. Frank stands at his anvil with an oil lamp overhead. Underneath, a workbench on the left can be seen many horse shoes. Behind Frank, you'll notice a coat covering a window. The photographer covered the window for better light to photograph. To the left of Frank is a poster advertising farm machinery.

To the right, you can see the brick forge. Air from the bellows fed the coals. You can see fire rising from the forge. The shop is cluttered with tools and other implements.

Frank's daughter, Mrs. Cassidy, was my fourth grade teacher at Chester Elementary School. I remember one day we were coloring in class. I was a little hyper when I was young. I was trying to color, but I was one of those kids who rapidly colored in long zigzag strokes. I couldn't stay in the lines. Mrs. Cassidy was walking up and down the rows of desks looking at our coloring. When she got to me she said, "A two-year-old could color better than you."

snowball hammer, sometimes called a snowballer. Men working in the woods with a team needed this specialized hammer. Driving on a snow-covered road spared horses from chunks of ice and snow collecting on their hooves.

But in the woods, a team might walk through a swampy area or cross a brook. When the horses' feet got wet, the snow would stick to their hooves. Imagine a horse with iron shoes trying to ascend or descend a steep grade.

The ice and snow covered the cleats of the horseshoes, making it impossible for horses to gain traction. If a horse slipped, he might break a leg. The answer was the snowball hammer.

Often blacksmith made, these snowball hammers were uniquely designed by the blacksmith. There is a snap on the handle end so the snowballer could be fastened to a leather harness.

The teamster used the hammer end to strike the iron shoes to dislodge frozen ice. The curved end has a pointed tip to chip ice around the shoe. This snowballer shows many strikes from the blacksmith peening the hot iron.

## SAPA TV to change Comcast channels

**REGION** – There are changes coming to SAPA TV, the public access station serving Springfield, Weathersfield, and Chester. Beginning Feb. 18, Comcast is relocating the channel lineup of public access stations throughout Vermont. The SAPA public channel located on Comcast channel 8 will move to channel 1077, and the SAPA government and education channel located on Comcast channel 10 will move to channel 1087.

The SAPA TV signals will be available on all four channels for 60 days after implementation. After the 60-day window, the signals will only be available on Comcast channels 1077 and 1087. VTel subscribers will not be affected by this change. SAPA TV programming will remain on VTel channels 160 and 161. Those without cable subscriptions can view SAPA programming through streaming and video on demand at [www.sapatv.org](http://www.sapatv.org).

The channel change will not affect the SAPA service area, channel content, or the services the station provides. SAPA will continue to provide video production education and training, access to state-of-the-art facilities and video equipment, and coverage of local meetings and events. ## Fish & Wildlife reminds Vermonters of Nongame Wildlife tax check-off

MONTPELIER, Vt. – Vermonters interested in conserving wildlife should donate to the Nongame Wildlife Fund on their state income tax form this year, according to the Vermont Fish and Wildlife Department. The fund helps protect some of Vermont’s most threatened wildlife such as bald eagles, lake sturgeon, spruce grouse, and Indiana bats.

Donations are leveraged by matching federal grants, meaning that a \$25 donation can help us secure up to another \$75 in

federal funds for wildlife conservation in Vermont. “The Nongame Check-off donations, along with hunting, fishing, and trapping license revenue, have helped recovery efforts for Vermont’s peregrine falcons, loons, ospreys, bald eagles, American martens, Indiana and northern long-eared bats, spiny softshell turtles, and other species,” said Director of Wildlife Mark Scott. Steve Parren and other fish and wildlife biologists manage nongame wildlife projects for the Vermont Fish and Wildlife

Department. Their work is diverse and includes mammals, birds, turtles, fish, frogs, bees, freshwater mussels, and plants, as well as the habitats and natural communities they need. “The Nongame Wildlife Fund has helped some of our great wildlife success stories in Vermont,” said Parren. “Thanks to the generous donations of thousands of Vermonters, we are restoring many of the iconic species of our Green Mountain State.”

## Vermont Fish & Wildlife offers ice safety tips after snow events

MONTPELIER, Vt. – The Vermont Fish and Wildlife Department urges people venturing out on the ice of Vermont’s lakes and ponds to always put safety first and monitor ice conditions, especially after significant snow fall. “The recent arrival of new snow can hide areas of thin ice and prevent further freezing,” said Colonel Jason Batchelder, the department’s chief game warden. “Ice thickness can vary considerably on different parts of a lake due to moving water from currents, rivers, and springs.”

- Leave your car or truck on shore. Every year, several motor vehicles go through the ice on Vermont lakes, and some people have drowned as a re-

sult.

- Leave information about your plans with someone – where you intend to fish and when you expect to return.
- Wear a personal flotation device and don’t fish alone.
- Carry a set of handspikes to help you work your way out onto the surface of the ice if you go through. Holding one in each hand, you can alternately punch them into the ice and pull yourself up and out. You can make these at home, using large nails, or you can purchase them at stores that sell fishing supplies.
- Fish with a friend. Ice fishing is a great sport to share with family members and friends, and having a partner with you increases both the fun and the

safety.

- Ice varies in thickness and condition. Always carry an ice spud or chisel to check ice as you proceed, and be sure to check the ice in several places.
- Be extremely cautious crossing ice near river mouths, points of land, bridges, islands, and over reefs and springs. Currents almost always causes ice to be thinner over these areas.
- Avoid going onto the ice if it has melted away from the shore. This indicates melting is underway, and ice can shift position as wind direction changes.
- Waves from open water can quickly break up large areas of ice. If you can see open water in the lake and the wind picks up, get off!
- Bring your fully charged cell phone with you.
- Carry a safety line that can be thrown to someone who has gone through the ice.
- Heated fishing shanties must have good ventilation to prevent deadly carbon monoxide poisoning. Open a window or the door part way to allow in fresh air.

## Bears are more active than normal this winter

REGION – Many Vermont bears are not getting much rest this winter, according to Vermont Fish and Wildlife’s bear biologist Forrest Hammond, so he is urging people to avoid disturbing them or providing any kind of food for them. Most bears seek their winter dens when it becomes difficult for them to find food and not due to winter cold. During years of natural food shortage, some bears give up trying to find food and enter their winter dens as early as October. This enables them to conserve the energy and fat reserves they have, rather than staying out and expending more energy looking for food that is not there. “But in years like 2019 when late autumn foods such as acorns, beech nuts, apples, mountain ash berries, and winter berries are plentiful, many bears will remain active as long as they

can find food,” said Hammond. “This was why so many bears and bear signs are still being observed even now. If they are still able to access some kind of food, many of them will remain active, rather than stay in their dens.” “We have a lot less snow this winter, and temperatures have been higher than normal, making it even more tempting for bears to wake up and seek a snack,” said Hammond. “Acorns and beechnuts are still abundant this winter, and there isn’t enough snow in much of the state to make finding them difficult, so many bears are still active.” “You can help by removing any potential source of food outside that will attract bears,” he adds. “Bears can smell a food source from long distances. And, if a bear starts to show up in your neighborhood, please bring in your bird feeders.” “In winters like this one where there is not much of an insulating snow cover, bears

feel less secure and spend less time actually sleeping while in their dens. So, people who go hiking with their dogs need to realize that with little snow this winter, bears are more vulnerable to being disturbed by free-roaming dogs. Either leave your dog at home or keep it under control while you are out there. If you accidentally disturb a bear from its den, it is important that you not return to the site as a bear will often come back once, but usually will leave for good after being scared off a second time. And, newborn cubs are dependent on their mothers for warmth so they don’t survive long if their mother abandons them.” Hammond suggests learning more about bears on Vermont Fish and Wildlife’s website at this link [www.vtfishandwildlife.com/learn-more/living-with-wildlife/living-with-black-bears](http://www.vtfishandwildlife.com/learn-more/living-with-wildlife/living-with-black-bears).
