

# BF Annual Meeting discusses Town Warning and Articles

**BELLOWS FALLS, Vt. –** At the Bellows Falls Village Corporation Annual Meeting on Tuesday, May 10, voters and staff discussed the warning with a majority vote declining to approve the village budget by Australian Ballot.

Moderator Paul Obuchowski updated voters on the procedures, reminding them, “As our friend Michael Harty always said, ‘we arrived as friends and neighbors and we will leave as such.’”

On the warning, Articles 1, 5, and 6 were voted on by Australian Ballot on Tuesday, May 17, with future budgets voted on the floor. Article 1 elects village officers, 5 passes the budget of \$1,649,973 with \$1,574,173 to be raised by taxes, and 6 approves purchase of the waste sludge dryer for \$268,450.

Much of the discussion referred to Article 2: “Shall the Village of Bellows Falls adopt its annual budget and all budget articles by Australian Ballot?” Motion was approved and seconded by Village President Deborah Wright and Trustee Stefan Golec, respectively.

Wendy Levy asked if Article 2 regarded only 2022. Wright explained that, due to Covid, they had changed the vote to Australian Ballot, but according to the Secretary of State, the vote for Australian Ballot must now be on the floor.

Dennis Harty opposed voting by Australian Ballot for the budget. He said that this was the only time trust-

ees could hear from voters and where voters could change the budget.

Wright pointed out the low attendance and said, “With a population of 3,200...it is a great concern to me that 18 people could decide the budget.” Doug MacPhee said, “We have lost our democracy...what scares me, 18 people could increase the budget.” Larry Clark agreed with Harty and said, “Once this change is made it’s no longer our budget, it’s the trustees budget...vote on the floor, and it becomes our budget.” Clark suggested advertising and offering bus services to increase attendance.

Levy said, regarding permanently giving up the vote on the floor, “Once you give up a right, it’s much harder to get it back.”

Paul Reis agreed that gaining the most votes was best, but said he had questions on the numbers, asking why the Bellows Falls Police Department needed \$17,000 in FY23 for gas, equating to \$326 per week for patrolling a one-mile radius.

Trustee Wade Masure said that, according to last year, 70 people voted on the budget. Village and Town Clerk Kathleen Neathawk confirmed there were 2,010 registered village voters.

Trustee Jeff Dunbar said he recalled a full town hall as a child. He said, “It’s on all of us to get people to the polls...I think it’s our responsibility to try to get more people engaged.”

Article 2, to adopt the budget by Australian Ballot, was rejected, with 6 in favor and 16 voting no.

On Article 5, budget questions referred to delinquent waste and water.

Reis said the manager and board were doing a great job, but was concerned about the burnt house on Barker. Municipal Manager Scott Pickup explained that the town was working with an asbestos removal company.

Harty asked about the surplus in the general fund. Pickup said it was larger than the current fund balance policy and caused by Covid relief and less spending on regular expenditures. Pickup said they had responsibility to leverage other money and were waiting on state ARPA fund requests before decisions were made for the federal ARPA funding that was discussed at the community forums. He said that it did not make sense to spend the local money until they heard from the state. Camoin Associates will present the final ARPA report at the joint board meeting on Tuesday, May 31.

For Article 6, MacPhee asked why the village needed the new sludge dryer. Pickup said, in the past, they paid to truck wet sludge to northern Vermont. The dryer turns the sludge into a Class A fertilizer that local farmers use on their fields. He said it’s “a true recycling of our waste.”

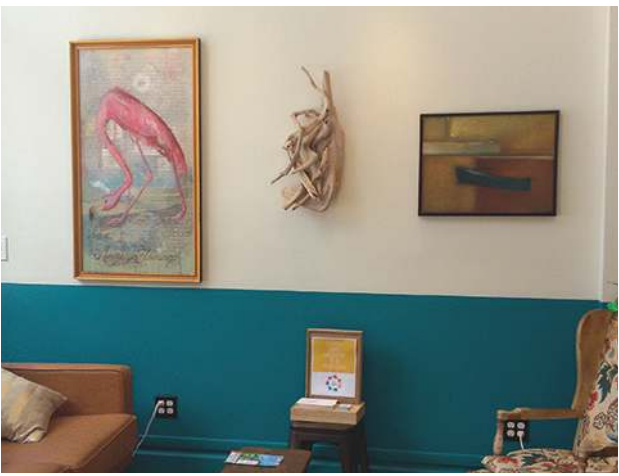

# May, Art Month in Bellows Falls

**BELLOWS FALLS, Vt. –** This year’s Art Month in Bellows Falls officially kicked off on Monday, May 9 with the opening of various collections of paintings by local artists, hanging at the Flat Iron Café, 51 Square. Managing Partner of the Flat Iron Cooperative Larisa Demos said, “We are thrilled to support the arts and the community by hosting the kick off of the month or so of events and also having our local artists and artisans’ work on display.”

The annual event dates back about five years, and has appeared in various ways since the group of artists that sponsors it was formed about ten years ago. Jeanette Staley, one of the original organizers and a participating artist over the years, said, “It’s an opportunity to recognize the culture and the artists... Every year we try to find the things that are going on in the community.” She notes that in 2016 the theme was “Resistance,” and art featured that year was in opposition to the global state of affairs. This year there is no such theme. In fact, last year the Covid situation prevented galleries from opening and there was no event at all. Staley herself has a studio on the road to Saxtons River. Saxtons River is also participating in the event; their art show will be housed at Main Street Arts. Robert McBride, Founding

Director of RAMP (Rockingham Arts and Museum Project), and a participant from the beginning, said, “We will be highlighting artists, events, shops, and restaurants that contribute year-round to the vital and cultural richness and economic stability of the community... The idea is to highlight downtown Bellows Falls with the arts in a general sense.” Staley says the group chose May since it makes the events a “lead-up” to the Vermont Craft Council’s statewide annual open studio tour on Memorial Day weekend.

This year, the BFDDA (Bellows Falls Development Alliance) has also gotten involved. Director Betsy Thurston said of local businesses, “There will be people in town for whenever they are open... Last year it was cancelled due to Covid. There are going to be so many people happy to come back here.”

Flat Iron Café will feature artists Staley, McBride, Scott Morgan, Claire Adams, Phillis Rosser, Charles Norris Brown,

Nick Kekic, Mike Lewis, and Shannon Parker.

Other featured locations include the studios of Rosser, McBride, and Mindy Fisher, as well as River Artisans Cooperative and the Canal Street Gallery.

For the Memorial Day Weekend Artisans’ Open Studio event, 33 Bridge Street will feature artisans working in blown and painted glass, pottery, stone, jewelry, painted floor cloths, and paintings on canvas and guitars.

The Flat Iron Café, many of the downtown businesses, and Main Street Arts in Saxtons River will have maps and schedules of events. At the end of the May, 33 Bridge Street Gallery will be an official site for the open studio tour and will host a number of artists. # Rockingham Recycling reminds residents to obtain Access Stickers

**ROCKINGHAM, Vt. –** The Rockingham Recycling Center reminds residents and non-residents that Access Stickers are required to enter the center on Route 5, south of Bellows Falls. Access Stickers for 2023 will be available June 1, 2022 and can be obtained at the Rockingham Town Clerk’s Office and at the Recycling Center cashier building.

Rockingham residents and non-resident property owners who pay taxes in Rockingham are entitled to two access stickers, free of charge. Additional access stickers will be available for a fee. Replacement stickers, required because of vehicle accident or windshield replacement, can be obtained at no cost, but proof of

loss is required. Proof of residency will be required when obtaining stickers. Each vehicle must have an Access Sticker displayed on the front vehicle windshield. If a sticker is not displayed, you will be asked to obtain a sticker before using the facility.

The Access Stickers are required to access the facility even if you are only leaving recyclables. The only exception to this is for those who are leaving electronic recycling items. The operating costs for the center are funded by the Town of Rockingham and its taxpayers.

Peter Golec, Selectboard Chair, noted it was not unreasonable for Rockingham to assess an Access Sticker fee for users from other towns to help pay for running the facility, as is the practice at other

town’s facilities. Golec reminds all users that even if you have an Access Sticker displayed, you must pay for disposal of household trash, appliances, and other items. There is no charge for items going into the recycle container. Current trash fees are for white trash bags, 30-gallon bags, and heavy-duty contractor bags. If you have more than four bags, you will be required to use the scales. Construction and demolition debris will be charged by the pound, weighed on a scale. We strongly encourage the use of trash tickets for trash disposal.

Cash is not accepted at the trash compactor. Trash compactor attendants do not have change and will not accept cash. The Town of Rockingham appreciates your cooperation.

# Outdoor burning ban —

**ROCKINGHAM, Vt.** – Due to the dry conditions, the State of Vermont and Rockingham fire officials have imposed an outdoor

burning ban. Burn permits are required at any time of the year regardless of weather conditions. You should be aware that all

outdoor burning should be under control at all times, even with a burn permit. If the outdoor burn is not controlled, and a response by a department is required by town ordinance, you will be charged by the Town Fire Warden for the assistance to put the fire out. Outdoor fire pits should be covered by a screen when in use. The Town Fire Warden responds to all complaints for illegal burns or nuisance burns. Only brush should be burned. No household trash, tires, or mattresses should be burned. The number to call for burn permits is 802-376-3936, Larry White, Town Fire Warden.

# “An Icebreaker Into Foster Care”

**SPRINGFIELD, Vt.** – Join Emily Rondeau, the Foster Parent Recruitment and Support Specialist, along with Cathy Paul, the office’s Resource Coordinator at the Springfield Town Library on Saturday, June 4 at 11 a.m. for their presentation of “An Icebreaker Into Foster Care.”

The Foster Parent Recruitment and Support Specialist has a Foster Parent Emotional Support Focus – Actively engage in recruitment strategies as highlighted in the statewide recruitment plan. Build and maintain strong working relationships with kin and foster families. Discuss positive parenting strategies with kin and foster families, and support the development of empathy and understanding for the trauma, attachment, and/or developmental challenges their foster child may experience.

The Resource Coordinator has a Specific Foster Parent Need Focus – Develop and support kin and foster care resources in each district office. They work to match children in need of foster care with trained, licensed foster caregivers within their districts. They maintain kin and foster caregiver records and make sure that payment arrangements are made. Resource Coordinators make assessments of the district’s need for foster resource homes, recruit foster caregivers, screen applicants, schedule training, and refer applicants to the licensing unit to complete the licensing process.

# Chester fishing derby

CHESTER, Vt. – This past Saturday, May 15, was the Chester Fishing Derby at Chester Reservoir. It was a warm morning, with bright sun. George Wilson was there from the Chester Rod & Gun Club, registering kids for the derby. At 9 a.m., the derby opened.

As usual, Danny Clemmons and I went. Danny sat with George and watched the kids report their catch. I wandered back and forth across the dam and along the road, talking to kids and their parents.

Excitement was in the air. It was shortly after 9 a.m. when Jacob Studin caught the first fish, a six-inch bass. Speaking of bass, there were two large bass, slowly cruising offshore. They were 15 to 17 inches long.

Right now, the bottom of the reservoir is covered with leaves from last fall. There were a few bare spots where a female bass, using her tail, had swept a small area clear of leaves down to the gravel. She does this so she can lay her eggs in gravel. I pointed this out to a couple people there. They found it interesting.

I've been covering this event for a number of years now. Six years ago, I met three-year-old Addison. I've seen her each year since. She has grown into a fine fisherman. This year, Addison brought her friend Emma.

**The catch**  
There were 48 kids registered to fish. Over 90 fish were caught. This was the best derby in recent years.

Most of the trout measured 9 to 11 inches. However, three trout measuring 12 inches were reported. George carefully measured each fish and recorded it. This was a little difficult as the fish were flopping around on the measur-

ing table. The question for George was how to award the largest fish category, a single prize, to more than one winner.

George solved the dilemma this way: Mathew Studin caught one 12-inch trout; Caleb Spittle caught two 12-inch trout. George awarded Caleb the prize.

As I walked around, I talked with kids and parents. I asked one young girl if she was having trout for supper. Her mom said she didn't know how to cook them. I told her how to clean them, and how I cook them, lightly coated with flour in a hot skillet with a little butter, not olive oil.

It was encouraging to see new faces this year. I hesitated to interfere or make suggestions, but I noticed one boy needing help. He didn't have a good technique. So I said to dad, "I don't like to butt in, but I can show him a better way." Dad said, "Please do, I don't know how to fish."

Another boy was catching trout and releasing them. I cringed when I saw the boy handle a trout with his dry hands. Again, I was hesitant, but I felt I had to say something.

I showed him and his dad how to wet your hands before handling a trout, that is, if you plan on releasing the trout. I explained that trout are covered with a thin mucus-type film. This film protects the trout from disease. Handling a trout with dry hands removes the film from the trout, exposing his sensitive skin to disease. If you wet your

hands first, none of the film will stick to your hands. His dad appreciated what I told him.

I'm hesitant because I don't want to appear as a know-it-all, or as interfering.

Fishermen have always been superstitious. Another kid wasn't having much luck. I told him something an old man told me when I was a boy, which was, "Spit on the bait for good luck." He did, but I don't know what effect it might have had.

George had a steady line of kids waiting to have their fish measured. Kids patiently waited their turn. George had a can of bug dope on his table for people to use. It's a good thing, mosquitoes were abundant.

When I left, I went to say goodbye to Addison and Emma. Emma gave me a big hug.

The next meeting of Chester Historical Society is Thursday, May 26 at the Academy Building on Main Street, at 7 p.m. The monthly slideshow will be photos from the estate of Lucile Carlton. Most photos date to the 1920s and were taken near and around the Carlton house on Goldthwaite Road. Included will be a couple views of the Carlton soapstone quarry off Reservoir Road.

Officially recognized as "patient-centered medical homes," multi-disciplinary care teams at each North Star Health location are focused on helping individuals identify their health-related priorities. During this 2022 Open Studio Weekend, Jackson shares a sampling of his 60 artistic years, along with his most current paintings and his “Rot Garden,” which has germinated and grown over the past 13. “My experience with wood sculpture, when exposed to the elements, introduced me to the beauty of natural material rotting away, returning to the earth,” says Jackson. His attentiveness to the fungi and molds that consume wood casts a spell, evoking in his work the beauty of decay in the natural world.

Visitors can walk in the gardens and woods at Jackson's studio to view sculptures made from wood, recycled materials, and the stems and roots of the invasive honeysuckle bush. And then there's nature's own breath-taking art at Jackson's studio – the inspirational, spacious view of the hills lining the West River valley.

The 30th Annual Vermont Spring Open Studio Weekend is the Saturday and Sunday of Memorial Day Weekend, May 28 and 29, from 10 a.m. – 5 p.m. each day. Artists welcome visitors, sharing the artistic and technical aspects of their work. Visitors learn the stories behind the creations, many of which are for sale.
