## The Rockingham Meetinghouse

BY RON PATCH

Below is some history from "The Connecticut River Valley in Southern Vermont and New Hampshire by Lyman Hayes, 1929." It relates to building the meetinghouse:

"Mrs. Ezekiel Weston was the daughter of David Haselton, who was born in 1791. Mrs. Weston says that she distinctly remembers that her grandmother, Jane Haselton, wife of Richard Haselton, related to her that her eldest child, Uriel (Mrs. Weston's uncle), was born on the 6th day of June, 1787, and that on the 9th day of June of the same year, before departing for the raising of the meeting house, her husband Richard, came into the house and bade her and their baby, who was then only three days old, goodbye, expecting, or fearing, at least, that he might be killed at the raising, but, on the contrary, returned in safety to his family after the house was raised. And further, my brother, E.W. Allbee, says he distinctly remembers hearing our father, Ebenezer Allbee, who was born on the 17th of April, 1768, say that he was at the raising, being then 19 years of age, and that it was in June, 1787, but he does not recollect the day of the month. The statement of Mrs. Weston fixes the precise date as June 9, 1787, of which there can be no doubt.

"An aged man living in Greenfield, Mass., in 1887, in a letter to A.N. Swain of the Belows Falls Times about the old meeting house building says: "It was my good fortune to have met General Fuller several times during the summer of 1816, who was the master builder of this old house. I was told at that time that when all was

ready Mr. Fuller quietly took his place on the beam and went up with the front broadside, as was customary in those days. At the time I saw him he lived in the Dr. Campbell house, so called, now owned and occupied by Rodney Wiley. I think it must have required three or four extra men to carry Mr. Fuller up, for at the time I saw him he was good for at least 250 pounds.

"A letter written by an old man living in Nashua, N.H., July 7, 1884, gives the following additional details of the 'raising':

"I can remember any event told me 70 years ago easier than incidents that took place five years ago. The year I was 16 years old my father died in Rockingham and I was obliged to work out from home. I went to work for old General Fuller. He lived one mile from the middle of the town and was the man who built the meetinghouse. He gave me a full account of the time they had at this raising. After he got everything ready the old General took a bottle of rum in one hand, a tumbler in the other and stood on the plate of the bent on the south side, then he gave the order to put it up in that position. He rode up on the plate, and he was a man weighing 200 pounds. When they had got it up he stood on the plate, drank his health to the crowd below, then threw his bottle and tumbler down and called for the ladder, coming down amid long and loud cheering.

"The Rockingham meeting house is 56 feet long and 44 feet wide. It was built of heavy old growth pine timber, portions of the frame and roof being 14 by 16 inches square, which must have required the combined efforts of a large force of men to raise in sections, or 'bents'.

"Without doubt serious accidents occurred at times at those 'raisings' of olden times, as feared by Richard Haselton, and described below:

"At the raising of the present church building in the village of Langdon, N.H., in June of 1842, a portion of the heavy frame fell killing one man and seriously injuring 15 or 20 others.

"March 15, 1804, Rev. Samuel Whiting posted the following unique, but expressive, notice upon the door:

"Notice - John Parks Finney and Lydia Archer, of Rockingham, came to my house, and having been published agreeably to law, but he was a minor and not having his father's consent, I refused to marry them. They, however, declared that they took and considered each other as husband and wife, meaning to live and do for each other accordingly."

## OLLI Launches Fall 2022 semester

SPRINGFIELD, Vt. - Katie Wood Kirchoff, Curator from the Shelburne Museum, will launch the Fall 2022 semester of the Osher Lifelong Learning Institute (OLLI), with the program "Luigi Lucioni: Modern Light" on Tuesday, Sept. 20 at 2 p.m. at the Nolin Murray Center next to St. Mary's Church on Pleasant St. in Springfield, Vt.

Dubbed Vermont's "Painter Laureate" by Life magazine in 1937, Luigi Lucioni was a twentieth-century realist painter and printmaker best known for his scenes of Vermont. There is currently an exhibition of his work on

display at Shelburne Museum until Oct. 16. Kirchoff will present a program about his work and life, highlighting details from the new publication about his work that she helped to write in coordination with the current display.

Sponsored by the University of Vermont, OLLI is run by local volunteer members and is geared mainly towards seniors who are 50 years of age and over who enjoy learning for the fun of it. Anyone who would be interested in this type of program, regardless of their age, is welcome. The programs are held Tuesday afternoons at 2 p.m. and last about an hour-and-a-half.

Pre-registration is highly recommended. However, if

you arrive without having registered, we will not turn you away. We will hand you a form and an addressed envelope to send in payment after the program.

The next program on Oct. 4 will be "May Lou Williams: Composer, Pianist, Pioneer!" presented by music historian Erik Nielsen and will highlight her influence on the American jazz world.

## LRC hosts Steven Price for lunch

LUDLOW, Vt. - At a recent meeting of the Ludlow Rotary Club (LRC), Steven D. Price, noted author of many equestrian books, spoke to the members about his varied career in writing about horses.

He indicated that, as a youth attending a summer camp, he was "somewhat accidentally" introduced to horseback riding. Apparently, his instructor thought he was an experienced rider and put him on an aggressive horse. This was the beginning of a long relationship with horses, albeit, a rather "bumpy" start that evolved into a more seasoned and creative experience.

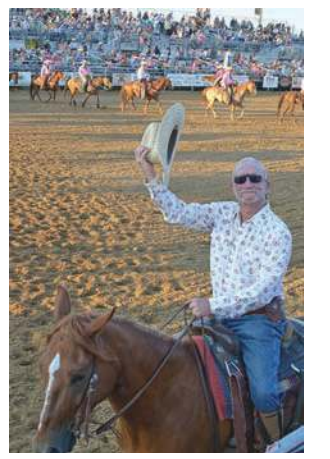
Price said that he rode "in Bermuda, Colombia, Ireland, England, France, Spain, Portugal, and Holland. I've ridden on American dude ranches and cattle ranches, fox hunts, and horse shows. Other highlights include galloping a horse on Santa Anita's main track, and in a Texas rodeo opening parade."

One of the highlights of Price's career was watching the 1973 Belmont Stakes in the Jockey's Room at the Santa Anita track that Secretariat won by 31 lengths, winning the Triple Crown. He said that at the finish of the race, the entire room of experienced jockeys arose and applauded Secretariat.

Price is the author or editor of 44 books dealing both with equestrian and other subjects,

including "1001 Dumbest Things Ever Said," "The Quotable Horse Lover," "The Ultimate Fishing Guide," and "Old As the Hills: The Story of Bluegrass Music."

## Senior Solutions, Seasonal Fuel Assistance

September is here – which means it is time to sign up for Vermont’s Seasonal Heating Fuel Assistance Program, which can offset winter heating costs by anywhere from a few hundred to even a few thousand dollars. Senior Solutions is launching a two-month campaign to help residents apply for assistance through Vermont’s LIHEAP program, which could help lower

your bills if you heat with oil, kerosene, propane, electric, coal, wood pellets, or cordwood. Half of Vermont seniors who are eligible never even apply, leaving money on the table. Many others wait until the middle of winter, when the temperature, fuel level in the tank, and bank accounts are all running low. But by waiting until after November, even those found eligible

receive only a portion of what they would otherwise be awarded. This program is income and household-size based. If your monthly income is at or below \$2,096 (single person), or \$2,823 (household of two), you may qualify. As household size increases, so do income limits. Benefits are sent directly to your fuel company on your behalf, giving you a

credit for the season. In the case of wood, it will either appear on an EBT card containing a cash amount, or could be directly deposited into your bank account. There are many misconceptions about this program: It doesn’t matter if you own your home, or rent, as long as you are incurring a heating cost. It doesn’t have an “asset test,” so the value of your

vehicles, property, and bank accounts are immaterial. Vermont residents may drop in without an appointment at any of the following locations during September to apply: Thursday, Sept. 8 – Weathersfield Food Pantry, 2-4 p.m. Tuesday, Sept. 13 – Wardsboro Library, 11 a.m. – 1 p.m. Wednesday, Sept. 14 –

## How does inflation affect me?

Are you saving for retirement? For your children’s education? For any other long-term goal? If so, you’ll want to know about something that can impact your savings: inflation. Inflation is the increase in the price of products over time. Inflation rates have fluctuated over the years. Sometimes inflation runs high, and other times it is hardly noticeable. The short-term changes aren’t the real issue. The real issue is the effects of long-term inflation.

accumulated wealth buys less and less, just with the mere passage of time. And those who put off saving and investing are impacted even more.

The effects of inflation can’t be denied – yet there are ways to fight them. You should own at least some investments whose potential return exceeds the inflation rate. A portfolio that earns 2% when inflation is 3% actually loses purchasing power each year. Though past performance is no guarantee of future results, stocks historically have provided higher long-term total returns than cash alternatives or bonds. However, that potential for

greater returns comes with greater risk of volatility and potential for loss. You can lose part or all of the money you invest in a stock. The principal is automatically adjusted every six months to reflect increases or decreases in the CPI; as

long as you hold a TIPS to maturity, you will receive the greater of the original or inflation-adjusted principal. Unless you own TIPS in a tax-deferred account, you must pay federal income tax on the income plus any increase in principal, even though you won’t receive any accrued principal until the bond matures. When interest rates rise, the value of existing bonds will typically fall on the secondary market. However, changing rates and secondary-market values should not affect the principal of bonds held to maturity.

Diversifying your portfolio – spreading your assets across a variety of investments that may respond differently to market conditions – is one way to help manage inflation risk. ## Cavendish Energy Committee talks compost

**CAVENDISH, Vt.** — The Southern Windsor/Windham Counties Solid Waste Management District in conjunction with the Cavendish Energy Committee and the Town of Cavendish will host a workshop specifically about composting on Thursday, Sept. 15, 2022 at 6:30 p.m. in the Cavendish Town Offices, 37 High St., Cavendish, Vt. Masks will be required for all. State regulations on safety will be adhered to.

Vermont state law has banned food scraps from household trash since July 1, 2020. Residents are required to compost their own food waste, or take their food scraps to a facility for composting. This rule has existed for approximately five years for restaurants, grocery stores, and other large food generators. How

can we as Vermont residents best comply with the new rules? Composting is easy, and beneficial to the soil, whether you create it in your backyard or take it to the Cavendish transfer station.

Ham Gillett of the Southern Windsor/Windham Counties Solid Waste Management District will address the aspects of Vermont Act 148 that relate to composting of food waste and recycling. Peter LaBelle of the Cavendish Energy Committee will join Gillett to discuss the basics of home composting and the other options available in order to comply with the law and to keep food scraps out of your trash. The presentation will last about 45 minutes with plenty of time afterwards for questions about composting and recycling in general.

As a bonus, all attendees will be eligible to win the

door prize of a new Soil Saver composter and may order composters for residential use. While these bins normally retail for \$100 each, they will be available to workshop attendees for \$65. Please bring exact change or a check; there will be no way to process credit cards. A second drawing will be held for a compost pail, good for kitchen use to gather scraps bound for the composter. These pails will also be for sale at the workshop for \$5 each.

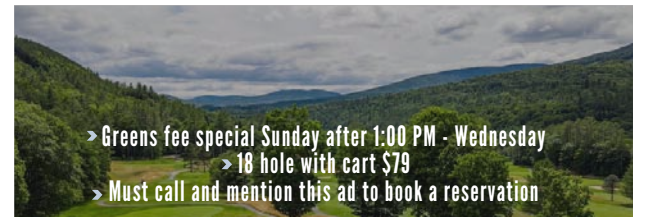

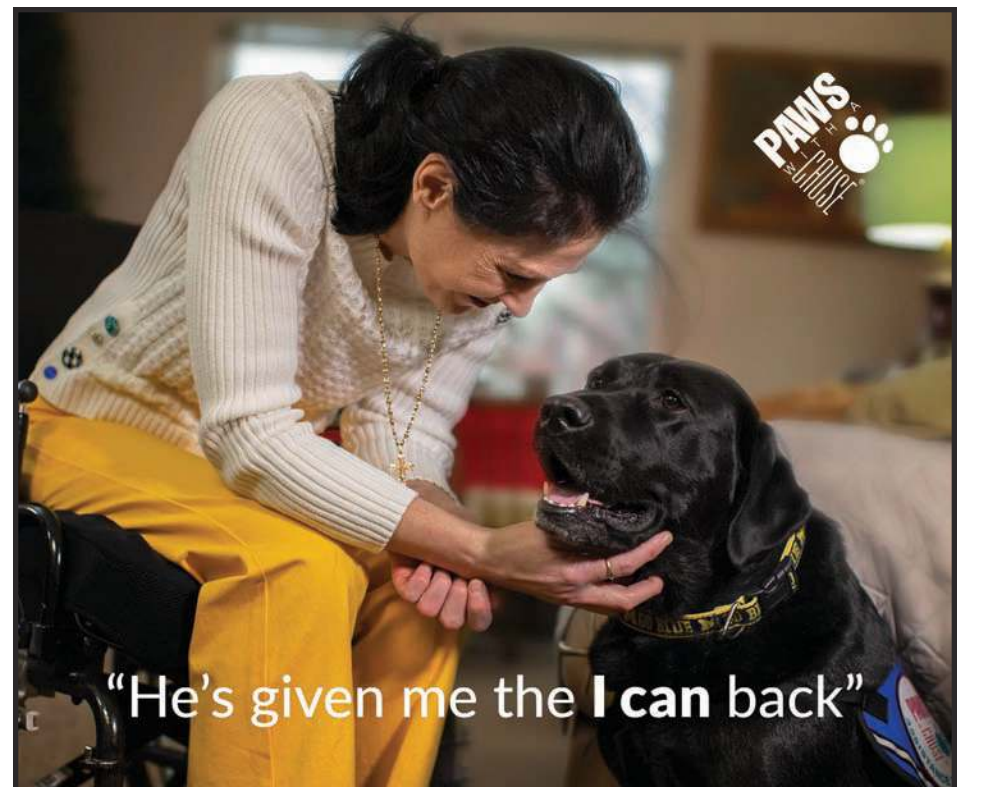

Cited by BBC Traveling Folk as “the most exciting vocal group in a generation... subverting expectations and redefining the genre,” Lynn Rowan, Will Rowan, Lauren Breunig (daughter of Fred Breunig of Nowell Sing We Clear fame), and Jeremy Carter-Gordon share a vibrant energy onstage, their connection to each other and to the music clearly evident. They

educate as they entertain, telling stories about the music and explaining the characteristics of the traditions in which they sing.

But there’s another, crucial dimension to Windborne. They are adherents to folk music’s longtime association with social activism, labor, civil rights, and other movements that champion the poor, the working class, and the disenfranchised. Drawing on songs from 400 years of these movements, they were launched to new heights in 2017 when a clip of them singing a protest song from the 1840s outside Trump Tower went viral. They continue to center their work around songs of social struggle.


