Trustees discuss opioid settlement

BELLOWS FALLS, Vt. – On Tuesday, Nov. 8, 2022, the Bellows Falls Village Trustees discussed the National Opioid Settlement payment to the village.

There were \$26 billion in settlements paid in February by the “Big Three” drug distributors, Amerisource-Bergen, Cardinal Health, and McKesson, along with opioid manufacturer Johnson & Johnson. Ninety percent of litigating local governments confirmed participation to receive recovery funds.

Municipal Manager Scott Pickup explained that the village will have received two separate distributions by the end of 2022: \$3,186 in July and \$3,348 in November. Pickup said at last week’s Selectboard meeting, Turning Point South representatives joined Greater Falls Connections (GFC) Director Laura Schairbaum to present their proposal for a town-funded community outreach coordinator. Turning Point South representatives Zach Labelle and Lama Tomas O’Flaherty Jr. asked the Town of Rockingham for a one-time grant of \$4,050, to pay 24 weeks for a part-time outreach coordinator, and for signs at George Street and at the entrance of the carriage house at GFC. The town approved the request as a 24-week

trial with their settlement funding.

Pickup explained that Turning Point South worked with GFC, and the signs would be on the fence at George Street and the Parks Place carriage barn. He said that Turning Point also worked with drug treatment and awareness programs in both Springfield and Brattleboro.

Pickup said this was an agenda item for trustee feedback and opinions; at the moment there was no specific proposal. Trustee Wade Masure asked if there were certain stipulations for where the money went. Pickup said it was a loose definition of health and wellness and there were no guidelines. Trustee Jeff Dunbar was curious about the town’s one-time grant proposal, asking what other resources there were for rehabilitation services.

Pickup said that the town’s proposal was a trial to see if it was effective for recovery and treatment. McAuliffe said he wanted to be sure the money was used in the village, and mentioned Covid’s effect on social services. He said that Parks Place was thriving, and “Laura is the only tenant left.” McAuliffe admitted it was a shame she was leaving, saying, “She’s been a great force in this community.”

Parks Place recently hired Jennifer Tolaro-Heidbrink

as Director to replace Schairbaum.

Pickup said the problems in Bellows Falls are greater than the \$7,000 they received, suggesting there might be ways to use the money to leverage other funding. He admitted a lot of people have been impacted by opioids.

Village President Deborah Wright said she knows there are organizations who assist people in rehabilitation with housing and mentioned the last time she heard from Turning Point they had approached the trustees to look at recovery housing.

Masure asked where the money was located. Pickup said it was in a dedicated account and not in the general fund, so they could appropriate how to use it and when, but agreed it should be separate. He said he would ask Finance Director Alyssa Harlow to highlight the account and Wright asked for it on the monthly report.

The board agreed to consider feedback and proposals before they decided how to spend village settlement funds.

Trustee meetings are on the second and fourth Tuesday of the month at 6 p.m. in the Lower Theater of the Bellows Falls Opera House.

Parks Place announces new Executive Director

BELLOWS FALLS, Vt. – Parks Place, a community-based resource center located in Bellows Falls, recently announced the hiring of Jennifer Heidbrink as their new Executive Director. A lifelong Bellows Falls resident, Heidbrink has several years of experience in the area of social services and states that she is excited to have this new opportunity.

“I have deep roots in Bellows Falls, and both my parents are from here as well,” Heidbrink said in a recent interview. “They adopted me from Korea when I was two months old, and I have lived here ever since, and now with my husband and two children.”

Heidbrink graduated from Vermont Academy before receiving a Bachelor of Arts degree in developmental psychology at Keene State College, and then a Master’s degree in clinical mental health counseling at Antioch University in 2012. She also has had a mental health counseling license in the state of Vermont since 2015.

“After graduating with my Masters, I worked at HCRS as a school-based clinician at Riverside Middle School in

Springfield,” Jennifer said. “I was then hired directly by the Springfield School District as a Clinical Case Manager at the Gateway Program. I provided counseling services, case management services for families, and counseling services for teachers.”

When Gateway closed, Heidbrink accepted a Therapeutic Case Manager position at Youth Services in Brattleboro, where she worked with young people who needed support with housing, mental health, education employment, and independent skills. Jennifer also ran the youth homeless shelter in Bellows Falls, and co-facilitated JUMP (Just Us Moms Program).

“My most recent employment was with Windham Northeast Supervisory Union (WNESU), working there for six years in many different roles. I began by supporting the district in building a behavioral classroom using trauma-informed interventions to help support students. I provided counseling for students and helped implement trauma-informed techniques in classrooms.”

Most recently, Heidbrink was the Early Education Home to School Liaison and the McKinney Vento Home-

less Liaison, where her responsibilities included meeting with families and helping them locate resources in the area, delivering food and school supplies to hotels, supporting communication between families and the schools, and facilitating local playgrounds. Jennifer has also worked at the Bellows Falls Opera House selling concessions, and is now the Operations Coordinator.

“Here at Parks Place, we are currently organizing a holiday program, partnering with Chroma, WNESU, the Bellows Falls Rotary, and the Auxiliary, to provide gifts for families in the Windham Northeast area. Please reach out to Parks Place if you are interested in donating for a child or would like to make a monetary contribution.

“I would like to thank all the past executive directors for their hard work and dedication to this community. I would especially like to acknowledge [fellow Parks Place employees] Megan Applegate and Julie Cermola for their hard work and commitment through the pandemic.”

Vermont passes Article 22, reproductive liberty

As of Tuesday, Nov. 8, 2022, the State of Vermont has enshrined rights to reproductive liberties within its borders; that is, voters

in Vermont elected to pass Article 22, also known as Proposition 5.

The Article passed into Vermont Constitution as of Monday, Nov. 14, 2022. It declares that, “An individual’s right to personal reproductive autonomy is central to the liberty and dignity to determine one’s own life course and shall not be denied or infringed unless justified by a compelling State interest achieved by the least restrictive means.”

Vermont also passed Proposal 2, which amends the Constitution of the State of Vermont to “clarify that slavery and indentured servitude in any form are prohibited.” This proposal also passed into Vermont Constitution as of Monday, Nov. 14, 2022.

“A Little Night Music” opens at Next Stage Arts

PUTNEY, Vt. – The sexy 1973 Broadway musical “A Little Night Music,” presented by the Wild Goose Players, premiered on Friday night, Nov. 11 at the Next Stage Arts theater in Putney, Vt., directed by David Stern, with musical direction by Mary Westbrook-Geha.

With music and lyrics by Stephen Sondheim and book by Hugh Wheeler, the romantic farce tells the story of a group of mismatched, upper middle-class couples in early twentieth-century Sweden. Inspired by the 1955 Ingmar Bergman film, “Smiles of a Summer Night” and described as, “An evening of sexual musical chairs on the longest night of the year,” the musical is perhaps best known for the popular song, “Send in the Clowns.” Morganna Ekkens, who plays actress Desirée Armfeldt, and Gavy Kessler, in the role of lawyer Fredrik Egerman, bring their considerable talents to the classic song, with Ekkens’ performance being especially poignant.

The rest of the cast is equally impressive, displaying a level of professionalism, enjoyment, and nuance. The production was well received by an appreciative audience.

A quintet of singers

opens the first act, entering one by one, harmonizing a blended overture of the show’s songs. These five characters act as a whimsical Greek chorus, and offer commentary throughout the show. The main couples then come waltzing onto the stage, awkwardly switching partners until the prologue ends with the entrance of Madame Armfeldt. Arriving in a wheelchair guided by her butler, Frid (Sam Cotton), and portrayed with a sardonic ennuï by Libby McCawley, Madame Armfeldt philosophizes with her 13-year-old granddaughter Fredrika (Teya Bryan), while playing a game of solitaire. “Solitaire is the only thing in life that demands absolute honesty,” declares the Madame.

Madame Armfeldt tells her granddaughter that the summer night smiles three times at human beings and their foolishness. “The first smile smiles at the young, who know nothing. The second, at the fools who know too little. . . and the third at the old who know too much.” This prediction plays out in a touching and delightful way, through an

evening of exposed secrets, romantic trysts, true love, jealousy, and soul-searching.

Involved in theater for over 35 years, Stern became the Artistic Director for the Wild Goose Players after filling that role at Main Street Arts in Saxtons River from 2014–2020. While there, Stern, and much of the “Wild Goose” team, led productions including “Sweeney Todd,” “Jesus Christ Superstar,” “Chicago,” and “The Secret Garden.”

Welcoming the crowd to the Next Stage Theater, Stern thanked everyone for coming and supporting the Wild Goose Players and community theater in general. He encouraged everyone to join their team of dedicated volunteers, either on stage performing, or working behind the scenes, and added that monetary donations were also always welcome.

The Wild Goose Players call Bellows Falls, Vt. home. Their next production, the Mark Hollmann/Greg Kotis musical “Urinetown,” will go on at the Bellows Falls Opera House in March of 2023. A summer 2023 production coinciding with the 100th anniversary of “The Velveteen Rabbit” will be performed outdoors, with free admission for kids.



Crown Point Road trip

Last week, Lonnie Lissai and I went exploring some of the 1760 Crown Point Road in Cavendish. Lonnie is now on the board of the Crown Point Road Association. Lonnie wanted to show me the site where, in 1760, a soldier died while building the Crown Point Road. He was buried right beside the road.

We were on Brook Road when Lonnie pulled over. I followed Lonnie a short distance into the woods to see a small marble marker for a Civil War soldier. Another 150 yards or so and we reached the gravesite for the soldier who died building the Crown Point Road.

federate positions at Petersburg, Va. on April 2, 1865.

His citation reads, "With the assistance of a few men, captured two pieces of artillery and turned them on the enemy."

Brevetted Lieutenant Colonel, U.S. Volunteers to date from April 2, 1865, he was appointed full Lieutenant Colonel on June 4, 1865, but was mustered out on June 26, 1865, before the rank could become official. His medal was awarded to him on Aug. 12, 1892."

The Union victory at Cedar Creek was considered a turning point in the North's favor. This victory assured the re-election of President Lincoln.

Years ago I read something about a Medal of Honor being lost in the 1927 Cavendish flood. My memory fades with time, but I do recall it was found years later downstream. I mention this because in 1928 Sperry's widow was issued a replacement Medal of Honor.

Why is Sperry's marker in the woods? This marker was his first marker. His rank is given as Major (not Lieutenant Colonel), and there is no mention of his Medal of Honor. So, sometime later the first marble marker was replaced with another, corrected marble gravestone. The replacement marker reads: "WIL-

LIAM JOSEPH SPERRY MEDAL OF HONOR CIVIL WAR LIEUT. COLONEL 6th VT INF DEC 28 1840, March 3 1914."

This replacement marker corrects the error of Major on the first stone to Lieutenant Colonel as well as having a Medal of Honor engraved thereon.

How or why this first marker ended up in the woods I do not know. One thing is for sure, Sperry is not buried in the woods. Both the first and second marble markers are Government Issue.

Sources for this article include "Peck's Roster of Vermont Civil War Soldiers and Sailors," Find a Grave, Danny Clemons and Ken Barrett.

Lonnie and I have made a couple trips together. First we went to Summit Cut in Mount Holly. That was a real workout. We plan to make additional trips in the near future.

A while back Lonnie asked for my assistance identifying objects at the Adams Grist Mill Museum in Bellows Falls. I was able to identify many of artifacts. I share Lonnie's enthusiasm.

Here is part of William Sperry's service record:

"Civil War Medal of Honor Recipient. He entered Civil War service soon after the start of war, being mustered in as a private in Company E, 1st Vermont (three month) Volunteer Infantry on May 9, 1861. He served through the engagement at Big Bethel, Va. in June 1861, and was mustered out when his enlistment expired on Aug. 15, 1861. On Oct. 15, 1861, he was mustered in as a Sergeant in Company E, 6th Vermont Volunteer Infantry, and served continually through the war, receiving promotions to 2nd Lieutenant on Aug. 21, 1862, 1st Lieutenant on March 3, 1863, Captain on Aug. 8, 1864, and to Major on Jan. 7, 1865.

At the Oct. 19, 1864 Battle of Cedar Creek, Va., he assumed command of the regiment when he became the senior unwounded officer.

He was awarded the Congressional Medal of Honor for his bravery in the final Union Army assaults on Con-




Brownell "Brownie" Asa Bacon, 1937-2022







Students plant native trees for water quality, wildlife

WESTMINSTER, Vt. – The Windham Conservation District and the River Valley Technical Center partnered with local landowners and the Vermont Land Trust to plant native trees and shrubs along a tributary of Sacketts Brook in Westminster on Oct. 27. Students, under the direction of John Harmer, spent the morning learning about riparian planting practices while helping the district to plant 260 native shrubs and trees. “The students did a terrific job on this project. Windham NRCDC works with local landowners to identify priority sites for restoration and leverages state funding and local volunteers to plan and implement these plantings through the Trees for Stream Program. This planting was funded by a grant from the Vermont Natural Resources Conservation Council using Clean Water Funding from the State of Vermont. Additional support was provided by the Vermont Land Trust and the U.S. Fish and Wildlife Service. Forest Service, Christmas Tree permits

RUTLAND, Vt. – U.S. Forest Service officials in Vermont are welcoming the public to select and cut a Christmas tree on the Green Mountain National Forest (GMNF) with the purchase of a \$5 permit. Permits are now available for purchase either online (an additional \$2.50 service fee applies) or in-person at our GMNF offices in Manchester or Rochester,

Vt. In support of the Every Kid Outdoors initiative, this year the Forest Service will provide fourth grade students with a free Christmas tree voucher by registering at www.everykidoutdoors.gov. Fourth graders who register must present a printed voucher to redeem a Christmas tree permit. Christmas trees for personal use may be cut on the GMNF, subject to the following conditions:

located in Manchester or Rochester. Please confirm that our office locations are open by making an appointment prior to travel. Permit cost is \$5 and is non-refundable. Permit must be attached to the tree before transporting it from the site where it was cut.
