## Electric ratepayer concerns

**LUDLOW, Vt.** – The Aug. 24 meeting of the Ludlow Electric Light Department Board of Commissioners began with a presentation from Ken Nolan, general manager of the Vermont Public Power Supply Authority (VPPSA), explaining to the board and those present what VPPSA is, and what Ludlow gains from its membership in VPPSA. There had been concern from ratepayers at the previous board meeting in July, where it was discussed that Ludlow had been paying VPPSA to implement a geographic information system (GIS) project for several years, apparently without usable results.

Nolan explained that VPPSA is a collection of small utilities throughout the State of Vermont, which provides services via aggregation of resources that would otherwise be difficult for small utilities to implement independently. For example, VPPSA monitors legislation and lobbies on behalf of its member utilities, constructs power plants of which member utilities may own shares, and provides IT support to its members. Ludlow is one of 11 current member utilities of VPPSA, the majority of which are in the northern portion of the state. Ownership of VPPSA is vested in its member utilities. "Ludlow is actually a partial owner [of VPPSA]," Nolan told those

present.

Nolan acknowledged that Ludlow had opted out of the VPPSA GIS project, though he said in response to questioning that there had not been a contract between VPPSA and Ludlow Electric, explaining that the VPPSA Board of Directors – which is composed of one representative from each of its member utilities – had initiated the project with the consent of all 11 members,

as a joint effort. Nolan asserted that some aspects of the project, for which Ludlow has paid over \$75,000 to date, were usable. "Part of that [cost] was for licenses for software that you were able to use. I acknowledge... that we did not move in designing the system the way Ludlow wanted it to be designed quickly enough, but the data was there," Nolan stated. Though ratepayers in attendance wanted to know if and how the cost of the GIS project could be recouped, Nolan explained that any refunding of the cost of the project would have to be taken up with the VPPSA board, of which Ludlow Electric Department manager Thomas Petraska is a member.

Concern was raised that Ludlow is currently contracted with VPPSA for its Advanced Metering Infrastructure (AMI) project, with those present wanting assurances that it would not turn out the same way as the GIS project. The AMI project is being done in response to a multitude of state requirements. When completed, it would allow metering to be done remotely, without the need for manual meter reading, among other advanced functionality. Nolan told the assembled ratepayers that the GIS project is one of "30 or 40" projects for which VPPSA is responsible, the others of which he claimed have been successful, and that the GIS project is currently being brought

back on track.

Responding to a question from foreman Brian Benoit about the repercussions of failing to implement AMI, Nolan stated that "Ludlow Electric only exists because it was given a franchise territory by the State of Vermont...if they ever make a determination that you're not keeping up with what they want you to do policywise...your franchise [can

be] revoked," though he noted that this is a rare occurrence. Nonetheless, he said that increased scrutiny by the Vermont Public Utility Commission (PUC) could result, making things such as necessary rate increases more difficult.

The board then went into executive session to discuss a personnel issue, after which they returned and authorized a motion allowing the chair to issue a written reprimand to an employee regarding the matters discussed.

Other issues raised by

those present were those of job descriptions and duties, safety and supervision, and the hierarchy of the electric department, specifically the removal of the position of superintendent. Several of these issues had been raised at the previous meeting, with Petraska telling those present that the department's handbook was currently undergoing revision to reflect the changes in the department's structure, and clarify the duties of its employees. Concern was also raised that Benoit was not himself a lineman, though he is responsible for supervising linemen, leading to what some saw as potential safety concerns. Commissioner Robert Brandt responded that this is also the case at Green Mountain Power (GMP). Ludlow ratepayer Steven Stariknok countered that GMP employees have access to greater resources when they are unsure of something, given the size of GMP's staff compared to Ludlow's. "If someone in a supervisory position doesn't have electrical experience, they can go to someone that does before a decision is made,"

# Londonderry talks recovery and Spring Hill culvert —

LONDONDERRY, Vt. -The Londonderry Selectboard gave updates on the storm damage at the Aug. 21 meeting. Town administrator Shane O'Keefe noted that he would be having a phone discussion with FEMA, and has scheduled an in-person meeting for Aug. 30 to go over the requirements for the town. The board also designated Bill Kearns as their FEMA representative, stating he "jumped right in" to the work.

Board member Martha Dale wanted to go over matters that are urgent beyond FEMA and road and bridge repair. She said this is the time for the town to "take advantage of this unfortunate situation to think about how we might rebuild better." Dale noted there was a Main Street study done previously by Stevens & Associates, an architecture, civil and structural engineering, and landscape architecture consulting firm in Brattleboro. Dale suggested using the study and research as a basis for

new plans and redesigns. Dale urged that the status quo isn't working in terms of business locations and their safety and protection against future floods and damages. "Not doing anything isn't an option at this point," Dale stated. The town needs to guarantee lower flood risks, stating local businesses help generate a robust tax base for the town, and they need to keep their business owners in mind.

Dale suggested the town is going to need

outside help, in addition to FEMA funding, and suggested getting a consultant who knows where the money is and where to apply it. She wants to see the town explore more possibilities for funding, and construct

a better 100-year flood plan.

The board was then updated that the U.S. Environmental Protection Agency (EPA) and the State of Vermont paid for the pickup and disposal of hazardous waste from the flood, 75% EPA and 25% state funding. The town won't be collecting any more waste until the Oct. 7 hazardous waste collections.

The town had slated a flood recovery day for Aug. 26, but pushed for another date, suggesting Sept. 16 might be more suitable.

Londonderry received a VTrans structures grant, and hired HGA as the engineer for the Spring Hill Road culvert replacement project. The scope of the project and preliminary plans are in place to construct a temporary culvert, and later get a permanent structure in place. The replacement requires historical and archaeological assessments, addressing the footprint and impacts, cam revisions in spring of 2024, with the final temporary design completed in the summer of 2024. The town would then accept bids in the winter for the long-term design, and the construction and completion of the permanent replacement would take place during the summer of 2025.

O'Keefe said there would be a two or three month closure in the summer of 2025, and also noted that although the town received grants, they will likely need more funding to complete the project, though they won't know final costs until they get bids. They reviewed bids for the temporary replacement project; Hunter Excavation at \$70,000 and Ameden Construction at \$55,000. The board accepted the bid from Ameden Construction.

The board also reviewed construction firms to contract for assistance with engineering and road repairs, and accepted Hammond Engineer. They said Everett Hammond has done right by the town, and has the experience. He is close by, a member of the Springfield Selectboard, always available, familiar with the town, and the least expensive.

Residents Bill Sinsigalli and Jennifer Ogden of Under The Mountain Road were in attendance, seeking information on the town's short-term rental (STR) ordinance. They were concerned that there is a loophole in the ordinance on the limitations of STRs being owner or non-owner occupied, as well as how many STR dwellings one person could operate. They don't want to see the rural area become overwhelmed with short-term tourists. The board agreed the couple had raised a good question about numbers and regulations, and put it on the next agenda in order to have the full board in attendance.

The town plans to have an inspection and plan for the repairs of Williams Dam for the safety of the community. They have to show FEMA the plan and get it approved before moving forward with any repairs.

The town clerks and treasurers office will be closed Sept. 12 and 13 for training, and the board will not be meeting on Labor Day. The next selectboard meeting will be Monday, Sept. 18.

Stariknok said.

The continuing issue of staff retention was also discussed. The idea of contracts obligating a certain length of service with Ludlow in exchange for training was again suggested, though Brandt responded that he was against this idea. "Do you want somebody working here who's not happy?" Brandt asked. Several people wondered out loud why employees would be unhappy.

Some suggested that Ludlow Electric begin to deplete its \$3 million reserve in order to pay its staff more and. hopefully, retain employees. This would, it was thought, have the added effect of causing the PUC to approve rate increases more readily, as the large reserve of cash makes the PUC hesitant to approve rate increases, despite the fact that Ludlow is currently operating at around an \$800,000 deficit, according to the board. Petraska explained that the PUC does not consider future expenditure plans when considering approval of rate increases, but looks only at actual expenditures and reserves for the previous year.

The board eventually

moved on to the remainder of its agenda. Benoit gave his foreman's report, which resulted in the approval of the purchase of new fuel tanks to replace rusting older ones at the end of their lifespan. The tanks will cost around \$24,000 in total, and have a 30-year warranty.

Petraska gave his manager's report, noting that Ludlow Electric is participating in a voluntary two-month moratorium on disconnections in response to the recent floods. He also told the board that, on Aug. 22, the electric department had a closing conference with the Vermont Occupational Safety and Health Administra tion (VOSHA), regarding an "accident" which happened on April 21. He told the board that citations would be mailed to the electric department.

In discussing business for their next agenda, Brandt suggested to the board that they discuss pay raises for Ludlow Electric employees. "We did our raises last December, assuming that the town was doing 5%," Brandt said. "However, the town has done 10%, so I'd like to bring that up next meeting and vote on [increasing our pay raises to 10%]." Brandt noted that, while that still will not see Ludlow Electric employees being paid similarly to their counterparts at GMP, it would make the pay competitive with other small utilities.

The Ludlow Electric Light Department Board of Commissioners meets on the fourth Thursday of every month, at 4:30 p.m. Currently, the board is in talks to move the meetings to the

## Artemas Leonard and Son

In the early to mid-19th century, here in New England, many firearms were individually built by highly skilled craftsman. Artemas Leonard of Saxtons River was one such craftsman.

His shop was on North Street in Saxtons River. He produced percussion firearms, including pistols, shotguns, target rifles, and over and under guns with combination rifle and shotgun

Over the years, I have seen a few of his firearms. He is known for his excellent rifling of barrels, creating very accurate rifles. He died in

The subject of this article is Artemas' son George. He was born in 1829 in Sax-

tons River. Growing up, he worked in his father's shop learning the trade. When his father died in 1859, George moved to Keene, N.H., to set

I have seen firearms marked George O. Leonard, Saxtons River. The over and under pictured with this article is marked "Geo O. Leonard, Keene N.H." If he moved to Keene in 1859, and had left Keene by 1869, as he had, this firearm dates between 1859 and 1869.

This gun is an over and under. The top barrel is rifled, and approximately .477 caliber. The bottom barrel is a 20-gauge shotgun. The wooden stock is cherry or walnut, with a cheek rest. The old original finish makes it difficult to determine the wood, but I lean towards cherry.

It has a crescent butt plate,

brass furniture and patchbox, lollipop tang sight, and a German silver inlay of a hunter and his dog. It's a very attractive firearm.

Leonard firearms have always been desirable. This gun is from a private home, where it has been for over 150 years. I can't imagine there are many left today with this pedigree.

From the same home is a percussion 12-gauge double in original fitted case. The fitted compartments are lined with green felt. The case is walnut with dovetailed corners. While a few compartments are empty, there is a powder flask, what I think is a vise for installing the spring, nipple wrench, and screwdriver. It is impres-

Masks are dangerous for democracy and health. After reading about the next Stage 33 concert in the Aug. 23 edition of The Vermont Journal & The Shopper, I was about to purchase my ticket. But as I continued reading, I discovered that "masks are required at this event, as one of the performers is immunocompromised." I put my credit card

Here are my objections to this mask requirement:

1) In a democracy, masks must be voluntary only, never required.

2) I cannot be responsible for my neighbor's immune system. My immune system is compromised by many Lyme co-infections. I take full responsibility for keeping myself active and functional, without a mask and without vaccination, which would compromise my already hard-working immune system.

3) Surgical masks do not prevent microbe migration. I was taught this in respiratory therapy school 30 years ago. N95 masks are to be used only for 20 minutes or so when a health professional enters the room of a person with a contagious disease like tuberculosis. Dr. Fauci's first masking statement said masks don't work. Two weeks later, he fudged and said masks do work. What are your thoughts?

4) While a mask actually does not corral microbes, it does collect carbon dioxide. The wearer then rebreathes carbon dioxide instead of air. This can cause fatigue, sleepiness, headaches, and long-term physical and mental effects.

5) Children and athletes should never wear masks. Their breathing rate is too fast to clear carbon dioxide and allow oxygen to enter.
