58th annual Weston Antiques Show

WESTON, Vt. - The two day Weston Antiques Show is a fundraiser that enables the Weston Community Association to offer entertainment throughout the year.

There were 33 exhibitors offering a plethora of antiques in traditional to contemporary styles. In every corner of the Weston Playhouse's three levels was some item that could satisfy anyone's taste.

One hundred percent of the funds achieved through preview and admission tickets, booth rents, corporate and individual sponsors go towards preserving and maintaining the Playhouse and other historical buildings for future generations to continue to enjoy.

The show was administered and staffed all by volunteers.

For those interested buyers wanting a sneak peek of the array of antiques, a preview was held last Thursday night.

The evening gala was catered by The Inn at Weston.

Besides Vermont, vendors came

from all over the States; Maine, New Hampshire, Connecticut, Massachusetts, Pennsylvania, New York, Kentucky, New Jersey, Virginia, Illinois and South Carolina.

Many of the exhibitors are second- to third-generation antique dealers.

They say it is in their blood. The passion for antique dealing brings people together. Such as is the story of husband and wife John and Robin Chase Sittig. Both of their mothers were dealers and went to the same show back in the '80s; this is where John and Robin met and have been together ever since.

Antique dealers are more than just dealers; they are historians selling tangible pieces of history. Taking

time to talk to them is part of the enjoyment when attend the Weston show. Each vendor was friendly and eager to tell the stories behind each piece.

Sue Lilly of The Red Horse enthusiastically explained the usage of carpet balls. Originating in England and Scotland, carpet balls were the indoor parlor version of Bocce balls. They are made of ceramic, weighted down with lead, and glazed in a plaid or starry ringed pattern. Different sizes were made for men, women and children.

Frandino Antique Oriental Rugs filled the theater area. Vintage rugs in every shape and size draped over the seats and hung from the walls.

Hermitage Antiques from Har-

Hermitage Antiques from Har- rison Maine had a 1600s brass Betel nut cracker. The design was folk, oriental with little birds. Betel nut was brought from Asia to Europe by Dutch and Portuguese sailors. This berry was sought after for its nicotine properties, but is hazardous to health.

Fiske and Freeman had the oldest antiques at the show. They had an array of chests, chairs and silverware from the 16th and 17th centuries.

Their oldest item was an unglazed stoneware mug from the 1300s.

Weston Marketplace catered the food for Friday and Saturday. This was their third year, and they are looking forward to many more in the future.

The Weston Antique Show has developed its reputation because of the great location, venue and friendly people.

LUDLOW, Vt. - Local artisans and crafters filled Presidential Hall and were spread out on the front lawn of Black River High School on Sat., October 1 for the 33rd annual Ludlow Harvest Fair with beautiful jewelry, woodworking, soaps, fiber arts, local honey, hand-blown and shaped glass, and other handmade and designed items. The community supported the varied talents of almost 60 local vendors as they perused the crafts and chatted with vendors.

Handmade by Hannah is a new artisan in the community, having just begun her business earlier this summer. Hannah paints custom order signs, and had several examples of her work on display at the Fair. She has designed and painted custom

signs for weddings, birthday parties, baby showers, and gifts for all occasions.

Woolly Bear Soaps and Sundries, since 1986, has been providing friends, family, and the community with soaps made only with pure vegetable oils, essential oils, and natural additives. The business began in Minnesota with Lorlei Baxter, an inspirational teacher. The business grew and grew, and customer feedback and ideas for new scents and experiments are always welcome.

The Community Art Garden, located at 295 Main Street in Chester, offers new experiences and welcomes artists of all ages. At the Fair, the Community Loom continued its debut, where everyone is invited to weave and contribute to this work of Community Art. This Community Loom, made of branches and woven with a love for the community, will

be installed as a part of the Community Art Garden in Chester.

Chase Woodworking, based in Chester, displayed the works of Gary Chase, who builds cabinets regularly, and does some woodworking on the side. For many years, Gary has found enjoyment in his hobby, working with the colors, textures, and patterns in the wood to create beautiful works of art.

Julie Peltier's Rag Bag Designs has been recycling and reclaiming fabrics to create new rugs, bags, and other crafts. Julie was inspired by her grandmother's knack for making crafts of all kinds, and she loves to continue the tradition, create new things, and share them with friends, family, and the community.

Lada Bohac's Glassblowing Studio has been creating hand-blown and hand-shaped glass art for over thirty years. He was trained in the Czech Republic and ten years ago, he brought the business and craft to America. Bohac lives in Windsor County, and specializes in colored glass in a variety of colors and shapes, including pumpkins, witches' balls, birds, turtles, and Christmas trees.

Charlotte MacFadden, a full-time teacher, studied silversmithing a few years ago, and has been vending at craft shows ever since. She has recently expanded her craft to incorporate semi-precious stones and pearls. She is inspired by her mother, Gwendelyn Louise and by nature as she creates beautiful jewelry and art.

LUDLOW, Vt. - Thanks to the generosity of several local businesses and individuals, dozens of music students from Ludlow's Black River High School will be enjoying a complimentary ticket to the upcoming Third Annual Black River Folk & Blues Fest.

The festival will be held on Saturday, October 8 at 7 p.m., bringing a variety of folk-and-blues-based musical acts and talented musicians to the stage at the Ludlow Town Hall auditorium. At last count, more than 20 students of Black River High School music teacher and band director Katie Herrle will be attending the show free of charge.

The event is hosted by the local, non-profit community group "FOLA" (Friends of Ludlow Auditorium). Bruce Farr, FOLA's Program Director, said that he is excited at the prospect of hosting so many young, musically inclined students at the show. "I couldn't be happier about it," Farr said. "It's the reason we founded this music fest

to begin with—to try and expose local Vermonters and others to some really great American roots, jazz and blues-based musical performances."

Farr said that when he and other FOLA members approached a hand-

Beginning in mid-October, Marguerite will be taking private appointments on Mondays at Neighborhood Connections to personally review your supplemental drug insurance plan. If another insurance plan will cost less

for equal coverage, it is easy to switch. It takes less than 5 minutes. You can't be refused coverage for any reason. And, enrolling in a new plan, automatically cancels your old one. Call 824-4343 to make an appointment. You must bring a list of your prescription drugs and your Medicare card. There is no charge for this service.

Signs of Life, new exhibit opening at the Great Hall

SPRINGFIELD, Vt. - The Great Hall presents its sixth annual showcase, Signs of Life, an exhibition featuring the works of husband and wife team Roger Sandes and Mary Welsh. The show will open with an artist's reception for the public on Friday, October 14 at 5p at One Hundred River Street. Wine and light refreshments will be served.

Signs of Life offers the opportunity to extend the glories of Vermont's summer featuring contemporary images of natural beauty and abstract form. Figurative works on nature-based, multi-cultural and art historical themes have been the subject of Roger Sandes' work since moving to Vermont 35 years ago. His large, iconic paintings incorporating symbols of life and human creativity hang in 32 states, D.C., Puerto Rico, Virgin Islands, England, Germany, Switzerland, and Morocco.

Roger Sandes' paintings look like silk and feel like eggshell. "My glazes and washes are highly translucent. Light can pass through the pigment and bounce

off of the white ground. That way the colors can glow. I hope to create objects of contemplation that will attract the eye and reward the viewer with layers of meaning, delightful color, and with allusions to living well."

Mary Welsh's collages are made of found materials from art magazines, art books, calendars and end papers which are glued with acid free acrylic medium on birch or mahogany plywood panels that have been prepared with acrylic gesso. Mary explains:

"My collages are depictions of what we all take for granted — houses, rooms and their contents. Viewing these scenes evokes memories and fantasies..."

One source of inspiration for the artists is their perennial garden. It takes the form of an arc on the sunny south side of their home leading to the entrance. It looks beautiful through thick and thin, and in nearly all conditions. It's a wonderful way to experiment with new color combinations, which often show up in their work. Roger says, "Some things thrive, some jump the beds and escape to the fields, some things we love just never last, but the garden endures."

Case in point is the small barn that Sandes and Welsh share. Though admittedly not perfect, it has served them well over the years. Filled with color studies and sketches, paint-spattered work clothes, material for collages and equipment for building frames, the studio presents itself as a

still-life snapshot of two people who have lived a life in art.

And they've lived it in close proximity. Their workspaces are just a few feet apart, a closeness that invites input, helpful hints and lots of support. "I couldn't imagine working alone," says Welsh. "We really are a team," adds Sandes.

Always, nature is close by, visible through two large windows, which look out on the Rock River. Birds are always around; sometimes deer and once Sandes saw a fisher, a large dark-colored member of the weasel family that he first mistook for a monkey.

"We both have little nature things in our work. Living in the middle of it keeps it in your mind," says Sandes.

Following a multi-million dollar renovation, Historic Fellows Gear Shaper on the Black River in Springfield, Vt. is now known as One Hundred River Street, featuring a medical center, retail stores, a café, and the soaring venue for public art—The Great Hall. Events at the Great Hall are sponsored by the Springfield Regional Development Corporation.

Francis Farrar - Master Whittler

A few, fortunate people are born with an artistic gift. Francis Farrar of Chester was one of these select few. Francis grew up on the family farm on Farrar Road in West Chester during the Depression. Growing up on the farm meant working when he wasn't in school. When he had any free time he took out his pocket-knife and whittled.

Francis graduated Chester High School in 1940 and then went to Goddard College. Peter Farrar, Francis' son supplied me with the information for this story. The most revealing information Peter gave me was a 1940 newspaper clipping regarding his father at Goddard College and Ernest Eniti.

Ernest Eniti was a concert violinist in Europe prior to World War 2. Eniti had played concert halls in: Paris, Budapest, Bucharest, Berlin and Rome. When World War 2 broke out in Europe, Eniti immigrated to the United States and settled in Vermont to teach violin at Goddard College. Below is an edited portion of that 1940 newspaper clipping.

"A violin costs more than I had, so I made one", said Francis Farrar. With no previous knowledge about violins, Francis went to whittling one. Student Farrar told Eniti that he'd like to learn to play the violin, to which Eniti strongly encouraged the young student.

Eniti often went to New York to play in concerts. He always borrowed famous violins from New York instrument dealers. These dealers liked to have their antique instruments played now and then to keep the resonance properly. But when he played at the New York Town Hall in the fall of 1941, he played Farrar's violin that had been made in the carpenter shop of Goddard College."

Francis made his violin in his spare time between classes. It took Francis three weeks to complete his violin. He only made two violins in his life. One was destroyed in the mail when it was shipped to him while he was in the army.

Francis probably would have chosen a career in violin making, but WW2 interrupted his plans. Plans were being made for Francis to attend a violin making shop. An entry in Francis' diary; January 14, 1941 Mr. Eniti wants me to make violins - says I might be a Stradivarius.

In 1941 he was drafted into the army. He served in North Africa and Italy but always found time to whittle. He served with the 5th Army in Italy.

He whittled a miniature chain out of wood about two feet long using a pocketknife. Each link is independent of the adjoining link. On one end is a wooden hook that swivels inside a square block. His carvings

of the female figures are exquisite. The detail is superb and the surface is as smooth as glass.

Francis carved many items and gave them away as gifts or traded them with other servicemen for something he wanted. He carved a ring for his sister Caroline, with

"Caroline" carved in relief.

From the Rutland Herald: "Ernest Eniti, noted Rumanian-born violinist was inducted into the army in Rutland. He remarked: My great hope today is that by fighting, not with my violin, but with a gun, I may do my small part in bringing a happier, cooperative way of life in the world. Two years ago I hated the war, but I have come to see that the only way to stop this war is to fight, fight harder than the evil forces that are seeking to make the world a place no artist, no one of sensibility, no decent person could want to live in."

Sunday, October 23rd, I will be doing an antiques appraisal at the Masonic Lodge in Chester. Watch for more about that here. Mark your calendars. It'll be an "Antiques Side-show."

Francis chose a chunk of spruce from an ancient church timber, a piece of maple from his father's woodpile and a piece of birds-eye maple from an old bedstead. When Francis finished the violin he got himself a bow and went to his dorm room to try it out.

Francis tuned his violin and started to play "Money Musk." Mr. Eniti heard him and with characteristic old-world artistry he nearly fainted when he heard the tone of the instrument. He grabbed it from Francis' astonished hands, tucked it under his professional chin and played DeBussey's "Girl With Flaxen Hair."

Act 39, new assisted suicide law

Vermont has a new assisted-suicide law, Act 39, that many doctors believe would force them to offer suicide as an option to patients whether they want to or not.

As a result, the Vermont Alliance for Ethical Healthcare and the Christian Medical and Dental Association have filed suit to try to derail the new law.

The suit says some medical professionals want to abide by their oath to "do no harm."

The State Board of Medical Practice and the State Office of Professional Regulation are interpreting the state's assisted suicide law to require healthcare professionals to counsel patients on doctor-assisted death as an option.

The alliance and other groups say the limited protection in the law for physicians who don't want to dispense death-inducing drugs themselves isn't strong enough, because the two state agencies are mandating that patients be counseled in "all options," including the option of assisted-suicide.

It seems like that's a stretch, to force physicians to offer the option of assisted-suicide, even if their medical ethics are to the contrary.

The Vermont Alliance for Ethical Healthcare is asking for an injunction against Act 39 while the suit moves through the courts.

The alliance says the agencies are coercing healthcare professionals into taking about the benefits of a procedure they may not believe has any benefits.

There's also a federal law protecting physicians who don't want to participate in assisted-suicide for conscientious reasons, so does that trump the state law? That's another possibility the courts will have to consider.

We aren't talking about patient requests for assisted-suicide here, but about doctors telling patients their death is an option if they're terminally ill.

That may not be what the legislature intended when it passed Act 39, so it could be time to do some fine-tuning of the law. That's what we'd advocate, anyway.

Op-Ed: How is the stomach flu transmitted?

REGION - You catch the stomach flu when virus-infested feces, vomit, or nasal secretions get into your mouth. Norovirus can be present in saliva.

The stomach flu is highly contagious and is primarily spread through the fecal-oral route. Technically, you need to swallow the virus to get the illness. When a person has viral gastroenteritis, the viruses are present in their feces and vomit. If another person accidentally swallows a few of these viruses, they get sick. Anything that you put into your mouth that has the viruses on it, can make you sick.

Improper Hand Washing

The main reason these viruses spread like wildfire is thought to be improper hand washing. Here are some examples of how the stomach flu can be spread by dirty hands. A person who is ill or contagious and uses the bathroom can leave some viruses on the faucet, flusher, toilet seat, or hand towel to wait for the next person. A restaurant or cafeteria worker who is contagious with a stomach virus, can start an outbreak by chopping lettuce with a microscopic fleck of feces under her fingernail. Diaper changing is another easy way to spread illnesses. Just think about all the things you touch after you change the baby's diaper BEFORE you wash your hands--especially if you have a kicking, twisting 1-year old. You touch the baby's clothes, the box of wipes, maybe a doorknob, a light switch, your sleeves, and the faucet.

A few of the viruses on your sleeve dry and fall onto your sandwich later that day. 48 hours later you are wondering where you went wrong. It is hard to do a perfect hand washing. So, if you or a family member actually has a stomach bug, I would recommend using a hand sanitizer that kills norovirus such as Clorox Hand Sanitizer Spray on your hands after you wash them in the sink. For more hand sanitizer suggestions, read this page. I would also recommend wearing disposable gloves to change a sick child's diaper and clean up.

Viruses are easily spread all over the house.

The last time someone in your house got the stomach flu, you washed your hands till they bled and you still got sick. This is partly because when a person (especially a child) is sick with viral gastroenteritis, the vomit and diarrhea get a whole lot of other places besides hands. Their clothes get covered and perhaps the carpet and toys. When the viruses are all over the place like that, it is hard to prevent other people in the house from catching the illness. It is hard to clean up every microscopic spec of vomit. If the sick person is an adult who makes it to the toilet, you have a good chance of containing the virus. But when it is a child who vomits in the middle of the family room, it is very difficult. Make sure to read the page about cleaning products that kill norovirus including Clorox Hydrogen Peroxide Wipes. In ad-

dition, your clean laundry is NOT sterile. I have done experiments that show that there are still live bacteria in clean laundry even after washing on hot, with chlorine bleach, and 1.5 hours in a hot dryer. I imagine that some viruses would survive that as well. I would wash all sick laundry 2 times AND make sure to wear disposable gloves when transferring the laundry from the washer to the dryer.

Stomach flu viruses can be temporarily AIRBORNE!

Norovirus has also been shown to become temporarily airborne when a person vomits. This is most likely true for the other gastroenteritis viruses as well. In one study, a person vomited in a hotel dining room. People eating at other tables all over the room got sick which could not be explained by direct contact. People at closer tables were more likely to be sick than people whose tables were farther away. When the virus particles settle out of the air, you have a nice light coating of virus all over the room. So, if your child vomits in the middle of the family room carpet, it is very easy for everyone to be exposed. People can breathe in and swallow the temporarily airborne viruses or touch contaminated surfaces and then put their fingers in their mouth. For example, the viruses can land on the TV remote control. When you are flipping channels and eating popcorn, you may eat the virus.

It stands to reason that if virus particles can be aerosolized when a

person vomits, the same phenomenon can occur when a person has explosive diarrhea. I have no scientific evidence to back me up, but I suspect that when you walk into a bathroom that smells horrid from a person having diarrhea, there may also be viruses in the air. Stinky public bathrooms are no longer just a funny joke.

Norovirus can be present in saliva.

The CDC, will tell you that norovirus is only present in vomit and diarrhea. However, norovirus is probably present in saliva in some people. Here is a research article that checked saliva samples from a family of 6 who all had norovirus. They took saliva samples every morning for 18 days and checked them for norovirus using RT-PCR. The results show that all 6 family members had norovirus present in their saliva for 9-13 days after the vomiting STOPPED from norovirus! 2 of the family members who never had vomiting (only diarrhea) still had norovirus present in their saliva for 10 and 13 days!! That is really, really upsetting. Hopefully, more research will be done so we can be certain of how scared we need to be. Rotavirus has also been shown to be present in nasal secretions 2,3,4. Therefore, people coughing and spitting when they talk can contribute to the spread of norovirus and rotavirus.

Friday morning the Windham Foundation of Grafton, Vermont, published a letter in the local town newspaper affirming its opposition to the proposed Grafton/Windham industrial wind project. For the past four years, our community group has been dedicated to educating ourselves and our neighbors about the impact of the project on our town and the region. Thus, we at Grafton Woodlands Group are gratified that the Windham Foundation has concluded that the project "is

not in Grafton's best interest, and we do not believe it should be built."

In its letter to the Grafton News, the Foundation notes, "If the wind project is built and the impact of construction and operation is adverse to the beauty and experience of Grafton as we know it, there will be no way to turn back. In our judgment, the risk to Grafton and all we seek to preserve is too great."

The letter points out, "As the town's largest taxpayer, the Foundation itself would be a major beneficiary (of the

developer's proposed payment to the Town). Some taxpayers would benefit. However, due to the way the State property tax relief program works, those who might benefit from a reduction in the municipal portion of their real estate taxes could find those savings offset by a loss in the property tax adjustment that is based on income, if they are eligible for that program. The result could be little or no net gain. Homeowners should assess their individual situation."

Grafton Woodlands Group appreciates that, in opposing the industrial wind project, the Windham Foundation has upheld its mission to "preserve and promote the vitality of Grafton and Vermont's rural communities." This echoes our mission, which is to protect Grafton's heritage.

Fiddle jam coming to Bellows Falls

BELLOWS FALLS, Vt. - The Northeast Fiddlers Association is planning a foray into southern Vermont to hold a "fiddle meet" Sunday, Oct. 16 at the Moose Club in Bellows Falls beginning at 12 p.m.

NEFA is a group of fiddlers, other musicians and folks who come to their meets to dance, socialize and enjoy the music. For more than 50 years, NEFA has held a monthly "fiddle meet" on the first Sunday of every month (the second Sunday if it's a holiday weekend) at an Ameri-

can Legion or VFW hall in one of several northern Vermont towns.

The group is scheduling a meet in another part of the state to increase awareness and membership. Membership is not required to attend and participate in the meets, but the dues are much appreciated.

All fiddle meets begin with a jam that lasts an hour. Fiddlers or other instrumentalists sign up on a numbered list on arrival and then either join the jamming session, get something to eat at the concession booth

or just socialize with old and new friends. At 1 p.m., the moderator takes the list and starts calling fiddlers up to the stage to each play three tunes. When a fiddler's name is called, he may play solo or invite as many people as he wants to join him. There is always a piano and/or guitar player available to back up folks who do not already have a back-up person.

A highlight of the NEFA meets is the number of people who come to just listen, dance, and enjoy the music. Another is that people who do not usually play with others or in front of others have a chance to do so. It is also an opportunity to meet new fiddlers, hear different styles of playing, learn new tunes and enjoy a very sociable Sunday afternoon.

People who have been members of the NEFA for at least 10 years become Lifetime Members upon their 80 birthday and no longer have to pay dues. Currently, more than 25 per cent of members are Lifetime Members.

THIS AND THAT

The Bellows Falls Terriers Field Hockey team is off to another great start. The defending Vermont Division III champions, who play a Division I-II schedule during the regular season, has turned back all challengers, halfway through the season. The latest win was a pulsating 1-0 overtime triumph over new rival Hartford. This is the second overtime win for the Purple and White and the second time in an extra session that Madison Streeter found a way to score the winning goal.

These two teams have had their days as rivals over the years. Once upon a time, when Jayne Barber and Heather Scudder were at the helms of the respective teams; they both competed at the top of Division II. Now Bethany Coursen has built a new era of contention in the Falls and the two have renewed the importance of the series, but not because they are in the same division, BUT, more likely because former Terrier athlete and coach, Heath Haskell, coaches Hartford and that brings about a natural scale of heightened excitement, which can reach its height when both teams take the contest to overtime. The two teams meet again in the season finale in Hartford on Friday, October 21. Expect more of the high drama then.

When one looks at all of the numbers which add up to the 9-0 BF start, Coursen's team has tallied 33 goals to the opponents 4. This clearly shows that the team certainly isn't a one-dimensional unit. The Terriers have its' share of one sided victories, 5-0 at Brattleboro and at Burr + Burton, 4-0 Brattleboro and Rutland at home and 8-2 home versus Mount Anthony, BUT, there are enough strong teams on the schedule to test this well balanced Purple and White eleven.

The Hartford game mentioned above saw both teams have their moments, both in regulation and overtime and the encounter also saw both goalies make spectacular saves when necessary. Coursen said the common denominator of both overtime successes was "having Macie (Madison Streeter) be in position to score and seeing Brigid (Hodsden) phenomenally running out and making amazing saves." The other overtime win came at tough Otter Valley 3-2 and BF was also challenged by a good Woodstock team 2-0 and an up and coming Springfield team 1-0 with both those games on the road.

One of the biggest reasons for the team's success has been a system change Coursen implemented during last season. "We ran a 4-2-3-1 and we switched to a 4-3-3 playing four forwards, three links and three halfbacks. It was not well received by players or parents at first, BUT, a state title run made it quite convincing," she noted. INDEED!

Hodsden and Emma Lober split the goal time and they are both becoming polished sophomores. Seniors Murphy Hicks and Aly Bashaw team with junior Paxton Santorelli to form a defensive halfway trio that might not have an equal in any unit they have played. Junior Faith Byfield backs up the half-backs and is settling in, as she gains experience backing up that unit. Senior Dakota Carter is the final halfback on the varsity roster.

Streeter, a sophomore, is the type of link who seems to best personify the flexibility needed to connect the rest of the team to the link position. Senior Fallon Vancor stabilizes the position, as Coursen gives her credit for communicating with her younger position mates well. Two more sophomores round out the position as Michelle Marchica and Alice Salter-Roy please Coursen with their alternating play.



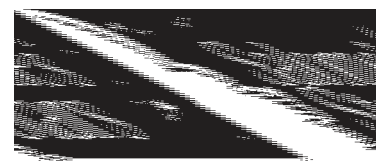

Vermont foliage report

MONTPELIER, Vt. - After prolonged warmer conditions during much of September, the first frosts have settled in the cold hollows throughout Vermont, triggering the next phase of increased color vibrancy. Excellent colors are now emerging in the north, at higher elevations along the spine of the Green Mountains, and throughout the state in isolated pockets, especially those associated with wetlands. Statewide, foresters estimate conditions are at 30-40 percent of full peak color. With forecasts for cooler air and showers continuing in much of the state this week, we are already

seeing an increase in both the proportion of leaves changing colors and the intensity and brightness of those colors. We expect all parts of Vermont to be moving through early color and into mid-season conditions by the weekend, and the state remains on track and well-primed for great color into the early weeks of October. Suggested Vermont driving routes (north to south):
 - Route 5A, from West Charleston through Westmore to West Burke.
 - Route 16 from Barton to Westmore.
 - Route 111 or 105 through Island Pond.

- Route 5 south from Barton to Orleans, then Route 58 to Irasburg.
 - From Lowell, Route 100 south to Route 118 in Eden, then north to Montgomery.
 - Route 242 from Montgomery to Jay.

Fall is prime time for Vt. fishing

RUTLAND, Vt. - As water temperatures cool across Vermont, the fishing action is heating up and the Vermont Fish & Wildlife Department has assembled a list of some of the top fall fishing opportunities in all corners of the state to help anglers get started toward a successful fishing trip. "With the onset of fall and cooling water temperatures, various fish species begin to feed heavily in advance of winter, resulting in some of the best fishing of the year throughout Vermont," said Eric Palmer, director of fisheries with Vermont Fish & Wildlife. "We hope anglers of all interests and abilities will get out on the water this fall to enjoy a gorgeous time of year in the outdoors and experience Vermont fishing at its best." From cold water species like trout and salmon, to warm water species such as largemouth and smallmouth bass, northern pike, yellow perch and walleye,

Vermont's array of fish species become more active during the fall as they feed to boost their energy reserves in order to sustain themselves during the winter. In addition to the rise in fish feeding activity, the fall season also means a decrease in angling pressure, less boat traffic on Vermont's lakes and ponds, and incredible views of Vermont's renowned foliage. "Fall is one of the absolute best times to be on the water in Vermont, regardless of what species you want to target, and you'll likely have your favorite fishing holes all to yourself," said Shawn Good, fisheries biologist with Vermont Fish & Wildlife. 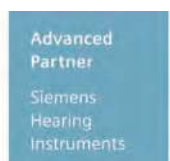

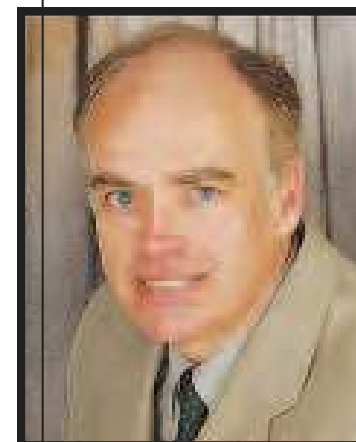
