

WARNING

The legal voters of the Towns of Chester, Andover and Cavendish, being of Green Mountain Union High School District No. 35, are hereby notified and warned to meet at the official polling places in their respective Towns, on Tuesday, March 7, 2017, between the hours of 9:00 o'clock (a.m.) in the Town of Chester; 8:00 o'clock (a.m.) in the Town of Andover; and 10:00 o'clock (a.m.) in the Town of Cavendish, at which time the polls will open, and seven o'clock (7:00) in the afternoon (p.m.), at which time the polls will close, to vote by Australian ballot upon the following Article of business:

ARTICLE I

Shall bonds or notes of Green Mountain Union High School District No. 35 in an amount not to exceed Eight Hundred Eighty-Six Thousand Five Hundred Fifty Dollars (\$886,550), subject to reduction from available state and/or federal construction grants-in-aid and the application of up to One Hundred Seventy-Five Thousand Dollars (\$175,000) reserves, be issued for the purpose of financing the cost of reconstructing and replacing the Green Mountain Union High School roof in the Town of Chester, the estimated cost of such improvements being Eight Hundred Eighty-Six Thousand Five Hundred Fifty Dollars (\$886,550)?

State funds may not be available at the time this project is otherwise eligible to receive state school construction aid. The District is responsible for all costs incurred in connection with any borrowing done in anticipation of the receipt of school construction aid.

Upon closing of the polls, the ballot boxes will be sealed, re-opened at the polling place in the Town of Chester, the ballots commingled and publicly counted by representatives of the Boards of Civil Authority of the Towns of Chester, Andover and Cavendish under the supervision of the Clerk of the Green Mountain Union High School District No. 35.


