# Ludlow Selectboard replenishes departments with surplus

LUDLOW, Vt. - The Ludlow Selectboard has decided to use a \$300,000 budget surplus to replenish funds pulled from several departments earlier in the budget season and leave the rest in a "rainy day fund," determining how to apply the funds at the end of the fiscal year in July.

In early January, the town of Ludlow discovered an error in their budget calculations leaving them with a \$106,000 shortfall. At that time, they pulled \$70,000 from several departments to make up some of that difference, including \$25,000 from the cemetery budget, \$10,000 from the skate park fund, \$10,000 from the Police budget, \$10,000 from the lister's reappraisal, and eliminating a crushed gravel purchase of \$15,000.

Now, realizing over \$300,000 in unassigned funds, the board agreed to replenish those departments fully and then set aside the remaining balance, possibly to buy down the tax rate which is set in July, something that Board Chairman Bruce Schmidt said he's a proponent of.

The board initially talked about \$443,000 in unassigned funds, but Municipal Manager Scott Murphy said that a portion of those funds were committed in the future, leaving approximately \$300,000 avail-

Rose Goings, Ludlow's director of Planning and Zoning, updated the board on the efforts of the Planning Commission saying that the board had abandoned their efforts to move forward with a shortterm rental registry. According to Goings, Vermont state legislators had started a House bill which encompasses many of their discussions around shortterm rentals including launching a rental registry, issuing certifications of compliance for pest-free status, water and sewer issues, and zoning laws. Goings asked whether the Selectboard had any interest in pursuing the matter, otherwise it would go no further in their committee and they would await any legislation coming out of the Statehouse.

The Selectboard agreed to leave the issue to be decided at the state level and instead would put efforts into zoning and affordable housing initiatives although it was not something that "happens overnight," according to Schmidt. He suggested they would need a financial partner to secure funding so people would have a reason to switch their rentals to provide long-term affordable housing.

Murphy said that the town had been communicating with the Okemo Valley Regional Chamber of Commerce who were working with several surrounding towns to talk about workforce housing. He had also reached out to Windham and Windsor Housing Trust in those efforts.

Board member Justin Hyjek said that Ski Vermont is looking to receive \$950 million from the next stimulus package and "a lot of that is already going towards affordable housing

developments and grants and subsidies," funding that could be coming down the pike to help in Ludlow's long-term housing efforts.

Murphy informed the board that Ludlow had been awarded nearly \$6,000 in a Better Places Grant, which will build and place decorated picnic tables throughout Ludlow to provide places for people to eat their local takeout. Artists from Fletcher Farms, as well as student artists from the Expeditionary School at Black River, will be designing the tables.

A new potential owner has emerged for the former Fox Run property, still with the intention for use as a treatment and rehab facility. The new possible owner, Divided Sky, submitted an application; but according to Goings, it needs to be updated with a site plan before they can schedule them for a DRB meeting in April.

The board approved the proposed changes to the personnel policy which ensured employees working holidays would receive 1.5 times their regular rate and a replacement day of "straight time." This policy largely impacts highway workers and matches the policy in place in the police contract. Although this had been the standard practice, it had not been formally written into the personnel policy until now.

The next Ludlow Selectboard meeting is Monday, April 5 at 6 p.m. via Zoom. The link is available on the town's website.

# Chester Townscape's Tree and Shrub Sale orders due –

snow? Think spring! Chester Townscape's annual Tree and Shrub Sale helps landowners prepare for the growing season by offering them goodsize, proven trees and shrubs at below regular retail prices so people can beautify their properties while supporting the nonprofit's civic beautification projects. The five specimens offered in 2021 are a Korean Dogwood tree and four shrubs: compact Red Osier Dogwood "Artic Fire," Dwarf "Hum-Sweet Pepperbush mingbird," Azalea "Ribbon Candy," and Doublefile Viburum "Summer Snowflake."

All specimens are hardy and low maintenance, sport colorful blossoms, and offer multi-season interest. Most are native, and all appeal to pollinators or birds. Any one of these plants would make a wonderful present for Mother's or Father's Day, birthdays, anniversaries, housewarming celebrations, or other special events.

Korean Dogwood is a Zone 4, broad, bushy, reliable, deciduous tree that reaches 15-20 feet tall and wide. Multiseason interest features creamy white, long-lasting flowers in May and June, after most other dogwoods have bloomed; edible, bird-attracting, crimsonred, raspberry-like berries in early to mid fall; and dark green leaves that turn orangered to scarlet in fall. This tree prefers part shade to full sun, best with protection from hot afternoon sun. It is not draught or heat tolerant, and it prefers richly organic, loamy, welldrained soil. Shallow roots

CHESTER, Vt. - Tired of welcome mulch or leaf litter. It and is low maintenance. is low maintenance, tolerates deer, and attracts birds, bees, and butterflies.

Red Osier Dogwood is a Zone 3, compact, native, deciduous, twiggy shrub that grows 3-5 feet high and 3-4 feet wide, with intense bright red stems for outstanding winter interest - and tiny white flowers in spring. It tolerates good range of soil and light conditions. The stems are reddest with more sun, but it is one of the most shade-tolerant

Dwarf Sweet Pepperbush is a Zone 3, compact, native, deciduous, stoloniferous shrub that grows 2-4 feet high and 3-5 feet wide, with fragrant, creamy-white blossoms in mid-late summer. It tolerates good range of soil and light conditions. Full sun to shade, but flowers best in sun or part shade. It is low maintenance and attracts bees and butter-

Ribbon Candy Azalea is a Zone 4, dense, deciduous, native, suckering shrub that grows 5-7 feet high and 6-8 feet wide, with horizontal-branching stems. Star-shaped, sweetly fragrant, pink flowers with white stripes bloom mid to late June with multiple buds at the branch ends. Thick, blue-green foliage turns red and orange in fall. It grows in part sun or part shade, but benefits from half day of sun for best blooms and form. It prefers moist or wet, well drained soil and is an excellent choice for wetter or shadier areas or naturalizing in semi-shaded woodland areas. Suggested mass planting for greatest effect. It attracts bees, butterflies, and hummingbirds

Doublefile Viburnum is a Zone 5, dense, deciduous, native shrub that grows 6-8 feet high and 8-10 feet wide, with beautiful, horizontalbranching form and threeseason interest. Showy, white, lacecap-like flowers late spring into summer attract butterflies. Toothed, deeply veined, dark green leaves turn red to purplered in fall. Ornamental red berries turn black and are favored by birds. It prefers full sun to part shade and loamy soil, but can do well in any medium-moisture, well drained, slightly acidic soil. It tolerates drought as it matures, but keep it watered until established. It is low maintenance and its beautiful form accents a stone wall, fence, or foundation.

Buyers do not have to be Chester residents, but they do have to preorder and pay before March 29 with a check to tax-exempt Chester Community Alliance. They must pick up the plants, likely in the first week of May, from Sunshine Acres Nursery on Route 11 in Chester.



# Gravity feed

What prompts me to write about gravity feed water was this sentence in my article last week, "Running into the shed she sat down in the tub, which was used to catch the running water..."

I realize some might not know what was meant by "running water." In the days before electricity, we did have running water in many homes. A spring or well was located at a higher elevation than the house. A waterline was dug from the source to the home. Waterlines were not buried as deep as today, in some cases a foot or less deep, and would freeze if the water wasn't kept running 24 hours a day, hence "running water."

I remember seeing running water for the first time in George Farrar's kitchen sink on Farrar Road in Potash. The water ran year-round. Overflow was discharged through a drainpipe and returned to the earth. I was probably 12 at the time. It fascinated me.

The house I grew up in on High Street had a different solution. Our house was a full two stories with a large attic above that we called the third floor. In the attic was a cistern. It's been years since I've seen it, but I remember it maybe three or four feet high and maybe measured something like six feet by four feet. By the time I came along, we had town water.

There was a zinc lining inside the cistern to prevent leaks. A one-inch diameter pipe at the top of the cistern delivered the water. There was a float similar to the float in your toilet tank. When the water level in the cistern dropped to a certain level, water flowed into the cistern. When the float rose to the proper level, the water to the cistern would shut off.

Our water came from a well water pipe was lead. High water pressure was needed to force the water from the basement to the attic. Water gains pressure as it is forced downhill through a pipe. When our house was built, it was a two-family home, so a lot of water was required.

I remember we had oak toilet tanks mounted on the wall over the toilets. Again, gravity feed. When you pulled the chain, the overhead oak tank was emptied. The water ran down a pipe and flushed the toilet as today.

With the cistern in the attic, anyone who turned on a faucet or flushed a toilet on either the first or second floor, water was sent to that room from the cis-

A collector of railroad antiques that I knew had a porcelain sign that read, "Don't pull the chain at the station."

#### **Problems**

There were problems with gravity feed water. If the waterline took on any air, you lost water and the line would have to be primed. An obstruction would create a similar situation. Gravity feed water could be a headache especially in the winter.

I used to own the brick house south of Chester on Route 103 the house that sits close to the road. It was about 1,200 feet from the well to the house. The lead water pipe I replaced with plastic pipe. Along the road, near Arnold Stoddard's sugarhouse, it was swampy and very wet. My well was up on the hill behind the sugar-

Here I didn't need to bury the waterline very deep. I dug down about a foot and laid the plastic pipe. This swampy up on the hill behind us. The section didn't freeze very deep in the winter.

Gravity feed over such a long distance caused numerous problems. Every winter I could plan on losing water for a time.

I wanted to explain her sitting in the tub of running water so readers would see a larger picture with that story. The more we understand days gone by, the better we are. Today there are still people using gravity feed water.

# University of Maine announces fall 2020 Dean's List





Dear Editor,

I winced to read that Springfield is sprinting to the front of the line for the testing of autonomous vehicles in Vermont. The Governor's Highway Safety Association website comes straight out of the gate, as all proponents of AVs seem to, with a barrage of vague bullet points touting their possible benefits. As it turns out, AVs may offer several benefits to society, such as safe drunk driving. I think the real impetus, though, is found in the GHSA's plea to Vermonters: "Let's not fall behind."

I think we ought to fall behind. The Harvard Business Review predicts that half a million truck driving jobs will be lost nationally in the coming decade to automated semi trucks, and I'm sure trains and ships will also be fully automated by then. Eventually, following the logic of AV proponents, OTCs could be made illegal. Then speed limits could be safely raised, and traffic lights eliminated. If you're a chicken trying to cross the road, you'll be wise to download Google Crossroads, which will be an innovative technology leveraging the power of AI to safely channel pedestrian intent. "Google Crossroads - Your Need, Our

# Vaccination expands to ages 65 and older -MONTPELIER, Vt. - As of the same account to make their

March 1, Vermonters age 65 and older are able to make their appointment to receive the Covid-19 vaccine. Health officials less than two weeks after scheduling was opened to people age 70 to 74 – reflects both the great progress of the state's Phase 3 vaccination program and the interest of Vermonters in getting vaccinated.

Vermonters 65 years old and above can make an appointment online at www.healthvermont.gov/MyVaccine. Anyone who has previously been eligible to receive a vaccine continues to be eligible and can make their appointments now. Anyone who is unable to

make their appointment online, needs help, or who wants to speak with someone in a language other than English can call 855-722-7878. The call center is open Monday to Friday, from 8:15 a.m.-5:30 p.m., and Saturday and Sunday, from 10 a.m.-3 p.m.

New users will first be asked to create an account, and then they can select a place, date, and time to get vaccinated. People who already have an account because they were tested through a Health Department site will use vaccination appointment.

Vaccination sites are available around the state, and people can choose a nearby location when said this expansion - coming making their appointment. In addition to the Health Department clinics, Kinney Drugs and Walgreens have joined the effort as participating pharmacies.

People will get either the Moderna or Pfizer-BioNTech vaccine. Most people will be asked to wait for 15 minutes after receiving the vaccine to watch for adverse reactions. Information about side effects and how to report any adverse reac-

tions will be provided. Appointments to receive a second dose will be made at the time of their vaccination. Getting fully vaccinated provides the best protection against the

Getting tested for Covid-19 is important, it's easy, we offer it at numerous locations across the state, and it's free. The Health Department will provide more information about registration for the next eligible groups when it is available.





## A reminder to remove ice shanties

MONTPELIER, Vt. Vermont state law requires that ice fishing shanties be removed from the ice before the ice weakens, according the Vermont Fish & Wildlife Department.

The shanty must be removed before the ice becomes unsafe or loses its ability to support the shanty out of the water, or before the last Sunday, March 28, whichever comes first. All contents, debris, wood, and supports must also be removed so they do not become a hazard to navigation in the spring.

The fine for leaving your ice fishing shanty on the ice can be \$1,000, and shanties may not be left at state fishing access areas.
