

## Laura Cody McNaughton Memorial Fund Scholarship Award

SPRINGFIELD, Vt. - The Laura Cody McNaughton Memorial Fund is proud to announce its first annual Public Health and Community Service Scholarship award to Angelae Wunderle of Bellows Falls, now studying at Drew University. The 2020 scholarship is for \$8,000.

Elected to the National Honor Society in her sophomore year, Angelae graduated from Green Mountain High School with a 4.2 GPA. She has been an avid volunteer peer tutor since seventh grade and has participated in drama and a variety of other extracurricular activities. She won the DAR Good Citizen Award and developed her leadership skills at the VSAC Leadership SEEDs Training program and the Hugh O'Brien Youth Leadership Program. Eight students applied the scholarship this year, based on the recommendations of their guidance counselors. All were outstanding in their own ways, but one other student impressed the selection committee so much that they voted to make a special \$2,000 award. This went to Ashley Chamberlin of North Springfield. She also has demonstrated strong leadership abilities, is a musician, an athlete, and an excellent student, all the while working after school. She has begun a nursing program at the University of Southern Maine in Portland.

CLAREMONT, N.H. TwinState MakerSpaces Inc., the nonprofit organization that operates the Claremont MakerSpace, in Claremont, N.H., is pleased to announce James St. Martin and Bryan Phaneuf as their March and April Artists in Residence. James and Bryan operate Doghouse Arcades, a small Claremont-based business specializing in home arcade and virtual pinball cabinetry and machines.

"James and Bryan bring a fun and entertaining project to the Claremont Maker-Space through their home arcade business. As many of us have been spending so much more time at home over the past year, we can attest to the need for new ways to keep occupied. What better way than having your very own pinball or arcade set up?" said Brendan Dangelo, director of Education at the Claremont MakerSpace. "The Artist in Residence program provides an opportunity to showcase the versatility of the Claremont MakerSpace and the creativity of our local community

of makers. James and Bryan will utilize many of our high tech tools to expand into a new line – a collapsible and modular skeeball system."

James St. Martin officially started Doghouse Arcades in November 2020, but the idea has long been his dream. The business, named in honor of his father who passed away from cancer, is a nod to a tendency to take on "wild projects" and end up "in the doghouse." His father's love for pinball is another way in which St. Martin makes and creates in his memory.

"CMS provides a large space to really spread out for our projects as needed with a variety of accessible tools right at our fingertips. The Artist in Residency will be a great way for us to produce an open source and free to the community product that we would have otherwise not been able to make," said St. Martin. Once completed, the project will be on display at the Claremont MakerSpace and will be available to be viewed by the public by appointment.

The Claremont MakerSpace Artist In Residence Program is designed to empower New Hampshire and Vermont-based

artists with tools, training, and space to create compelling new work. Each CMS Artist In Residence receives \$800 towards the creation of new work at the CMS, two months of Unlimited CMS Membership, a dedicated studio space at the CMS, and training to use new tools. Each residency runs for two months. Applications for the next residency must be submitted by April 15, 2021. Artists and makers in all mediums are welcome to apply.

TwinState MakerSpaces, Inc. and the CMS Artist In Residence Program are supported in part by the New Hampshire State Council on the Arts and the National Endowment for the Arts.



### Mr. Majestic

Kim Kendall is a classmate and friend of mine. This past January I paid him a visit. When I walked in, Kim said, "The eagles are out there to-

I got up to look. Sure enough there was a bald eagle in his field.

Two Vermont game wardens, Asa Sargent and Kyle Isherwood, bring Kim roadkill deer. They drag them out in Kim's field, maybe 200 feet from the house. Don't get excited; these are deer too mangled for human consumption. There are benefits in disposing the carcasses this way.

A deer lying off the side of the road will attract all species of animals that feed off the carcass - coyotes, foxes, crows and ravens, raccoons, and bald eagles. Here they can be hit by a car. By moving the carcass away from the road into the field, any threats from humans are eliminated. We can live our lives and the critters can live theirs.

Several times this winter when I've been at Kim's, I've tried to get photos of the eagles. These eagles have excellent eyesight. Even if I carefully sneak up to the kitchen window, the eagles would see me and fly away.

Scott Kendall, Kim's nephew, set up his game camera nearby. Scott got some great photos, which he emailed to me. The photo with this article is one of them. These are beautiful photos. Scott's game camera is much better than mine.

I don't remember Vermont having bald eagles in residence when I was a kid. It was in the 1980s, as I recall, when this majestic bird was reintroduced, at least in our first eagle on Route 5, north of the toll bridge in Springfield. In years since, their numbers have increased.

You'll notice their heads and tails are not pure white. The head is white but has mottled brown feathers inter-

mixed. It takes up to five years for an eagle to reach maturity, at which time their head and tail turn pure white. The eagles feeding at Kim's are mostly immature birds – although he has seen a couple adults. One day Kim had five eagles present.

The female eagle is larger than her male counterpart with a wingspan of six to seven feet. They are said to mate for life. The female will weigh about 12 pounds and the male about nine pounds. It is not uncommon for an eagle to live 20 years

Along with the eagles, crows and ravens are regular diners. At night coyotes and foxes come in to feed. They drag off large bones to dine in privacy.

Kim and I often talk about the natural world and life's cycle. Kim told me that a deer carcass will completely disappear in a week or so - bones and all. So far this winter the game wardens have brought in three deer

#### The cycle

When the birds and animals have eaten their fill, they return to the woods where they download in the woods. This benarea. I remember seeing my efits plants and trees providing a natural fertilizer Bones too large to be eaten are scattered throughout the woods. These bones are eaten by insects. Nothing is wasted. Hard to be any greener or more natural, I say.

farmers and an old hippie. Sometimes I ask Kim a question why this or that works. Kim will shrug his shoulders and say in his Vermont drawl, "Weeell, I don't know, but it does." He doesn't need to know why it works. What he knows has been passed down from one generation to

I was at Kim's this past weekend. I looked out the kitchen window. Nothing was left of the carcasses, but I noticed a new bluebird house on a post. Kim told me a bluebird won't move into a dirty house so you have to clean out the old nest every year, and that can be prob-

Mark Dutton made the new birdhouse. Mark made it to easily open with hinges for cleaning. Kim says the bluebirds are back. Kim has also seen a phoebe. They like to build mud nests in his barn. Nature is welcome as long as they follow Kim's rules.

## Federal income tax return deadline postponed to May 17

**REGION** - Due to the unusual conditions related to the coronavirus pandemic, the IRS has postponed the due date for individuals to file 2020 federal income tax returns and make tax payments from Thursday, April 15 to Monday, May 17, 2021. Taxpayers will incur no interest, penalties, or additions to tax during this approximately one month relief period for any return or payment postponed under this relief provi-

The relief applies automatically to all taxpayers and no additional forms need to be filed to qualify for the relief. The new deadline applies to federal income tax payments for taxable year 2020, including payments of tax on self-employment income. It does not apply to estimated tax payments for 2021 that are due on April 15, 2021. There is no limit on the amount of tax that can be deferred.

Note that under this relief provision, no extension is provided for the payment or deposit of any other type of federal tax, or for the filing of any federal information return. The IRS urges taxpayers to check with their state tax agencies regarding state tax filing and payment deadlines.

#### Need more time?

If you're not able to file your federal income tax return by the May due date, you can file for an extension by the May due date using IRS Form 4868, Application for Automatic Extension of Time to File U.S.

Individual Income Tax Return. Filing this extension gives you an additional five months, until Oct. 15, 2021, to file your federal income tax return. You can also file for an automatic fivemonth extension electronically - details on how to do so can be found in the Form 4868 instructions. There may be penalties for failing to file or for filing late.

Filing for an extension using Form 4868 does not provide any additional time to pay your tax. When you file for an extension, you have to estimate the amount of tax you will owe and pay this amount by the May filing due date. If you don't pay the amount you've estimated, you may owe interest and penalties. In fact, if the IRS believes that your estimate was not reasonable, it may void your ex-

Tax refunds

The IRS encourages taxpay-

ers seeking a tax refund to file their tax return as soon as possible, and to file electronically with direct deposit. The IRS issues most tax refunds within 21 days of the IRS receiving a tax return. However, the IRS has experienced delays in processing paper tax returns due to limited staffing during the coronavirus pandemic.

#### IRA contributions

Contributions to an individual retirement account (IRA) for 2020 can be made up to the due date, without regard to extensions, for filing the 2020 federal income tax return. The postponement of the 2020 tax filing due date by the IRS also generally extends the time to make IRA contributions for 2020 to May 17, 2021.



it on brook trout in rivers and streams. We generally support the proposal to lower the daily limit on brook trout in rivers and streams, though the coalition raises two concerns.

First, NFC believes that a daily brook trout limit of six fish, consistent with the current sixfish limit for nonnative brown and rainbow trout, would be prudent. This has been VT NFC's consistent position over time; it supports conservation, is simple for anglers to understand, easily enforced, and easy to implement. And it comports with the department's goal of rule simplification.

Compared with other states, Vermont's current limit of 12 brook trout a day in rivers and streams is more than double that of the 15 of 22 states in the brook trout native range, and twice that of three others. The two highest states - Georgia and Massachusetts – have an eight fish limit, which is still 33% lower than Vermont. A better look at how Vermont compares to other states may be seen at www.nativefishcoalition.org/ campaigns/2020/11/21/vermont-going-from-twelve-fishto-eight-is-not-enough.





tive steps involve the establishment of credit freezes with the major credit bureaus, obtaining and reviewing credit reports, and examining bank, investment, credit card, and medical expense documents for accuracy. The Federal Trade Commission recently announced the extension of unlimited free access to personal credit reports until April 2022. Go to www.annualcreditreport.com.

Remember the adage: "If it's too good to be true..." Use common sense and good judgement when dealing with anyone demanding an immediate commitment on the phone or online.

If you are a victim of a scam or a scam target, report it to state or federal agencies. Identity theft and scams are threats to everyone regardless of age, gender, education, or ethnicity. Scammers are truly equal opportunity criminals.

#### Current Covid-related scams

Scammers do not live in a vacuum. They are aware of stressful times and events in order to use them to their advantage. Most

Americans are likely aware of the recent legislation involving stimulus payments of up to \$1,400 per person, but most people do not know the details related to the payment. Con artists are taking advantage of this by impersonating government officials in calls, texts, and emails from a variety of agencies. They threaten loss of benefits, unpaid tax due, or simply want verification of personal information. Government agencies do not issue these alerts nor do they require personal information requested in an auto-

mated telephone call, or robocall. A new series of Medicare scams eveloped calls on Medicare re cipients to provide identification numbers, including Social Security numbers to the caller, or risk losing Covid-19 benefits. Again, government agencies do not use "cold call" or robocall techniques

Another recent adaptation to scams is the use of random, unsolicited telephone calls or text messages promoting financial assistance. Such calls may inform you that your automobile warranty is about to expire or that you are eligible for credit relief or consolidation. These offers carry messages that may be welcomed by those having financial difficulties due to Covid-19. Most frequently, these robocalls ask the recipient to "press 1 to speak to an agent."

Don't risk falling victim. These calls are illegal and the best action is to simply hang up. Any other behavior may be taken as your interest in random attempts to take money and personal information.

Another new tactic promotes opportunities to make money with investment opportunities. The offers promise guaranteed returns and no risk to investors. Such "opportunities" are illegal, prohibited by state and federal law. When solicited this way, your best approach is to immediately contact the Federal Securities and Exchange Commission or your state financial regulations depart-

The world of scams and fraud exists in a constantly changing environment. Take time to educate yourself; it is your best de-





### Vermont trout season to open

MONTPELIER, Vt. -Vermont's traditional trout fishing season opens Saturday, April 10, and despite lingering snow cover, the Vermont Fish & Wildlife Department says anglers can still have fun and be successful early in the season while following Covid-19 safety precautions.

"Just like any other time of year, anglers fishing early in the spring should adjust their tactics based on conditions," said State Fisheries Biologist Shawn Good. "Trout will become more active with warmer water temperatures, and despite an

early spring, most streams and rivers are still quite cold. But if you can find a good location and present your bait or lure without spooking the trout, you can enjoy getting outside and you have a good chance of catching a few fish." "Finding a small to me-

dium low-elevation river or stream that is not too murky from spring runoff can be key. Trout are coldblooded and may be slow to bite especially with low water temperatures, so it's important that they can also see your bait, lure, or

Larger baits can often be more effective for enticing early-season trout into biting. Spin-anglers should try nightcrawlers, egg imitations, or bright colored spoons and spinners. Fly anglers may find success in the early season by drifting large, more visible flies such as wooly buggers, streamers, or San Juan worms along the bottom in slower pools and runs.

Trout will often hold close to the bottom in the deeper areas of streams during high flow conditions to conserve energy. Choose locations and tactics that allow you to fish using a slow retrieval right along the bottom. Focus on deep holes behind current breaks created by big boulders, downed trees or logjams where trout may be resting. Approach the hole from downstream as trout will often orient themselves facing the current.

While Vermont offers excellent and diverse fishing opportunities for wild trout, stocking also occurs in many streams and rivers where wild trout populations are low or absent. This generally happens between May and June each year following spring runoff.

"Early in the season, like on opening weekend, you'll probably have more success if you focus on waters known to hold wild trout," said Good. "Despite unpredictable weather during early spring, each year anglers report catching impressive trout during opening weekend."

Anglers who like to fish and release their catch don't need to wait for opening day. There are year-round catch-and-release fishing opportunities for trout and bass in Vermont. See page 31 of the 2021 Vermont Fishing Guide and Regulations for a list of rivers open to year-round trout fishing. The guide is available from license agents and it is at www.eregulations.com/ vermont/fishing.

The guide is a helpful tool for planning a fishing trip as it includes maps showing rivers and lakes, as well as fishing access areas and public lands for fishing and hunting. It also lists the fish species found in each body of water.

The Fish & Wildlife Department urges anglers to use good judgment to keep everyone safe and reduce the spread of the coronavirus:

• Drive to your fishing spots only with your immediate family members and only if everyone is feeling well.

• When fishing from shore, keep a distance of at least six feet between you and your companions. A good way to measure this is with your fishing pole!

• Don't share fishing gear with others.

• Avoid touching your eyes, nose, and mouth.

• Clean your gear well after using it.

• Wash your hands for at least 20 seconds with soap and water after fishing.


