BF Trustees hear plans for Vilas Bridge

BELLOWS FALLS, Vt. – On Tuesday, Feb. 8, the Bellows Falls Village Trustees heard an update on the Vilas Bridge project from Municipal Manager Scott Pickup.

The Vilas Bridge was closed in 2009 and since then Bellows Falls residents, merchants, and Town and Village board members have requested that the New Hampshire Department of Transportation conduct the necessary engineering studies to rehabilitate the now 92-year-old bridge. New Hampshire owns 93% of the Vilas Bridge and is responsible for that share of the funding.

NHDOT released the ten-year plan for 2023-2032 with the Vilas Bridge project categorized in the State Red List for bridges. The plan from Dec. 27, 2021 is still pending approval but has preliminary engineering scheduled for 2023.

Pickup said the updated plan also included additional federal infrastructure funding, and numbers reflecting a total project cost of \$17 million. He explained the unfunded portion was

about \$460,000 which was the Vermont share for engineering and construction.

Pickup shared a proposed amendment by the Vermont Agency of Transportation to the Statewide Transportation Improvement Plan for an additional \$480,863 added to FY21 for the Walpole – Rockingham Vilas Bridge project.

He said that they worked with state municipal planners to ensure the STIP matched the necessary funding with New Hampshire's.

Pickup said "it's as close as we've come...it appears [to] be a fully funded project." He said that the plan was submitted for legislative approval this month and once approved it just needs the signature of Governor Chris Sununu.

Pickup added, "Hopefully 2023 sees the beginning of a rehab project that will benefit the village and our whole community."

The Vilas Bridge rehabilitation carries economic, safety, and environmental implications. The loss of the crossing has rerouted thousands of visitors daily around the downtown district of Bellows Falls and it continues to raise safety

concerns for mutual aid efforts between Walpole, N.H., and Bellows Falls.

The current crossings include the Arch, or Church Street Bridge, that is often bottlenecked with an "at-grade" rail crossing that handles freight of 100-plus cars, or an underpass with height restrictions connecting Westminster, Vt. to Walpole, N.H.

Environmental concerns of the deterioration of Vilas Bridge and its further rehabilitation delays involve the waste pipe running along the underside of the bridge. Walpole carries an agreement with the Bellows Falls Wastewater Plant and a failed bridge would be catastrophic to the Connecticut River south of Bellows Falls.

The Bellows Falls Village Trustees meet on the second and fourth Tuesdays of the month in the Lower Theatre of the Bellows Falls Opera House at 6 p.m. This year, Town Meeting is an informational meeting only on Monday, Feb. 28, with all articles to be voted by Australian Ballot on Tuesday, March 1.

BF Teacher and Coach, Tim Eno, gets "The Call to the Hall of Fame"

BELLOWS FALLS, Vt. – Lifelong Bellows Falls resident and Bellows Falls Union High School graduate, teacher, and coach, Tim Eno, was recently chosen as an inductee into the Vermont Principals' Association Hall of Fame.

"I received the phone call last week and it caught me totally by surprise," Eno said in a recent interview. "The induction is in Montpelier on May 20."

A graduate of BFUHS in 1976 and Keene State College in 1981, Eno has been a positive fixture in the community and school system for over three decades. "I've been a teacher for 35 years and for the last 18 at the Bellows Falls Middle School," Eno said.

Eno has also been heavily involved in school athletics, having coached the school's track-and-field and cross-country ski teams for nearly 30 years. "I have been the BFUHS head track coach for the last 27 years and this one will be my last. I was also the cross-country coach until 2019, and held that coaching position for 20 years."

Coach Eno's accomplishments are impressive; achieving an astounding 18 combined state championships, many conference and league titles, as well as coaching many individ-

ual state and New England champions. His impact on the community, the student athletes, and his peers is unmistakable.

"I absolutely love coaching track and cross-country, and I have been blessed with numerous intelligent assistant coaches over the years which has helped me achieve those championships... it wasn't just me! I'd like to especially thank 'Grump' Haskell, who has been with me as a volunteer assistant coach for all of my 27 years in coaching."

"I ran cross-country and played basketball for Coach Russ Pickering in high school and he probably had the biggest influence on me as a student athlete. We were D1 state champs in cross-country in 1973, 1974, and 1975. He was a great mentor and I'm not really sure what path my life would have taken without his mentoring along the way."

As the varsity track and

cross-country head coach, Eno has helped hang many championship banners in the BFUHS gym, including nine boys' and six girls' track-and-field state titles, as well as one boys' and back-to-back (2018 and 2019) girls' cross-country titles.

"Bellows Falls is a very unique town and school system where we are blessed with hard-working, dedicated athletes," Eno added. "The support from parents, the school, and the community has just been incredible over the years, and it has been such a pleasure coaching and making all these friendships with the athletes, other coaches, and parents along the way."

"It won't be easy to walk away from all of this, but Coach Bisbee told me once upon a time that 'you'll know when it's time...' and I think it's time. Many thanks to everyone that has helped me a long the way. Go BF!"

Springfield Community Players named Organization of the Year

SPRINGFIELD, Vt. – The Springfield Regional Chamber of Commerce has named the Springfield Community Players as Organization of the Year for 2021.

For over 100 years the organization has presented at least one community theater production a year and averaged four a year. This includes 2020 when the comedy "Check Please" was presented via Zoom due to Covid. In 2021 they presented a two-production live season at their Studio Theater at 165 South St.

The organization's involvement in bettering the Springfield community also played a large part in its receiving the award. In 2021 the Players provided pre-concert live Broadway and similar music, as performed by some of their members, at the weekly August concerts in Comptu Park, provided a venue for this year's Apple Blossom festival's abbreviated event, and helped provide meals to Springfield's First Responders.

Jessica Martin, Director of Springfield on the Move, was one of those who nominated the Players. She appears on a YouTube video produced by the Chamber to announce the winner. She

said she "can count on these folks when Springfield on the Move needs help, even if its 94 degrees outside [and] I need help setting our tent up for our concert in the park." Martin actually performed with the Players herself in the '80s. Taylor Drinker, Membership and Events Director of the Chamber, said they have had an annual Outstanding Organization award in addition to their Outstanding Citizen award since 2014. She says their Board of previous winners considered new nominations this year as well as some brought forward from previous years.

John MacDonald has been President of the Players in recent years including

the 2021 award period. He said, "I was extremely surprised and yet honored that we were recognized not only for the past year but also for our past work in supporting our community over 100 years. Community theater not only provides an alternative style of entertainment it also brings families together."

Donald Gray is one of two current Lifetime Members. He first appeared on their stage in 1974 as a member of the chorus in the musical "Brigadoon." He has since worked in many other roles with them, as well

\$1.4 million in ARPA funds awarded to Rockingham

ROCKINGHAM, Vt. – American Rescue Plan Act funds totaling \$1.4 million are to be awarded to the Town of Rockingham, Village of Bellows Falls and Village of Saxtons River as part of the federal stimulus funding for Covid relief and economic investment.

Eligibility includes Economic Development Projects through public and private funding as well as the original four broad criteria outlining eligible uses of essential worker response, public health emergencies and negative economic impacts, reduction in revenue to government services and necessary investments in water, sewer, or broadband infrastructure.

Camoin Associates of N.Y. has been hired to consult with the project team consisting of Municipal Manager Scott Pickup, Development

Director Gary Fox, Bellows Falls Village President Deborah Wright, Saxtons River Trustee Chair Amy Howlett, Rockingham Select Board Chair Peter Golec and Bellows Falls Downtown Executive Director Betsy Thurston. The team will invite organizations and the public to submit project ideas. Camoin will run the public engagement sessions, organize project information, create reports and make a final presentation at the meeting of all three boards in May of 2022.

ARPA funding may be pooled for regional projects if they are ARPA eligible. This means that Rockingham may allot funding for regional or countywide investments and projects in each Village may get Town supported funding as well.

Rockingham invites the public to engage in this process, however it is not a requirement of the ARPA award to the Town and Vil-

lages. Two public meetings will be held in March and April to discuss prospective ideas from organizations and residents. The team is accepting big or small ideas, at any stage of development, and requests project ideas with long-term impacts.

Every idea submitted can create community support and leverage future grant funding, so please share your project ideas.

Deadline for submission is March 2. Find more information on eligibility criteria on the Vermont League of Cities & Towns www.vlct.org/resources/american-rescue-plan-information and the Town of Rockingham www.bit.ly/3GM56rT.

Print your application to submit on Town Meeting on Feb. 28 and on March 1 at the Masonic Temple at the polls.

Rockingham Library presents indoor seeding

ROCKINGHAM, Vt. – On Thursday, Feb. 24 at 6 p.m., learn the how’s and why’s of starting seeds indoors from gardener Marsha Stern over Zoom. During this workshop, Marsha will demonstrate how to fill containers with soil and how to set the seeds. She’ll show participants how to choose containers, placement, and watering methods. Marsha will also provide information and advice on reading seed packets, other sources of plant-specific information, troubleshooting, and holding and saving seed.

To get ready for this workshop, participants need to look around their

home and collect a bucket or bowl to work with, a large jar of water, a mixing tool, a paring knife or other pointy object, and two containers in which to plant their seeds. Containers can be small clay or plastic pots, or anything at least 2-1/2 inches deep that can be punctured for drainage. Tofu cartons and blue plastic mushroom cartons are an ideal size. Even four to six plastic drinking cups might fill the bill.

Once a person contacts the library to receive a Zoom invitation to this program, a packet with enough soil to fill two pint containers and a choice of lettuce, basil, yarrow, and lobelia seeds will be made available to pick up at the library.

Participants will have the option of planting during the workshop, or later, while away from their computers.

Marsha began starting plants indoors with frugality in mind. She has stayed with it for the undiminished pleasure of seeing green life emerge from a box of dirt at any time of year. Although she has gradually added various assistive devices, she encourages beginners to start with nothing more than a little understanding and some ingenuity. She is the current coordinator of the Bellows Falls Community Garden. been around forever, and people seem not to realize we’re there. It’s finally good we got some recognition.”

The Players were formed in the fall of 1920. “Nothing But the Truth,” was presented at the Town Hall in January of 1921. A tradition of community involvement was started after the 1927 flood when \$100 from the proceeds from “Adam and Eva” was donated to relief efforts in the Town of Cavendish. In 1954 Bob Spindler directed “Of Thee I Sing”, the group’s first musical. This started a tradition of presenting one musical each season. In 1979 the former Southview School was leased from the town, and it is the group’s current Studio Theater and home. In recent years, through grants and major donations, they have made a number of upgrades to the facilities.

Taryn Sidney became the Players new President this year. She has written their press releases and participated in other ways over the past few years. She says they are now putting together a season that will start in the spring. She says she has seen “moments of growth in the past few years,” and that they are now “moving into new experiences.”

Retirement account rollovers

REGION – A rollover is the movement of funds from one retirement savings vehicle to another. One might want to make a rollover for a number of reasons, some of which include an employment situation change, a desire to switch investments, or the receiving of death benefits from a spouse's retirement plan.

There are two possible ways that retirement funds can be rolled over: The indirect rollover, and the direct rollover.

With the indirect, or 60-day, rollover, one might actually receive a distribution from their retirement plan account or IRA. One can make a rollover at any age, but there are specific rules that must be followed. Most importantly, one must generally complete the rollover within 60 days of the date the funds are paid from the distributing plan. If properly completed, rollovers aren't subject to income tax, but if one fails to complete the rollover or misses the 60-day deadline, all or part of the distribution may be taxed and subject to a 10% early distribution penalty.

With the direct, or trustee-to-trustee, rollover, transaction occurs directly between the trustee or custodian of the old retirement plan and the trustee or custodian of the new plan. One

never actually receives the funds or has control over them, so a trustee-to-trustee transfer is not treated as a distribution. Direct rollovers avoid both the danger of missing the 60-day deadline and the 20% withholding problem. A trustee-to-trustee transfer is generally the most efficient way to move retirement funds. Taking a distribution in one's own hands and rolling it over may only make sense if the holder needs to use the funds temporarily and is certain they can roll over the full amount within 60 days.

Anyone who has a vested balance of more than \$5,000 generally can keep their money in an employer's plan until they at least reach the plan's normal retirement age, which is typically 65-years-old. If they terminate employment before then, they can consider a rollover to either an IRA or to a new employer's

plan. An IRA, in contrast to an employer plan where investment options are typically limited to those selected by the employer, is virtually unlimited. The distribution options in an IRA may be more flexible than the options available in the plan of one's employer. On the other hand, employer-sponsored plans may offer better creditor protection. In general, federal law protects IRA assets up to \$1,362,800 plus any amount rolled over from a qualified employer plan or 403(b) plan if bankruptcy is declared. In contrast, assets in a qualified employer plan or 403(b) plan generally receive unlimited protection from creditors, regardless of whether bankruptcy is declared.

Black History Month – What's in a photo?

Tom Hildreth wrote the following history. Whenever I have an aviation question I always go to Tom. If he doesn't know off the top of his head, he will look it up and get back to me.

Because of my interest in WWII history, I was aware of the 'Red Tails.' I thank Tom for bringing this to our attention. It makes me proud to be an American:

Many people have become familiar with the Tuskegee Airman through the movie of the same name that came out in 1995. This National Archives photo depicts three black Air Force fighter pilots, graduates of the Army Air Force flying school at Tuskegee, Ala. There were nearly a thousand pilots trained at Tuskegee, and most of them eventually served with the all-black 332nd Fighter Group, which began combat operations in Italy in February 1944.

The 332nd was quickly involved in combat missions against the Luftwaffe and German ground forces. The group converted from the nearly obsolete P-39 Airacobra to the P-51 Mustang in June 1944. At this point in the war, the dull camouflage of American combat aircraft was being replaced by bright colors that identified the units in the crowded European skies. The 332nd Fighter Group became known as the "Red Tails." The group returned to the U.S. and was made inactive in October 1945.

Activated a second time on July 1, 1947, the 332nd was stationed at Lockbourne Air Force Base, near Columbus, Ohio, a combat unit of the newest American military service branch. On July 26, 1948, President Truman's Executive Order 9981 directed the desegregation of the US military.

The Air Force would be the first of the service

branches to desegregate. In 1949, Air Force leadership decided to conduct a gunnery contest for its fighter units that would test their proficiency.

Three pilots from each of the post-war fighter groups would participate in the meet, which took place at Frenchman Flats near Las Vegas, Nev. between May 2, 1949 and May 12, 1949. The men in this photo represented the 332nd Fighter Group. In fact, they won the competition in the propeller-driven category. Who were they?

Capt. Alva Temple, left, graduated from flight training at Tuskegee in July 1943. Temple flew 120 combat missions during WWII. He earned the Distinguished Flying Cross, which is awarded for "Heroism or extraordinary achievement while participating in aerial flight." Temple was the team leader in 1949. After retiring from the Air Force, Temple opened a Gulf station in Columbus, Ohio. He went on to become prominent in statewide affairs. He passed away in 2004, leaving a legacy of community service.

1Lt. Harry T. Stewart, center. Stewart enlisted in the Army Air Force as an aviation cadet at 17. He graduated from Tuskegee Flight School, and went on to fly the P-40, P-47, and P-51. On April 1, 1945, Stewart shot down two German fighters, and in escaping the fire of a third, caused the enemy pilot to lose control and crash.

He flew 43 combat missions during WWII.

1Lt. James Harvey, right. Drafted in April 1943, Harvey was accepted for flight training and graduated from Tuskegee as a 2Lt. in 1944. Harvey went on to a long career in the Air Force, retiring as a Lt. Colonel in 1965.

1Lt. Holbert L. Alexander, Alternate pilot at the gunnery meet (not seen in this cropped photo). Alexander remained in the Air Force flying fighters until he died in a crash at Chelmsford, Mass. on March 25, 1953.

The 332nd Fighter Group, winner in the propeller-driven category in the 1949 meet, was never properly recognized for their achievement. The following is an excerpt from an article written by Dave Kindy in the Jan. 26, 2022 Philadelphia Enquirer:

"However, their accomplishment would be lost to time – either accidentally or through intentional oversight – for seven decades. While the jet winners, the 4th Fighter Group, were listed in Air Force almanacs, the propeller winners of the first competition were listed as 'unknown.' That omission was corrected this month when a plaque naming the four Black pilots was installed at the U.S. Air Force Weapons School at Nellis Air Force Base in Las Vegas. It acknowledges their accomplishment of earning 'Top Team Honors' at the fighter gunnery meet in 1949."

Summer Food Program seeks organizations to participate

MONTPELIER, Vt. – The Vermont Agency of Education Child Nutrition Programs is seeking sponsors for the Summer Food Service Program. This program, also known as Summer Meals, is federally funded by the United States Department of Agriculture and administered by AOE Child Nutrition Programs. Funds are available and sponsors are needed to provide meals to children at summer food program sites. The AOE is specifically seeking to onboard non-profit organizations to sponsor the Program throughout the upcoming summer.

Vermont school food service programs have worked tirelessly to continue providing meals to children throughout the pandemic. To reduce the burden on schools while maintaining access to nutritious meals, nonprofit organizations are encouraged to apply to

participate in the program to continue providing this service to communities throughout the state over the summer of 2022. Non-profit organizations interested in partnering with schools to operate summer meal sites are also encouraged to participate. Interested organizations should contact Jamie Curley.

This program bridges the gap between school years, giving children ages 18 and under the fuel they need to play and grow throughout the summer months and return to school ready to learn. The AOE enters into an agreement with sponsors to provide meals to children at their sites. Sponsors can be supervisory unions or school districts, private nonprofit organizations, government entities, and nonprofit residential camps. Sponsors are reimbursed on a per meal basis for meals served to children. Sites are

the physical location where meals are served. Examples of sites include schools, parks, housing complexes, and libraries. Sponsors often have more than one site. "Open" sites are where any child, 18 and under, can eat a meal, no questions asked. Closed-enrolled sites serve meals to a set population of children. Open and closed-enrolled sites may serve up to two meals or snacks each day. Campsites may provide three meals or snacks a day and must use individual child data to determine eligibility. Children who are members of households that receive 3SquaresVT or Reach Up benefits or meet the income guidelines are automatically eligible to receive free meals at campsites.



Springfield Selectboard's meeting regarding retail cannabis, I wanted to respond to Kyle Laurita Bonometti's coverage of the meeting in the Feb. 2 article. In the article, Bonometti writes, "Concerns about an uptick in youth marijuana use were also voiced, to which Silberman pointed to statistics showing that there has been virtually no proven link between the presence of local cannabis sellers and an increase in youth use." While this comment was stated in the meeting, myself and other professionals in the field refuted this statement with evidence that was then shared by me with Town Manager Mobus via email. The article presented on Feb. 2 failed to mention the counter statement.

I think it is important that the public is aware that there are multiple documented studies ranging between June 2015 and October 2021 from already legalized states of Washington, Oregon, and California (having had cannabis

retail in place since 2013 onward) that refute Mr. Silberman's claim. These studies show the following:

- Greater retailer availability of cannabis is positively associated with use among adolescents.
- Past 30-day use of cannabis among youth increased in counties of Oregon where retail outlets exist relative to downward 30-day youth cannabis use in counties that did not allow retail cannabis (study: www.ncbi.nlm.nih.gov/pmc/articles/PMC6986306/).
- Greater availability of cannabis and alcohol are positively associated with co-use among adolescents, and with beliefs favorable for cannabis and alcohol (study: www.pubmed.ncbi.nlm.nih.gov/33435786/).

While not specific to youth, a Washington State study from February 2020 finds that as retailers open closer to where people live, more individuals use cannabis more frequently. These effects are concentrated among young adults (age 18-26), for women, and for rural residents. (study: www.pubmed.ncbi.nlm.nih.gov/34712040/).

It is my hope that you will print these facts for people to better understand the public health implications that retail cannabis has on a community.



SPRINGFIELD, Vt. – Ruth Bader Ginsburg, as portrayed by Sheryl Faye in her one-woman show, is coming to the Springfield Town Library on Tuesday, March 8, at 6 p.m.

Ruth Bader Ginsburg was an American lawyer

and jurist who served as an associate justice of the Supreme Court of the United States from 1993 until her death in September 2020. She was the second woman and the first Jewish woman ever appointed to the Court and became the longest-serving Jewish justice.
