Springfield Town Meeting–

SPRINGFIELD, Vt. – On Monday, March 3, town and school district moderator John Brady opened the Springfield Town Meeting by introducing Boy Scout Troop 252, who led the Pledge of Allegiance. The meeting was informational only, giving all those in attendance the opportunity to comment on any of the 29 articles presented.

There was no discussion on Articles 2-3, which proposed nominal compensation for the town moderator and each of the selectboard members. These articles passed the following day.

The town budget, a total sum of \$15,872,049, was proposed in Article 4. Town manager Jeff Mobus reported that health insurance costs were up by 22%, and the cost of services had increased. “You can’t try to balance your budget on the backs of your employees,” Mobus commented. “If you’re not paying market wages...you’re not going to have the employees to do the services.”

Mobus recognized current public works direc-

tor Jeff Strong, who was in attendance, and announced that Strong would be retiring at the end of this calendar year. Mobus thanked Strong for his more than 40 years of service to Springfield, where he has “worn many hats.”

Library director Sue Dowdell had also submitted her resignation to Mobus, after having served the town for six years.

Mobus reviewed a slide presentation that broke out the amount of taxes required in fiscal year 2026, \$12,307,313, an increase of \$657,307, or 5.75%. However, there was an increase of 6.1% in other revenue that reduced the percentage of taxes to be raised to 5.34%.

Mobus stated that the largest percentage of the town budget, 27%, goes toward public works, which covers the cost to maintain the town’s infrastructure. He noted that this year’s budget reflects a more realistically balanced distribution of expenditures due to town finance director Cathy Sohngen reallocating health insurance costs of about \$1.2 million to align with appropriate personnel within each department’s budget, rather than presenting it in one lump sum.

Mobus reported on

\$70,000 in additional funding this year for economic development costs, approved by the board last year. “The way you reduce the tax rate,” Mobus explained, “is to grow the Grand List. So, the board is working very hard on economic development to attract new businesses and new residents.”

Upon Mobus’ recommendation, the selectboard applied \$300,000 of fiscal year 2023 surplus funds to the amount to be raised by taxes in fiscal year 2026. That will bring the amount of the tax increase down to \$357,307, a reduction of 3.15%. Springfield voters approved the budget by Australian ballot the next day.

Article 5 appropriated \$1 million for repaving, road construction, gravel road improvements, and ancillary services, as specified in the Road Surface Management System (RSMS) report prepared in 2022 as a 15-year improvement plan. This amount will be added to the current highway budget of \$325,000.

Article 6 proposed a 1% local options tax applied to meals and rooms, in addition to the state’s 9% meals and rooms tax. The

additional funds are intended to reduce property tax rates. This article was also approved the following day. Aimee Parnell, executive director of SAPA TV in Springfield, was present to address the meeting with regards to their request of \$10,000 in Article 7. SAPA TV has provided Springfield with video coverage and archiving services for the selectboard and school board for more than 25 years, Parnell reported. Fiscal year 2026 will be the first year SAPA TV is asking for compensation from the towns

they cover to offset decreasing cable television subscribers, which in the past has contributed more than 80% of the public access network's annual income. The article passed. Articles 9-13, pertaining to the school board, school budget, and taxes, were reviewed, and some questions were brought up regarding declining enrollment numbers versus increasing costs. "Something doesn't add up," commented one Springfield resident. The school district budget of \$40,742,326 for the ensuing fiscal year is an expenditure of \$13,918 per student, a 3.98% increase from the current budget.

Springfield resident and school budget committee member Rey Rigney addressed the meeting with regards to the "transition plan that was so arbitrarily and deceitfully pushed through without a care for what any of the parents in Springfield might have wanted." Rigney was referring to the proposal to move fifth graders to the middle school. Rigney remarked that the plan was approved hastily and behind the backs of parents, with none of the transparency promised. He concluded by stating that he no longer supported the budget, and no longer trusted the school board. There was some discussion on meeting the needs of special education students, and selectboard member Michael Martin addressed the meeting speaking as a Springfield citizen who had worked on the school budget that eventually passed last year. "Nationwide, special needs students represent about 13% of enrollment," Martin stated. "In Vermont, [that number] is about 17%. In Springfield, it is closer to 28%."

About one-third of the proposed school budget covers special needs students. Springfield voters disapproved the budget at the following day's vote, one of only nine school districts statewide to do so. Articles 14-29 proposed the appropriation of funds to various social services, such as SEVCA, Senior Solutions, Valley Health Connections, Turning Point Recovery, the Springfield Art and Historical Society, and the Springfield Community Band. All articles passed the following day.

with white cheese cloth and Hydrangeas which grew on their land."

Check out the detail in the decoration. The hydrangeas are a wonderful complement. The car is completely covered, so identifying it might be impossible.

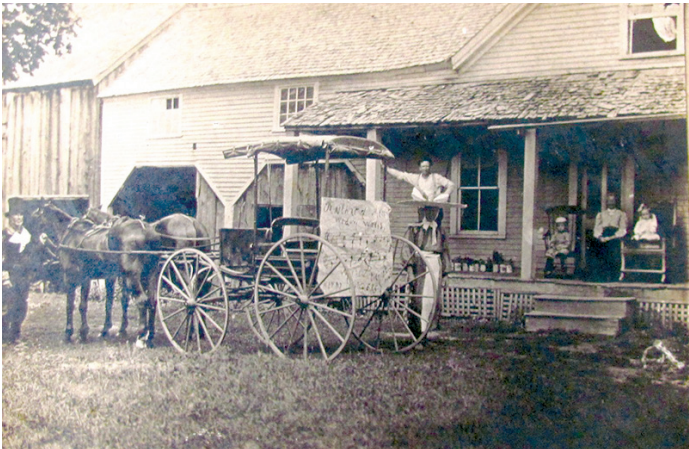
Notice the boy in his pedal car sitting on the hood. His car is decorated too. I love his smile. The driver is dressed rather smartly with a cap. His wife sits next to him. Behind her is a young girl with a white hat. Behind her are two well-dressed women. The one closest is holding a baby.

The man on the porch with white shirt is Louis Marshall. Louis was a stee-

plejack, and had been a cowboy in one of the Wild

West shows. In front of him, at ground level, is a woman wearing a hat with a 3-foot diameter brim. A man wearing a top hat holds the horse's bridle. A woman and two young children sit on the porch.

I think this may be the Albert Marshall place. If you take the road from Upper Bartonsville to Cambridgeport, you will pass Marshall Road on the right. 65 years ago, I went with my mother and Florence Pierce out to Marshall

Road to see Louis Marshall. I'm pretty sure Louis's cabin was on his father Albert's land. If I'm wrong, I'm sure someone will correct me.

The house with ell, and then an attached barn, is classic New England architecture. In the winter a man could leave the kitchen, pass through the ell, into the barn to feed and take care of his animals, all without ever going outdoors. It was a very good system. Many of these old places have lost their barns. Kim Kendall's barns are as they were 150 or more years ago. This photo would date to 1900-1910.

Genealogy Interest Group

REGION – The next in-person and Zoom meeting of the Windham County Genealogy Interest Group (WCGIG) will focus on an exploration of "The New Full Text Search on FamilySearch," and "Getting Acquainted with the New Interface at Chronicling America," on Saturday, March 15, from 10:30 a.m. – 12:30 p.m., over Zoom and at Brooks Memorial Library. In case of inclement weather, it will be Zoom-only.

Please register at www.bit.ly/wcgig2025. A Zoom link will be sent before the meeting. For those people in the local vicinity, an in-person meeting will also be conducted at Brooks Memorial Library, 224 Main Street, Brattleboro, Vt.

FamilySearch's new Full Text Search is designed to significantly streamline the research process by allowing users to search the text contained within images of documents. Whether it's a handwritten record or a typed document, this tool not only highlights the name being searched, but also provides an automatic transcription of the document. For documents that have not been indexed, Full Search uses advanced recognition tech-

nology to pinpoint the exact location of a person's name within the record, eliminating the need for tedious page-by-page navigation. Users can now find relevant information more quickly and accurately, saving hours of painstaking work. This tool will be especially valuable for those working with unindexed or hard-to-read documents, giving them access to hidden gems that were once too difficult to extract. Full Search is currently available as an experimental tool on FamilySearch, and its development will continue to evolve based on user feedback. Come to the meeting and let's see what we can discover.

Over the past year, the Library of Congress has been redesigning an interface to the all-important Chronicling America. Since 2006, the Chronicling America Historic American Newspapers collection provides access to select digitized newspaper pages produced by the National Digital Newspaper Program (NDNP), a partnership between the National Endowment for the Humanities (NEH) and the Library of Congress. The consortium has digitized more than 3 million items,

and made these historical newspapers accessible for searching through 1963. Over the past year, the library has been redesigning the interface, and will be migrating to the new design very shortly. We will explore the changes from the legacy site to the new site, as well as visit "Chronicling America: A Guide for Researchers" for search tips and how best to use the collection, and a few of the topics in "Chronicling America" compiled by the librarians at the Library of Congress.

While I was waiting, there was a small child crying in her mother’s lap because her leg was in a lot of pain. Her mother told me that she had been waiting for two hours. An hour later, I finally got moved into a room and got X-rayed. Fortunately, there was no fracture, just an acute sprain, so I went home and have been treating it with ice.

While I was there, a nurse came in with a warm blanket, and told me that it was the last warm blanket. That’s not right – they should have enough medical supplies to provide what everyone needs.

I also heard a staff person say that six ambulances had

pulled in – and they were already overcrowded, which is why other patients and I had long waits. One of the ambulance drivers said that they had seen an increase in calls for Springfield since the Bellows Falls Health Center closed. I myself have been to the Springfield emergency room in the past, and I never had as long a wait as I did this time.

Closing the Bellows Falls Health Center has already put extra demand on Springfield Hospital. I’ve been reading in the news that this hospital may be slated for closure. I, along with other people in Bellows Falls, rely on Springfield Hospital for emergency care as well as other hospital care. Instead of closing, we need the Springfield Hospital to stay open with adequate staffing and all the supplies and medications that the staff need to care for us.

He was predeceased by his parents, one son Scott T. Dunda, brother Thomas, and brother-in-law Larry.

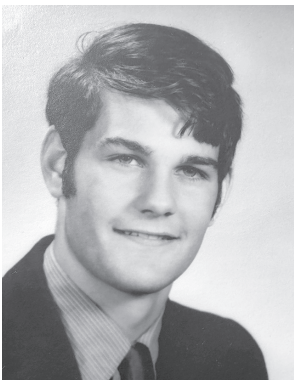

Paille Road Bridge #48: Remove and replace 2 galvanized steel guard rails, install 53.92 CY of riprap, and install 1 6ftL x 3ftW x 40inD wingwall. Proposed mitigation consists of extending 4 wingwalls (20ftL x 8ftH) with reinforced concrete.
Frog City Road Bridge #33: Install 1,061 CY of riprap. Proposed mitigation consists of installing 4 reinforced concrete wingwalls (10ftL x 20ftH).
Scout Camp Bridge #46: Install 450.37 CY of rip rap and 38.52 CY of concrete. Proposed mitigation consists of installing 4 reinforced concrete wingwalls (10ftL x 10ftH) at Bridge #46.

The project is within a mapped special flood hazard area (100-year floodplain). The actions may have temporary effects on the floodplain dynamics in and around the area where the work is conducted. A map of the area is available upon request.

The project must be in a floodplain because the bridges are functionally dependent on their presence in the floodplain. BRACC Teen Center

CHESTER, Vt. – Last year, the Black River Area Community Coalition (BRACC) launched an after-school pilot program in response to needs voiced by the community. The teen center program now serves more than 70 local youth, offers regular weekly drop-in hours, and continues to see a rise in attendance with new and returning participants showing up each week.

The Chester Teen Center provides a safe space in the community for teens to connect with each other, have fun and be creative, develop leadership skills, and get access to support and mentorship. On Wednesdays and Fridays, groups of students walk from school to the space to spend a couple of hours hanging out, playing games, painting, listening to music, and planning their own activities. In addition to offering regular drop-in hours, the teen center has held special events like movie nights, bonfires, karaoke, dances, and birthday parties. They've also ventured out in the community for field trips to local ski hills and

to the Okemo Valley TV studio for a youth-led podcast project. BRACC director Lauren Ingersoll and program supervisor Andrew Moore work together off site and on site at the teen center to facilitate activities for between 15 and 30 youth attendees each day. In the last couple of months, participating teens ran their own bake sale fundraiser, designed a new logo for their space, and started their own creative projects and committee groups.

succeed. Thanks to this collaborative effort from our community, we're able to provide a place for kids to go outside of home and school – and it's something they look forward to every week."

Registration for the teen center program is free and exclusive to youth in grades 6-12, or aged 13-19. Understanding retinal detachment

SPRINGFIELD, Vt. – The human eye is a marvel of biological engineering, allowing us to see the sparkle of light in the night sky from millions of miles away, or the dazzling array of colors in a sunset. But what happens when this delicate structure experiences the dramatic event known as a retinal detachment? Buckle up, as we embark on a journey through the eye to find out.

What is a retinal detachment? If the eye was a movie camera, the retina would be the film, and the light entering the eye would be the projection. If the film was suddenly damaged, what would happen to the projection? A suddenly distorted or dark screen.

Retinal detachment occurs when the retina, the thin “wallpaper” in the back of the eye, becomes separated from its supportive tissue. This can lead to permanent vision loss if not diagnosed and treated promptly.

Retinal detachment can occur for many reasons. Some common culprits include age, high myopia (nearsightedness), eye trauma, eye surgery, and diabetes. As we mature, the vitreous gel that fills the eye can shrink and pull away from the retina, leading to a detachment. If you have a strong glasses prescription for nearsightedness, your retina is thinner and more stretched than the average person, putting it at a higher risk for a retinal hole

or tear. If you have vision changes after a hard hit to the eye or eye surgery, get your eyes checked. Retinal detachment is a common complication of eye trauma. Uncontrolled diabetes can lead to diabetic retinopathy, or bleeding and abnormal blood vessel growth, that can detach the retina.

How do you know if you’re having a retinal detachment? There are often warning signs. Symptoms are often described as seeing persistent flashes of light in your peripheral vision, or increasing new black spots or “floaters” in your view. In some cases, there will be a dark shadow or curtain over a portion of the vision. These are all serious symptoms that need

immediate attention.

If you suspect a retinal detachment, schedule a visit with your eye doctor as soon as possible for timely diagnosis and treatment. Your doctor will dilate your eyes and determine if a detachment is present. If so, there are many treatments available depending on the type of break. Retinal surgeons may use a laser to seal down the retina. In some instances, a scleral buckle, or belt, will be placed to hold the retina intact. Another procedure, pneu-

mat-ic retinopexy, is the process of injecting a gas bubble in the eye to push the retina back against the eye wall.

Retinal detachment may sound scary, but with timely diagnosis and management, many people regain their vision. So, keep your eyes peeled for any unusual symptoms, and don’t hesitate to seek help. After all, we only get one pair of eyes.
