New owners of Leslie’s Tavern reclaim historical spirit(s)

BELLOWS FALLS, Vt. – It was 1985 when Leslie and John Marston purchased a 218-year-old former tavern at 660 Rockingham Road, once owned by the Lovell family of Bellows Falls. Circa 1790, Enos Lovell built the main structure, which later became a tavern, providing food, a place to stay, and lively hospitality to travelers arriving by stagecoach. At the time, Rockingham was nicknamed “Village of Seven Taverns,” for its cluster of inns along Post Road (now Route 5).

The Marstons restored the historic building, and in 1986 christened the new restaurant Leslie’s The Tavern at Rockingham. For 40 years, John and Leslie earned a loyal customer fanbase by creating delicious and memorable, Vermont-inspired fine-dining cuisine, served in a cozy setting, using fresh, local ingredients.

When the Marstons began considering retirement last year, Sam Putnam had been working as John’s sous chef for five years, and Sam’s wife Ashley was in restaurant management. Sam asked if John might consider leasing the restaurant to them, and John was open to the idea.

Both Sam and Ashley are New Hampshire natives, and their families had been coming

to Leslie’s Tavern for years. “On one of our first dates,” Ashley recalled, “Sam took me to John’s cooking class.” The couple currently lives in Charlestown, N.H.

Sam’s affinity for cooking started early. Not only did Sam have a natural knack for it, but he was eager to learn recipes and techniques directly from his “Grandma Put” in the family kitchen.

As 2026 kicked off, and the Putnams started to settle into their new roles, Ashley was pleasantly surprised to learn how much she enjoys bartending, and wished she had discovered it sooner. Sam, Ashley reported, was having fun experimenting with new sauces for the nightly specials menu.

Although the new Leslie’s Tavern will not offer cooking classes, they do host other types of events, charity fundraisers, corporate galas, and birthday parties. Live music performances happen most Thursdays and Sundays, with no cover charge.

“The cooking classes were really John’s thing,” Ashley said. “But we hosted a Christmas party for the Walpole vet last year, and other events.” For a private party of 40 or more, they will close the restaurant to the public.

The couple is excited to expand the bar service, and are already offering a more casual

happy hour menu from 3-5 p.m. The rustic bar area is warm and inviting. “We really want to open that bar up and make it a place where you want to stop in for a quick bite and a beer,” said Ashley. “You don’t have to come in for a fancy meal.”

Of course, the “fancy” meals will remain on the menu. Ashley and Sam’s plan is to continue the fine-dining traditions established by John and Leslie, including using fresh vegetables and herbs grown in the gardens planted by the Marstons more than 30 years ago, but, at the same time, grow the more casual tavern experience, and expand their local clientele.

Ashley said they want Leslie’s Tavern to be “not just [a place] for special occasions. We want employees from Sonnex to feel like this is somewhere they can swing by after work.”

Current hours are “Thursday through Sunday, 3 p.m. to 8ish,” said Ashley, making the point that closing time can be flexible. For instance, for a private event, or if someone traveling to the area arrives at 7:30 p.m., Ashley wants those folks to know they are welcome, will be happily served, and the staff will never make them feel rushed.

Rockingham Selectboard welcomes interim town manager

BELLOWS FALLS, Vt. – At Tuesday night’s Rockingham Selectboard meeting, Selectboard Chair Peter Golec introduced the interim town manager, Alex Torpey. Torpey is the former town manager of Hanover, N.H.

Golec reported that town officials met with Torpey earlier

that day “to update Alex on all the good things and the bad that are happening. He left the meeting with a stack of papers ‘that high,’” Golec said, indicating a tall stack of paperwork. “So, we’ll try to be easy on him tonight.”

“I appreciate the opportunity to work with all of you,” Torpey told the board. “I’ve had a fun time so far today meeting [some

of] the staff.”

Torpey said he was in a “downloading phase” as he tries to get a fuller understanding of the town’s needs and priorities. “Basically, my job over the interim period,” Torpey explained, “is to work on the urgent and important stuff, and push the other stuff so that the manager that you hire in a few months has the ability to come in and

make those decisions with department heads and staff.” Torpey assured the board that he was there to “keep the business running and support the boards,” and not to make any big changes.

Moving down the agenda, Golec announced that he met with Jarrod James, director of the Rockingham Recreation Center in Bellows Falls, to dis-

cuss the issue of mold at the center. Golec said they toured the whole building and found minimal evidence of mold, which was removed by James.

There was a brief discussion about what could be done to increase revenue at the recreation center, including a potential tier pricing program mentioned by Torpey.

Development director Gary

Fox announced the public hearing scheduled for Jan. 20, at 5 p.m., pertaining to the environmental cleanup at the former paper mill located in the TLR buildings in Bellows Falls. The hearing will take place prior to the selectboard meeting set for that evening. “The documents will be available in the town clerk’s office as of [Jan. 9],” said Fox.

Documentary “Join or Die”

Blending rigorous social science with humor, warmth, and striking visuals, “Join or Die” asks three urgent questions: What makes democracy work? Why is American democracy in crisis? Along the way, Putnam's story is enriched by voices from across politics, public health, economics, and culture, including Hillary Clinton, Pete Buttigieg, U.S. Surgeon General Vivek Murthy, Eddie S. Eric M. Taylor, 2025

CHESTER, Vt. – Eric M. Taylor passed away peacefully at home in Chester, Vt., with his wife Sali singing his favorite Grateful Dead songs by his side. His 77 years of life were packed with love, adventure, music, and friends, until he finally succumbed to ALS on Dec. 28, 2025.

Born in Cleveland, Ohio, his parents Burt and Doris Taylor moved to California shortly thereafter. Though living most of his adult life in Vermont and New York City, he remained a California kid his whole life, always seeking sunshine and the outdoors. One of his favorite places was the Sierra Mountains, and he once hiked the entire length of the John Muir Trail.

Upon graduating the University of Denver in 1970, Eric promptly married Sali in a sunny meadow behind her family home in Chester, Vt. They moved to Weathersfield Center, Vt., to chase a back-to-the-earth lifestyle, raising goats and chickens, cutting hay, and making maple syrup with Willis and Tina Wood.

Eric started filmmaking in 1973, first working as a sound recordist for the PBS Kids’ show “Zoom.” Enamored with the verité style and true stories of documentary work, he traveled the world recording everything from penguins in Patagonia, to the Kaiyapo people deep in the Amazon, and Madonna for her film “Truth or Dare.”

His shift to primetime television came in 1987, when he directed a segment in the pilot episode of “Unsolved Mysteries.” He ended up directing more than 100 segments for the show, relishing the opportunity to mix documentary interviews with dramatic recreations. He filmed documen-

taries for HBO, PBS, National Geographic, and others across 36 different countries and all 50 states, until he retired in 2010.

Students of Buddhism, Eric and Sali both believed in fostering compassion in their community, and founded the Westchester, N.Y., chapter of Beyond War. As part of his spiritual journey, Eric used his documentary skills to make films inspiring social change featuring Ram Dass, Thich Nhat Hanh, and the Dalai Lama.

Eric also had a lifelong passion for live music, seeing performances up until a week before he died. His favorite band was the Grateful Dead, and he attended several hundred shows dating as far back as 1967. After retiring, he played his five-string banjo for 15 years with the Stringfield Springers, an old-time string band based in Vermont.

For the last four years of his life, Eric courageously faced the challenges of ALS without complaint, ultimately letting go when he could no longer communicate. We want to thank our exceptional caregivers Coleman Drew, Katie Barber, Bonnie Hudson, and Vish Shetty, as well as Dr. Elijah Stommel and the Dartmouth Hitchcock Medical Center, the VNH for Vermont and New Hampshire, and the many ALS support groups and organizations for their extraordinary support. And, we want to acknowledge the tremendous number of friends and family who have been so helpful throughout these years, whose love, music, and guidance kept us in good spirits.

Eric is survived by his wife Sali; his sons Nate (Talya) and Jake (Jean); four grandchildren Caro, Mark, Grayson, and Hawken; his brother Karl (Su-

san); and his sister Jean (Andy). All of them will fondly remember his heartfelt stories, boundless love, and gracious smile.
