## VTel donates to Turning Point Recovery Center

SPRINGFIELD, Vt. – Vermont Telephone Company (VTel) recently presented a \$2,500 donation to Turning Point Recovery Center as part of its Round Up for Change community giving program. The check was presented on Jan. 7, following the close of the 2025 program year.

Each year, VTel selects a nonprofit organization to participate in Round Up for Change, and for the 2025 program period, Turning Point Recovery Center was chosen as the recipient. The program, which launched in 2024, allows VTel customers to voluntarily round up their monthly bill to the nearest whole dollar, with 100% of the rounded contributions donated directly to the selected organization. Customers can enroll or modify their participation at any time by visiting [www.vermontel.com/roundup](http://www.vermontel.com/roundup), or by contacting VTel customer service.

During the 2025 program period, participating customers raised a total of \$845.34 through voluntary monthly roundups. Following the program's annual conclusion this year, VTel doubled the customer-raised amount, bringing the total donation to an even \$2,500.

Turning Point Recovery Center supports individuals and families affected by sub-

stance use disorder by providing a safe, substance-free environment focused on recovery and connection. The organization offers peer-led recovery support, recovery coaching, wellness activities, and community-based resources, embracing multiple pathways to recovery while strengthening the emotional and social well-being of those it serves.

"Round Up for Change is made possible by our customers and their commitment to giving back locally," said Andrea Spaans, marketing manager at VTel. "Their participation helps support nonprofit organizations doing important work in our communities, and we're grateful to have been able to contribute alongside them to help make an even greater impact."

Looking ahead, VTel has selected Meals and Wheels of Greater Springfield as the Round Up for Change recipient for 2026. Meals and Wheels supports older adults and homebound neighbors throughout the region by helping ensure access to nutritious meals, regular wellness checks, and continued independence. The organization plays a vital role in reducing isolation and supporting the health and wellbeing of community members who may otherwise lack reliable daily support.

## Springfield projects slight budget increase

SPRINGFIELD, Vt. – The Springfield Selectboard held a public hearing for the purpose of budget review for the 2026-2027 fiscal year.

New Springfield town manager Scott Pickup seemed to hit the ground running, as he presented the overview of the budget. Pickup acknowledged there had been quite a bit of work done by finance director Cathy Sohngen, former town manager Jeff Mobus, and the budget advisory committee (BAC) prior to his coming on board the previous week.

Selectboard Vice Chair Michael Martin reminded everyone that "the original budget presented by staff was \$17,455,000. The prior year's budget was \$15,872,000." Martin said the board had tasked the BAC with reducing the proposed budget to reflect an increase of no more than 5%, "which they successfully did."

Additionally, Martin said, "The Town of Springfield is blessed with a fund balance in excess of its costs, so we have at our disposal up to \$200,000 that we can use to offset next year's costs." This, Martin ex-

plained, would reduce the spending increase to about 3%.

Martin reported that, based on budget projections, they expect an 8% increase in revenue.

There were no questions or concerns presented by citizens in attendance.

Board Chair Kristi Morris moved to adjourn the public hearing, and, upon commencement of the regular selectboard meeting, the board voted to approve the budget as presented, at \$16,776,225.

Former selectboard member Walter Martone was in attendance, representing the Springfield Historical Society. Several representatives from Stellafane, including the president of the Springfield Telescope Makers Club, Celia Detrich, joined Martone to present a proposal for the creation of a new museum located in the downtown area specifically dedicated to the history of Springfield and Stellafane. Founded by Russell W. Porter in the early 1920s, the Springfield Telescope Makers Club was formed after the completion of a hilltop observatory.

"Between the two of us," Martone commented, "we've got a lot of Springfield's history." Martone then explained that many artifacts, documents, and other items of historical sig-

nificance were collected in multiple storage areas and not accessible to the public.

The request was for \$25,000 to fund the establishment of the new museum. Martone told the board that the societies were working on a marketing and business plan to ensure the museum would eventually become self-sustaining.

Martone explained that the joint museum would "enrich the downtown area, attract visitors – including those attending Stellafane's annual conference – support economic development, and better preserve Springfield's heritage."

The board voted to amend the previously approved budget to include \$25,000 for the new appropriation. A second vote approved the revised budget total of \$16,801,225.

Martin reported on the upcoming meeting schedule of the ordinance committee as they begin reviewing the new land use planning ordinance. Martin said the committee is required to deliver findings by March 20, but he expects they will finish before that date. He encouraged the public to attend these discussions.

The Springfield Selectboard meets on the second and fourth Monday of each month, at 6 p.m. The board's next meeting will be Monday, Jan. 26.

## Springfield Rotary Club hears from VRmont Studios

During her presentation, Michaud outlined the wide range of projects VRmont Studios undertakes, including video production, livestreaming, podcasts, promotional content, and

event coverage for nonprofits, businesses, and community organizations across the region. She emphasized that the studio's mission extends beyond production work, to focus on mentorship, accessibility, and expanding opportunities for individuals who may face barriers to traditional employment.

Michaud also highlighted the broader role of the Black River Innovation Campus as a community hub for entrepreneurship, innovation, and workforce development. By combining professional-grade media production with education and support, VRmont Studios contributes to both individual career growth



She holds a bachelor’s degree in political science from Regis College, and a master’s degree in professional studies from Pennsylvania State University.



## Susan M. MacNeil, 1953-2025

**BELLOWS FALLS, Vt.** – Susan Marie MacNeil, a devoted community leader, advocate, and beloved matriarch, passed away unexpectedly at her home in Bellows Falls, Vt., on Jan. 10, at the age of 72. She leaves behind a remarkable legacy of compassion, service, creativity, and fierce love for the people and causes that mattered most to her.

Susan was born on July 21, 1953, in Cambridge, Mass., to Jean and Charles MacNeil. In 1959, her family moved to Coventry, Conn., where she was raised and attended local schools. Even at a young age, Susan stood out for her

intellect and enthusiasm for life. She excelled academically, was an avid and lifelong reader, and brought energy and spirit to everything she did, including her role on the cheerleading squad. Susan later made her home in Keene, N.H., where she became deeply rooted in the community, before eventually settling in Bellows Falls, Vt.

No matter where she lived, Susan showed up fully and generously, believing that communities are strengthened when people commit themselves to one another. Her professional life was defined by public service and fearless advocacy. For decades, Susan dedi-

cated herself to nonprofit, arts, health, and civic organizations throughout New England. She was especially committed to supporting individuals and families affected by HIV/AIDS, working during a time when stigma and fear often kept others at a distance. Susan approached this work with humanity, dignity, and persistence, ensuring that those most marginalized were seen, respected, and cared for.

After moving to the Keene area in the late 1980s, Susan held countless leadership roles, some paid, many volunteer, all undertaken with the same devotion. She served as PTA president at both Franklin and Marlow elementary schools, later becoming an executive board member of the New Hampshire State PTA Association. At Keene State College (KSC), she served as

vice chair and then chair of the Operating Staff Council, earning recognition as a KSC Outstanding Employee. Susan's love for the arts and community connection led her to roles as director of marketing and, later, interim executive director of the Colonial Theatre. In 2000, she became executive director of AIDS Services for the Monadnock Region, a position she held until 2008, and again from 2009 until the organization merged in 2014. During her tenure, she created and nurtured beloved fundraising and community-building events, including Just Desserts, Keene Karaoke IDOL, and later Southern Vermont IDOL, programs that brought joy, talent, and togetherness from across New England. One of Susan's most meaningful contributions was her work bringing pan-

els of the AIDS Memorial Quilt to local communities each year for World AIDS Day. First encountering the quilt in Washington, D.C., in 1996, Susan often said that seeing it in person was life-changing. That experience became a catalyst for her lifelong commitment to AIDS advocacy and remembrance.

Susan also worked with the Keene Unitarian Universalist Church and the 100 Nights Shelter before relocating to Bellows Falls in 2015, where she joined Landmark College. She quickly immersed herself in civic life, lending her experience to Keene Pride and Bellows Falls Pride, helping these organizations navigate challenges and grow stronger. Even after a work-related accident in 2022 limited her physical abilities, Susan continued to advocate, promote events, and support others however she could. She served as a Bellows Falls Village Trustee, was active with the Rockingham Arts & Museum Project and Rockingham for Progress, and championed the preservation of the historic Miss Bellows Falls Diner. Susan also hosted a local television talk show, provided voiceovers for commercials, acted in local theater, wrote screenplays, published books, and volunteered wherever help was needed. If a cause was underserved or difficult, Susan stepped forward.

At the heart of Susan's life was family. She was a devoted mother to her son and a fiercely proud grandmother to her granddaughter, who she loved with intensity and purpose. She was a loving sister, a cherished aunt, and

a constant presence in the lives of her extended family. Susan deeply admired her mother, and credited her with instilling the compassion, generosity, and strength that guided her life. Susan cared for her mother through the end of her life, an experience that profoundly shaped her advocacy around end-of-life care. After her mother's passing in 2022, Susan wrote and self-published "18 Minutes: A Daughter's Primer on Life & Death," inspired by the final moments they shared. She went on to advocate for amplified phones in hospital rooms, and created a traveling workshop, "Life, Death and Cake – Preparing for a Good Death," helping others navigate end-of-life planning with honesty and grace. Susan's sense of family extended far beyond blood. She cultivated a wide "found family" of friends, colleagues, artists, and neighbors, who relied on her loyalty, encouragement, and unwavering care. On her refrigerator was a bumper sticker that read, "And what difference did you make today?" When asked about it, Susan simply said, "That's really how I've lived my life."

Susan is survived by her brothers Bill MacNeil, of Sebring, Fla., Donald MacNeil and his wife Debbie, of North Windham, Conn., and Bruce MacNeil and his wife Betsy, of Keene, N.H.; her son Justin Ellsworth, of Bedford, N.H.; her granddaughter Kiyah Dannan Glenn-Ellsworth, of Keene, N.H.; several nieces; a nephew; and grand-nieces, all of whom will forever cherish the light she brought into their lives.

"Improving your home's energy efficiency in 2026 is an investment that will pay off for years to come," said Peter Walke, Efficiency Vermont's managing director. "It'll pay off literally, with lower energy bills. With improved comfort. With lower emissions thanks to more deliberate energy use. And by lowering demand, it supports a more affordable electricity system for everyone connected to our shared grid."

Now is the perfect time to plan a home energy project. Find a contractor in the Efficiency Excellence Network near you to start your project or begin planning for spring.

Heat pump heating sys-

tem rebates are available through a joint program offered by Efficiency Vermont and your electric utility. Efficiency Vermont's website also has information on additional incentives that may be available from your utility.

Weatherization rebates offering up to 90% cash back are also available from Efficiency Vermont, with limited-time funding from the Vermont Department of Public Service, supporting increased incentives for low- and moderate-income households. Free weatherization services for low-income households are also available through the state's Weatherization Assistance Programs.

Incentives and solutions that can help Vermonters embrace energy savings in 2026 include the following.

Free resources to prioritize energy investments in the new year – Understand current offers or diagnose high bills by calling Efficiency Vermont's

energy advisors. You can also schedule a free virtual home energy visit with an Efficiency Vermont energy expert to get personalized advice and a list of next steps toward your goals.

Up to 90% cash back on weatherization projects – Air sealing and insulating your home lowers energy bills, makes a home more comfortable year-round, and improves indoor air quality. Weatherization also makes it easier to embrace clean technologies like heat pumps. Increased weatherization incentives are only available through the end of 2026, or while funding lasts.

Rebates for heating systems that work for your household – Save up to \$475 on a ductless "mini split" heat pump, or save up to \$2,200 on a ducted heat pump. Or opt for advanced wood heating with a wood or pellet stove (and a \$400 rebate), or get \$6,000 off central wood heating systems.

Save up to \$1,000 on water heaters that use heat pump technology – Get a \$600 discount when you upgrade to a heat pump water heater, bringing the efficiency and savings of a heat pump to the hot water needed in your kitchen, bathroom, and laundry room. Income-eligible households can get an additional \$400 back.

Create a healthy home with appliance rebates – Control your home's temperature and save on energy bills with up to \$100 cash back on a smart thermostat, or manage moisture in your home with up to \$90 off a dehumidifier. You can also get up to \$400 off a heat pump clothes dryer or washer/heat pump dryer combo unit. If you're already planning for summer, get up to \$150 off a window AC unit.

Income-eligible residents of Windham County can get up to \$15,000 toward wood or pellet central heating systems (furnace or boiler). This is in addition to the \$6,000 rebate from Efficiency Vermont for these wood heating sys-

## Raku pottery class

Berends will be teaching the exciting Japanese firing technique known as raku. Raku is a 16th-century technique developed in Japan for making tea-ceremony ware. It has been

Raku is a fun, exciting technique, where pots are fired to 1,840 degrees, pulled out of the hot kiln, and manipulated with sawdust and water to change the look of the glazes. The glazes can be metallic, and/or have a crackle effect, making each piece truly unique and one-of-a-kind. We will also fire

pots with an exciting new technique known as horse hair raku, which creates interesting designs on the clay. The raku firings can be done indoors or outdoors, depending on the weather.

The class will include wheel-throwing, slab-making, and extruding instruction. The first day will include making all types of clay work, and the second day will be glazing and firing all the pots in the raku tradition. Emphasis will be on being creative, and learning the basics of pottery, including making the work, glazing, as well as firing. The class is geared towards teens through adults, and limited to four students.

Berends has been a master potter for over 30 years, with a Bachelor of Fine Arts from the New York State College of Ceramics at Alfred University, as well as a Master of Fine Arts from Montana State University. He worked with a Spanish folk potter for a year, and was also a guest artist-in-
