Springfield on the Move projects and events planned

SPRINGFIELD, Vt. – Springfield on the Move (SOM) has several initiatives designed to bring more activity, businesses, events, and visitors to downtown Springfield, with Director Vanessa Rebentisch leading the effort.

SOM has partnered with the Town of Springfield, Springfield Regional Chamber of Commerce, Springfield Regional Development Corporation, and local residents with the goal of revitalizing downtown, including Main Street and the 100 River Street building. Rebentisch is working on multiple projects that she said “stretch from working with private property owners, to tenants, to entrepreneur workshops.” She explained, “We try to elevate the community by focusing a lot on community pride.”

SOM has also partnered

with the Town of Springfield for the Springfield Incubator Program, a strategic initiative aimed at stimulating economic development in downtown Springfield. The plan aims to utilize 27 Main Street and offer space for lease to vendors, including weekly food vendor spotlights, and arts and craft vendors. Each week, one food vendor will have the opportunity to sell their culinary creations, and alongside them will be other vendors showcasing their handmade goods.

The Incubator Program will help to revitalize downtown Springfield, enhance the shopping experience, and support the local economy. If you have a product to share, this is your opportunity to apply by submitting the online form at www.springfieldonthemove.com/incubator-program.

You’re invited to join Springfield on the Move at its Annual Meeting on Aug. 25, at 5 p.m., at the Great Hall, 100 River Street. The Annual Meeting is open to

the community, who can see what’s new and learn about next year’s plans and new initiatives, and engage with community members to share ideas. The meeting will be catered by Springfield Co-op.

The Great Hall is located inside the 100 River Street building. Rebentisch said, “We have been focusing on revitalizing this building, because it is enormous, it’s weatherproof, and it’s a huge asset to this community.” The plan is to utilize the space for a variety of businesses or related centers, where residents and visitors can go to spend some time and be im-

mersed in the experience. Plans are in the works for a wellness center downstairs, and to bring the Great Hall up to code for full-scale retail. Also, the Springfield Telescope Makers have partnered with the Springfield Historical Society to open a new joint-effort museum in the space.

Scheduled events to be held at the Great Hall include upcoming quarterly art shows; The Festival of Lights, planned for Nov. 20; and a Christmas market, scheduled for Dec. 12, from 10 a.m. – 4 p.m.

Additionally, Fourth Fridays Music in the Park is held the fourth Friday of every month through October, from 5-8 p.m., at Comtu Cascade Park on Main Street. Attendees can experience a downtown area filled with local vendors, fantastic live music in the park, and plenty of activities for everyone. Mark your calendar for

upcoming 2026 Fourth Fridays, scheduled for Aug. 28, Sept. 25, and Oct. 23.

Cleanup of former J&L plant moving forward —

SPRINGFIELD, Vt. – Bob Flint, director of the Springfield Regional Development Corporation (SRDC), attended the Aug. 10 Springfield Selectboard meeting to present an informational update on the demolition and redevelopment project at the former Jones & Lamson (J&L) plant, located at 160 Clinton Street.

Along with Thomas Kennedy, of the Mount Ascutney Regional Commission (MARC), and Daniel Voisin from Stone Environmental, Flint outlined the brown-field cleanup effort at the historic site before taking questions and comments from residents in attendance.

Flint explained the latest action, which will be going on for the next month or so, by saying, “My flippant way of [describing] it...is we’re going to be sucking some of the bad stuff from under the slab before it gets to the

river.”

Voisin clarified the “bad stuff” of concern was non-aqueous phase liquid, or NAPL, which, in this case, is bunker oil, a petroleum by-product with a tar-like consistency left over from crude oil refining.

“Essentially what we’re doing,” said Voisin, “is...using the existing well network to put a bio-solvent into the ground to reduce the viscosity of the bunker oil...then extract[ing] to get that out of the ground.” The extracted liquid will go through several treatment tanks before being discharged through the town sewer system.

Using this “enhanced recovery” method, Voisin explained, will leave about 5% of the contaminants remaining, which will be monitored, but allows the remediation to happen more quickly and cost much less than a full excavation of the site.

There will be another opportunity for public com-

ment on Aug. 29. If there are no significant objections raised, remedial implementation will begin on Sept. 7, with an anticipated completion of extraction in mid-October.

Future cleanup plans include removing asbestos from an exterior brick wall on the north end of the site and demolition of the rest of the building with the exception of one section of the skeleton, which will remain as a visitors pavilion. The total cost thus far is around \$9 million, and funding has not yet been secured for any work beyond the current extraction project.

The board next heard from the Friends of Skitchewaug regarding the historic Spencer Hollow Schoolhouse, located just off Route 143. Constructed circa 1800, the school is listed on the

National Register of Historic Places and is the oldest brick schoolhouse in Vermont.

The local group of volunteers has been caring for the site with the goal of reopening the building and using it for limited community and educational purposes. They reported receiving a matching grant from the Preservation Trust of Vermont to conduct an evaluation of the structure and create a prioritized plan, at a total cost of \$750. They requested that the board approve \$375 in matching funds. After Town Manager Scott Pickup confirmed town funds are available, the board authorized the payment.

At the outset of the meeting, Pickup updated the board on the list of properties with multiple, ongoing fire and safety code violations that are currently being addressed by the town. Pickup announced that a new zoning administrator would be starting at the end of the month, which will

help to bring a more rapid resolution to these types of complaints.

Regarding the property at 78 Valley Street, the board voted to approve withdrawal of \$20,000 from the town fund balance to purchase the property. Pickup relayed, “By authorizing this transaction, we will trigger a required period for the public to potentially appeal this expenditure of public funds.”

Future plans for the site could include demolition and subsequent use of floodplain programs, to be determined by public meeting.

Further along the agenda, Pickup presented a request to the board regarding bringing on New England Municipal Consultants (NEMC) in a greater capacity, to provide ongoing assessing services. The town is actively under contract with NEMC to conduct the state-

Springfield Garden Club dedicates Liberty Tree —

SPRINGFIELD, Vt. – An exciting, historical event occurred recently in Springfield, Vt., at the Crown Point Country Club. On June 30, at 5 p.m., more than 60 people gathered to celebrate the planting of a Liberty Tree by the Springfield Garden Club (SGC). This event, in turn, was part of a larger effort to plant 250 Liberty Trees across the nation by July 4, the 250th anniversary of the birth of our nation.

This story begins in 1775, in Boston, Mass., where Patriots would gather below an old elm tree known as the Liberty Tree near Boston Common to discuss their dissatisfaction with British rule. The British sought to disrupt these gatherings and cut the tree down in August of that year. That, obviously, did not deter the Patriots, who went on to defeat the British in the Revolutionary War that involved the Crown Point Road.

Skip to 2023, when the Sons of the American Revolution formed the 250th SAR Liberty Tree Program

with the goal of planting 250 disease-resistant Princeton elm trees, with at least one in every state. As of today, 325 Liberty Trees have been planted in 47 states. The tree in Springfield is the 291st tree to be recorded and one of only three in the State of Vermont.

Just this spring, SGC member Karen Jarret notified the garden club about the Liberty Tree project. It

was enthusiastically embraced by the club, which quickly formed an ad hoc committee. In trying to decide where to install it, the Crown Point Country Club (CPCC) came to mind, as the historic Crown Point Road passes through it and the site is accessible to the public. The CPCC graciously agreed to welcome the tree on its premises. The tree was then ordered through Woodbury Florist, and it was planted by them on June 7, at the CPCC near Crown Point Road Marker No. 14.

June 30 brought a little rain, but still brought a full house to join in the dedication ceremony. Mike Martin started off by stating the CPCC was honored to be the permanent home of the Liberty Tree, and then introduced the SGC president, Adrienne Faulhaber, who led the program. Faulhaber welcomed representatives from the Crown Point Country Club, the Springfield Chamber of Commerce, the Town of

Springfield, Springfield on the Move, the Springfield Art and Historical Society, the Charlestown VFW, The Fort at No. 4, the Daughters of the American Revolution, the Springfield Reporter, WCAX Channel 3, Woodbury Florist, the Rockingham Historic Preservation Society, and the Crown Point Road Association; local veterans; and the pub-

lic. She told the crowd that, “Today, we are celebrating the planting of a new Liberty Tree to honor the legacy of this Crown Point Road and the history here, and to honor all of the veterans who have answered the call to serve and protect our freedoms and rights as citizens.” Tim O’Hearne from

Springfield Parks & Recreation new programs and master plan

SPRINGFIELD, Vt. – Springfield Parks & Recreation is looking at both immediate opportunities and long-term planning as it works to meet the recreational needs of the community. Parks & Recreation Director Adam Middleton recently spoke to the Springfield Rotary Club, providing an update on the department's programs, facilities, and future plans.

One of the department's newest offerings is a cheer-leading program, which is being introduced this fall. Middleton said youth sports continue to attract significant participation, with approximately 150 to 200 young people taking part in sports programs.

The department's facilities are also busy, particularly during the winter months. Middleton said approxi-

mately 150 to 200 people pass through the doors of the recreation building during the winter, underscoring the role the facility plays in providing activities and a gathering place for residents.

While current programs remain an important focus, Middleton is also looking toward the future. He said he hopes to develop a master plan for Springfield Parks & Recreation that would provide a comprehensive look at the community's recreational needs. Such a plan could help identify priorities for facilities, programs, and future investments, while ensuring that the department's resources are being used to best serve Springfield residents.

Middleton's presentation was part of the Springfield Rotary Club's regular series

of programs featuring community leaders and organizations. The club provides an opportunity for local officials and community members to share information about programs and initiatives affecting Springfield.

mandated townwide reappraisal.

Pickup reported that Nicole Knight, Springfield's current town assessor, was going to step back from fieldwork to focus on office and Grand List maintenance. Pickup proposed that NEMC take over duties such as field inspections and data collection, while Knight

remains in a supportive, clerical, in-house role.

Ryan Silvestri, co-owner of NEMC, was at Monday's meeting to introduce himself and answer any questions. He explained the state requires reappraisals every six years. Ultimately, the board voted to approve the NEMC contract, with partial offset of costs from state per-parcel funds.

Additionally, the board approved an event permit application from the Springfield Regional Development Corporation to hold the River Valley Employment Fair at Riverside Middle School, on Sept. 25. The job fair connects employ-

ers with job seekers and will run from 11 a.m. – 7 p.m.

A few town project updates reported by Pickup included the completion of the Seavers Brook Road paving work, as well as the touch-up operations on Woodbury Road. Pickup said the paving contractor would begin work again around Sept. 3 on Eureka Road, Mineral Street, and St. Patrick Street. Also, the Grove Street culvert construction project is complete, and the road has been reopened.

the Charlestown VFW then led everyone in reciting the Pledge of Allegiance while reenactors in costume from The Fort at No. 4, Eric and Barbara Bye, held up a 1776-era flag.

Next, Karen Oehl, pastor of the United Methodist Church in Springfield, led the singing of the national

anthem. Jeff Taft-Dick, an unofficial CPCC historian and SGC member, gave a brief history of the Crown Point Road and noted that Leland Lawrence, a founding member of the CPCC, suggested that the CPCC be named after the historical road. Taft-Dick also told an interesting story about President Dwight Eisenhower being given an honorary membership to the CPCC; the president ordinarily did not accept memberships to clubs, but made an exception because of the history involved. This was followed by a dedication prayer by Karen Oehl, who asked that the act of planting this tree be received as a "pledge of commitment to liberty and justice for all."

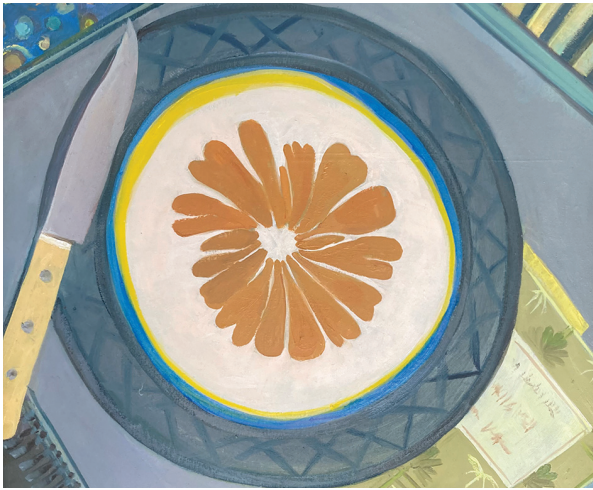

New artwork on display at Canal Street Gallery —

BELLOWS FALLS, Vt. – Canal Street Art Gallery presents new artwork from Nancy Fitz-Rapalje, Kim Grall, and Edward Kingsbury III, open Aug. 21 – Oct. 11. Join the gallery on Aug. 21, from 5-7 p.m., for Bellows Falls Third Friday and an opening reception for the artists. All gallery events are free and open to the public; for wheelchair accessibility, call 802-289-0104.

Fitz-Rapalje, based in Bellows Falls, Vt., presents paintings from some of her familiar subjects, such as floral still lifes, peaches, and apples. Made in her calculated, geometric style of brushstrokes, Fitz-Rapalje employs her well-known top-down perspective, thereby flattening the background and focusing on placed objects. Fitz-Rapalje, referring to her paintings as “sketches,” describes her practice of painting quickly from observation as “a quick drilling of the eye and a short alla prima battle.” For the artist, the finished painting then becomes a reminder of that day when she really looked, and thus is reinvigorated to do it again.

Grall, based in Westminster Station, Vt., creates two- and three-dimensional artworks expressing the artist’s connection with nature

through the use of many natural materials which the artist grows, forages, and makes herself, such as beeswax; earth pigments; plant-based, handmade papers; raw fleece; leaves; feathers; and grasses. Most recently, Grall is making marbled, handmade papers. The artist also uses techniques such as pyrography, painting, and collage to make representations of scenes from the world, focused on birds, bugs, amphibians, and native plants where the wetland meets the forest.

Kingsbury, based in Keene, N.H., shows new abstract acrylic paintings, studies in color and pattern and the practice of making art as prayer. The resulting paintings are Kingsbury’s

abstract representation of God. The artist’s paintings are intricate line-made structures layered with opaque and translucent color, and all-over applications creating luminous woven surfaces.

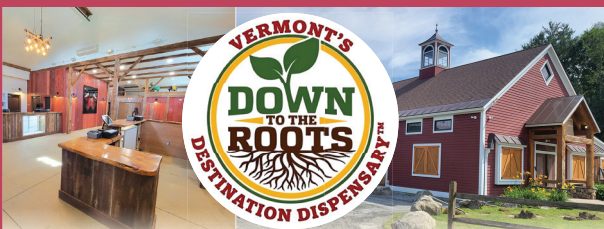
This festival and fundraiser is only possible due to the imagination and generosity of our community, and we invite you to join us as a builder or event volunteer to help us host this regional treasure.

FOLA to screen classic “Safety Last”

LUDLOW, Vt. – It’s a cinematic image so powerful, people who’ve never seen the movie instantly recognize it; Harold Lloyd hanging from the hands of a huge clock, from the climax of his silent comedy “Safety Last” (1923), has emerged as a symbol of early Hollywood and movie magic.

See for yourself with a screening of “Safety Last” on Saturday, Aug. 22, at 7 p.m., in the Heald Auditorium at the Ludlow Town Hall, 37 Depot Street in Ludlow, Vt.

Presented by the Friends of Ludlow Auditorium (FOLA), the screening will feature accompaniment by Jeff Rapsis, a New Hampshire-based composer who specializes in creating live music for silent film presentations. Admission is free and all are welcome to this family-friendly event. Donations are accepted at the door to support the Friends of Ludlow Auditorium.

“Safety Last” follows young go-getter Lloyd to the big city, where he hopes to make his mark in business, then send for his small-town sweetheart. His career at a downtown department store stalls, however, until he gets a chance to pitch a surefire publicity idea: Hire a human fly to climb

the building’s exterior. But when the human fly has a last-minute run-in with the law, Lloyd is forced to make the climb himself, floor by floor, with his sweetheart looking on. The result is an extended sequence filmed without trick photography that blends comedy and terror, holding viewers spellbound.

Lloyd, along with Charlie Chaplin and Buster Keaton, is regarded as one of the silent screen’s three great clowns.

Lloyd’s character, an ambitious young man ready to struggle to win the day, proved hugely popular in the 1920s. While Chaplin and Keaton were always favored by the critics, Lloyd’s films reigned as the top-grossing comedies throughout the period.

Rapsis will create a musical score for the film live during its screening, in the manner of theater organists during silent cinema’s peak years in the 1920s.

“For most silent films, there was never any sheet music and no official score,” Rapsis said, “so creating original music on the spot to help the film’s impact is all part of the experience.”

“That’s one of the special qualities of silent cinema,” Rapsis continued. “Although the films themselves are often over a century old, each screening is a unique experience – a combination of the movie, the music, and the audience reaction.”

We’re so grateful for their kindness, and to our community for supporting everything we do.” WCHS does more than just adoptions, and every service is funded by donations. It offers spay/neuter services, vaccine and nail trim clinics, microchip-

ping services, flea and tick preventatives, a pet food pantry, and wellness appointments for Pet Care Assistance (PCA) clients. Already in 2026, WCHS has placed 465 pets in new adopted homes and performed 995 spay and neuter surgeries. It has taken its services mobile with vaccine clinics, and offered free spay and neuter surgeries to Tri-Park residents. 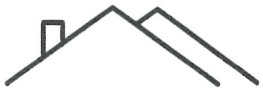

Dear Editor,

Kendra Rickerby’s letter of Aug. 12 about the Vermont Department of Education encouraging the use of AI in Vermont school systems and in the classroom is built on deceptive grounds. She has succumbed to one of the ploys the Wall Street gamers use to keep the AI bubble from bursting.

It was Wall Street hedge funds that invented “Democrats for Education Reform” when George W. Bush instituted the “Race to the Top.” Its purpose was not to promote better education, but to profit from the creation of the standardized testing industry. It is now the tech industry which is seeking to find some sort of profitability in a consistently unprofitable wild goose chase by tapping into the last vast reservoir of public funding: the public education industry.

The first test of AI as a help to students proved it a massive failure. A UMass study showed so, www.gazettenet.com/2025/11/07/use-of-ai-in-the-classroom-doesnt-lead-to-higher-grades-umass-study-says. And, to quote Elizabeth Laird, director of the Equity in Civic Technology Project at the Center for Democracy and Technology, “Our research shows AI use in schools comes with real risks, like large-scale data breaches, tech-fueled sexual harassment and bullying, and treating students unfairly.”

As for using it in school administration, there are two fatal flaws.

First, just like driverless cars, it will never have the subtlety of information processing that the human brain has. Just like the Waymo taxis on the streets of Los Angeles, it will need a

human operator to correct its deficiencies from moment to moment.

Second, to even promote AI as a solution is to completely miss Vermont’s real problem with education: The system as it is focuses on cost effectiveness rather than educational effectiveness. Nobody educates anybody well by focusing on costs. Humans are too diverse in essence to be treated like parts on an assembly line. The individualized approach to each one is necessary, and the people who understand that are teachers. Rather than prioritizing costs, we should give the teachers what they need.

One of the few high government officials to realize the value of education was Reagan’s Secretary of Defense Caspar Weinburger. When strategists suggested that Head Start be

eliminated so the money could be used to build more missiles, he squashed the idea. He knew how valuable Head Start was. Thirty years later, a study confirmed what Weinburger had felt: Adults who had attended Head Start programs in their toddler years had led far more law-abiding lives than their peers, consistently.

It is time to break the Wall Street profit-and-loss shackles. We must stop evaluating education by a balance sheet, empower teachers to use their professional skills, and judge by the long-term results: where the children arrive decades later.

A fed bear is a dead bear

REGION – In Stowe recently, the Vermont Department of Fish & Wildlife authorized the killing of a bear that had grown dangerously comfortable seeking food around people from homes and businesses. If the past few years are any indication, by the end of summer we will have had to put down or provide similar authorizations for dozens more bears to end acute conflicts that threaten human safety.

No one wants this outcome for Vermont’s bears, but when Vermonters fail to put proactive coexistence measures in place before bears learn that our homes and villages are good places to find food, this is the predictable outcome. This challenge is not limited to Stowe or even to mountain towns. Except for the Champlain Islands, if you live in Vermont, you live in bear country, and Vermonters are collectively failing our bears.

We say “collectively” because whole communities teach bears where to find food, not just individual households. It is tempting to blame one family’s birdfeeder or one business’s dumpster, but bears are more adaptable than this. Our neighborhoods need to be in lockstep taking down birdfeeders when

the snow melts and keeping trashcans and totes stored inside until immediately prior to pickup on trash day, and our downtowns need to present a unified front of well-secured dumpsters.

A bear that finds an easy meal when one house leaves their garbage out overnight will soon test other houses. Vermont’s bears mastered strategies like this over many years, and have now passed their knowledge on to multiple generations of cubs.

Bears are not at fault for these behaviors. Creativity, group learning, and tenacity are simply their nature. These are also the qualities that inspire our affinity and respect for bears. Humans are to blame when we collectively create situations that encourage bears to take risks and then fail to correct our mistakes quickly enough for coexistence to work.

Over the past several decades, our department’s approach to human-bear coexistence has centered on creating the conditions for our bear population to thrive and providing the information and assistance for Vermonters to voluntarily keep bears wild.

We conserve thousands of acres of remote bear habitat,

place hundreds of “Keep Bears Wild” signs in communities across the state, partner with the nationally recognized non-profit BearWise on print materials to share at workshops and community gatherings, and publish extensive coexistence resources online. We invite bear coexistence news coverage each spring and throughout the summer, support peer-learning networks on living in bear country, and oversee a sustainable, regulated bear hunt every fall.

Our biologists and game wardens annually field upwards of a thousand inquiries about living with bears, conduct hundreds of site visits to provide on-the-ground coexistence advice, and, in serious cases, wardens issue citations when bears are being intentionally fed. Even so, both the number and severity of bear incidents are escalating, putting

both bears and humans at risk.

Today, Vermont is home to as many as 8,000 bears, substantially more than in the past, but whether those encounters become conflicts has less to do with bear numbers than with what people do or don’t do. Human behavior, and specifically our ability to make good on the shared responsibility of living in bear country, is the single most important factor.

Put simply, Vermont’s bear population is thriving, and we need Vermonters to meet a higher standard as stewards of our bears. If we cannot change course together, then Vermont will continue to play out the grim adage: a fed bear is a dead bear.

“Vermont Civilian Conservation Corps Camps”

REGION – Historian Martin Podskoch’s book “Vermont Civilian Conservation Corps Camps: History, Memories & Legacy of the CCC” was released in August 2026. The book describes the history of the 36 Civilian Conservation Corps (CCC) camps and supply depots where young men aged 18-25 years and World War I veterans built dams, state parks, and state forests from 1933-1942.

For the past four years, Podskoch has visited and explored the 36 Vermont CCC camps and gathered the camps’ histories and photographs from historical societies, museums, libraries, personal interviews, and state and college archives. Families of CCC young men and veterans who worked in Vermont state parks and forest shared their relatives’ memories and photos of camp life and work projects.

The Civilian Conservation Corps (CCC) began on March 31, 1933, under President Franklin Roosevelt’s New Deal to relieve the poverty and unemployment of the Great Depression. Workers built trails, roads, campsites, and dams; stocked fish; and built and maintained fire towers, observer’s cabins, and telephone lines. They also fought fires and planted millions of trees. The CCC disbanded in 1942 due to the need for men in World War II.

Brian Lindner, native Vermonter and historian, stated, “At a time when the Great Depression was crushing the dreams of Americans, President Roosevelt created the Civilian Conservation Corps. Vermont State Forester Perry Merrill saw its potential and successfully lobbied Washington with a long list of ‘shovel-ready’ projects that created the state park

system, hiking trails, forest fire protections, streambed improvements, and reforestation projects. These helped make Vermont a leader in the sport of skiing and outdoor recreation.”

The history of the following 36 Vermont towns with CCC camps and supply depots is told in Podskoch’s book: Barre Supply Depot, Bellows Falls, Bethel, Brunswick, Colchester Supply Depot, Colchester Army, Cuttingsville/Shrewsbury, Danby/Mount Tabor, East Barre, East Burke, East Wallingford/Weston, Elmore, Jericho/Firing Range, Ludlow, Marshfield/Groton, Mendon, Middlesex, Milton, Montpelier/Middlesex/Wrightsville, Montpelier/McKee, Moscow, Northfield, North Thetford, Peru, Plymouth, Poultney, Ricker Mills, Rochester, Saint Albans, Sharon, Underhill Center/Firing Range, Waterbury/Village, Waterbury/Dam, West Burke/Sutton, Wilmington, and Windsor.

“Marty Podskoch has been researching Vermont’s CCC camps for many years, and

this book provides a comprehensive history of them,” said Lyman Orton, proprietor of The Vermont Country Store. “Many of the trails at Bromley ski area were built by the CCC. The dirt road from Landgrove to Mount Tabor on Route 7 was worked on by CCC crews, and my father pointed out the excellent job they did, as evidenced by the good condition the road was in compared with some town roads that did not hold up as well. My father told me, ‘Those boys knew how to put down a good base,’ and it still rings in my ears.”

Podskoch is a retired teacher from Delhi, N.Y., in the Catskill Mountains, and the author of 12 books. He also writes a weekly column called “Adirondack Stories” in five Adirondack newspapers. Jane Kolias’ “METALSUM” opens at NXT Gallery

PUTNEY, Vt. – Next Stage Arts invites the public to celebrate the opening of “METALSUM,” a new exhibition by Putney artist Jane Kolias, whose inventive sculptures and metal quilts transform discarded objects into compelling works of art. An opening reception will be held Saturday, Aug. 29, from 4-6 p.m., at NXT Gallery, located at Next Stage Arts, 15 Kimball Hill in Putney. Each piece begins with an idea but evolves organically as salvaged components suggest new possibilities. The resulting works celebrate creativity, sustainability, and the beauty of reinvention. Kolias generally leaves her finished sculptures unpainted, allowing the original character and weathered surfaces of the salvaged materials to remain visible.

“METALSUM” also introduces a newer dimension of Kolias’ practice: vibrant metal quilts crafted from vintage cookie tins. Drawing inspiration from traditional quilt patterns while embracing colorful reclaimed materials, these works expand her exploration of texture, pattern, color, and found-object artistry. “Metal quilting is a new endeavor for me,” Kolias explains. “I use traditional quilt patterns for design inspiration and colorful cookie tins as a base material. This invites me to bring the dynamics of color into my design work.” A lifelong artist, Kolias has worked across a remarkable range of creative disciplines, including theater, dance, costume design, textiles, landscape art, stonework, and hardscaping. Her artistic practice has encompassed community theater and cabaret, competitive ballroom dance, costume and wardrobe design, interior and textile arts, quilting, rug hooking, painting, needlepoint, and other crafts. She has also studied stonewall construction at The Stone Trust and developed her skills in hardscaping and rock-garden design. Her recent focus on metalwork – including jewelry making, metal fabrication, welding, and metal quilt-

ing – brings together decades of creative experience in a body of work that is playful, inventive, and deeply rooted in craftsmanship. Born in New Hampshire and now based in Putney, Kolias has maintained a lifelong connection to the arts as both an artist and teacher. The exhibition will be on view at NXT Gallery through Nov. 8. The gallery is open during Next Stage events and by appointment with the artist. Wildlife photographs at Gallery at the Vault

SPRINGFIELD, Vt. – Galley at the Vault is excited to present “An Illusion of Proximity,” a show by wildlife photographer Steve Costello, on display from Aug. 5 – Sept. 22. Costello credits his special interest in wildlife, especially his love for birds and animals, to three mentors. Growing up in Burlington, a childhood friend’s father introduced him to the outdoors and wildlife. Costello later attended St. Michael’s College, where photography professor Chazz Sutphen’s critiques and inspiration helped him fall in love with the camera.

After a 10-year journalism career, Costello met bird advocate Meeri Zetterstrom on his first day at work at Central Vermont Public Service (CVPS), the electric utility serving Milton, Vt., where she lived. Zetterstrom, a native of Finland, had seen a single osprey, a species that had been wiped out by DDT in the 1930s in Vermont. She wanted the state and CVPS, which owned the lake above which Zetterstrom lived, to help restore the elegant raptors to Vermont skies. Costello, about 30, and Zetterstrom, in her 70s, became fast friends, and a partnership was born.

Working with Zetterstrom, CVPS, later Green Mountain Power (GMP), and the Vermont Department of Fish & Wildlife, Costello helped make Zetterstrom’s dream come true. A pair of ospreys eventually produced a single chick on a platform just below Zetterstrom’s lakeside home, and thanks to Zetterstrom’s relentless efforts and support from CVPS and the state, the birds proliferated. Within a decade, dozens of ospreys were fledging in Vermont each year. In 2005, they were removed from the Vermont endangered species list. Throughout that effort, Costello learned at Zetterstrom’s hand how to photograph wildlife without affecting it, and how to use photography to move people to support wildlife conservation. Most of this collection was photographed from substantial distances with

long telephoto lenses. After retirement from GMP four years ago, Costello returned to his roots, writing wildlife stories and shooting photos for the Rutland Herald and the Times Argus on a regular basis. “One of my primary objectives is to provide the viewer with a look at wildlife they might not normally be able to see themselves, to put them face to face with these beautiful and interesting species,” Costello said. “I aim to create portraits of the birds, animals, and even reptiles, and what I call the illusion of proximity.” Gallery at the Vault is located at 68 Main Street in Springfield, Vt. 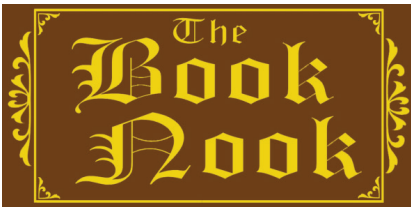
